SC returns PTI's plea with objection

ISLAMABAD: The Supreme Court (SC) on Thursday returned Pakistan Tehreek-e-Insaf (PTI) Chairman Imran Khan's petition for long march. The Supreme Court's registrar raised objections to the petition, noting that the top court had already issued an order on the matter, and the PTI had not moved the relevant forum. "The petitioner (PTI) has not approached any other appropriate forum available under the law for the same relief and has also not provided any justification for not doing so," the SC's registrar said while raising the objection. Among other issues, the top court's registrar said the plea mentions were "controversial issues" in paragraphs 4, 5, 12, and 14.

PTI Chairman Khan had abruptly announced the end of his "Azadi March" on March 26 and had given the government a six-day ultimatum to announce a date for a general election. He had later said he called the march off due to fear of "bloodshed". Just after PTI Secretary-General Asad Umar filed the plea in the apex court yesterday morn ing, Khan had announced that his next plan of action would rely on the court's ruling.

Chinese banks to refinance Pakistan with \$2.3b funding

LAHORE: Finance Minister The restoration of Pakistan's Miftah Ismail on Thursday said that the government has reached a refinancing agreement worth \$2.3 billion with Chinese banks. In a tweet, he said that "the terms and conditions for refinancing of RMB 15 billion deposit by Chinese banks (about US\$ 2.3 billion) have been agreed". Forex reserves drops below \$10 billion

KARACHI: The foreign exchange reserves dropped by \$378 million to reach \$15.771, reaching the 29-month low level.

Statistics released by the State Bank of Pakistan shows, the reserves held by the central bank decreased to \$9.72 billion in the week ended May 27 That's roughly a 50% drop from August and enough to pay for less than two months of imports.

The shortage of dollars could worsen as the nation forecasts its trade deficit will widen to a record \$45 billion in the vear ending June. Authorities have raised fuel and electricity prices, a key condition to unlock the remaining \$3 billion of an existing loan by the multilateral lender.

Meanwhile, the oreign reserves held by the private banks also witnessed a sharp decline to \$15.771 billion, witnessing a decrease of \$378 million.

New dams vital to bolster agri, achieve self-sufficiency in food: Minister

Khursheed Shah says 20% work on Mohmand dam completed while remaining work would be completed by 2026

MOHMAND: Federal Minister for Water Resources, Syed Khursheed Ahmed Shah here on Thursday said that construction of new dams were vital for bolstering agriculture productivity, fulfilling people's water requirements and achieving self-sufficiency

Talking to media persons after visiting different sections of the underconstruction Mohmand dam costing Rs 309.6 billion, the Federal Minister said this multifaceted project was very important for the country's economic and agricultural water needs besides providing clean drinking water to Peshawar and adjoining areas.

He said 20 percent work on Mohmand dam has been completed while the remaining work would be completed by 2026. "Pakistan is an agricultural country and construction of new dams is required to bolster agriculture production and ensure food

security," he said.

He said large dams have a direct impact on the economy and if four new dams were built then not only our economic and agricultural growth would improve but immensely help in paying out of the country's debts.

With completion of Mohmand dam, he said, the water shortage problem of Peshawar would be addressed. Over 300 million gallons of water per day would be provided to Peshawar from Mohmand dam for drinking purposes with Rs957 million benefits.

Likewise, the project would provide

friendly electricity to the national grid every year with an estimated Rs45.76 billion annual revenue.

The Mohmand dam hydro-power project is being constructed on River Swat about five kilometers upstream of Munda headworks in Mohmand district. Construction work on Mohmand dam is progressing at a good pace and despite COVID-19 pandemic, work on the project continued on its 14 different sites.

Federal Minister Khursheed Shah said that there was a time when Pakistan had provided Rs200 million financial assistance to Germany.

To a question, Khursheed Shah said Pakistan can't afford political instability and chaos. He said the people of KP would make Imran Khan accountable for his broken promises in the 2023 general election.

"Where are one million jobs, five

2.86 billion units of environmentally million houses and one billion trees in Khyber Pakthunkhwa," he said, adding the PTI government has failed to address the peoples' problems and economic issues despite obtaining about Rs 22,000 billion record loans during last three and half years.

Eating eggs can boost heart health

ISLAMABAD: Researchers have shown how moderate egg consumption can increase the amount of heart-healthy metabolites in the blood, publishing their results today in eLife.

The findings suggest that eating up to one egg per day may help lower the risk of developing cardiovascular disease.

Eggs are a rich source of dietary cholesterol, but they also contain a variety of essential nutrients. There is conflicting evidence as to whether egg consumption is beneficial or harmful to heart health.

A 2018 study published in the journal Heart, which included approximately half a million adults in China, found that those who ate eggs daily (about one egg per day) had a substantially lower risk of heart disease and stroke than those who ate eggs less frequently*.

Now, to better understand this relationship, the authors of this work have carried out a population-based study exploring how egg consumption affects markers of cardio-

vascular health in the blood. "Few studies have looked at the role that plasma cholesterol metabolism plays in the association between egg consumption and the risk of cardiovascular diseases, so we wanted to help address this gap," explains first author Lang Pan, MSc at

the Department of Epidemiology and Biostatistics, Peking University, Beijing, China.

Pan and the team selected 4,778 participants from the China Kadoorie Biobank, of whom 3,401 had a cardiovascular disease and 1,377 did not. They used a technique called targeted nuclear magnetic resonance to measure 225 metabolites in plasma samples taken from the participants' blood. Of these metabolites, they identified 24 that were associated with self-reported levels of egg consumption.

Their analyses showed that individuals who ate a moderate amount of eggs had higher levels of a protein in their blood called apolipoprotein A1- a building-block of high-density lipoprotein (HDL), also known as 'good lipoprotein'. These individuals especially had more large HDL molecules in their blood, which help clear cholesterol from the blood vessels and thereby protect against blockages that can lead to heart attacks and stroke.

The researchers further identified 14 metabolites that are linked to heart disease. They found that participants who ate fewer eggs had lower levels of beneficial metabolites and higher levels of harmful ones in their blood, compared to those who at eegs more regularly.

"Together, our results provide a potential explanation for how eating a moderate amount of eggs can help protect against heart disease," says author Canqing Yu, Associate Professor at the Department of Epidemiology and Biostatistics, Peking University. "More studies are needed to verify the causal roles that lipid metabolites play in the association between egg consumption and the risk of cardiovascular disease." (Courtesy Science Daily)

IHC clubs all petitions against legal amendments

ISLAMABAD: The Islamabad High Court on Thursday directed to club all the petitions challenging change in procedure of the overseas vote. Petitioner Muhammad Iqbal argued in the court of Chief Justice Athar Minallah that the recent amendment by the government in the law was against the constitution. Justice Athar Minallah said that the overseas Pakistan have not been disenfranchised in the amendment. "If the nine million overseas Pakistani citizens will vote in a single constituency," he questioned.

"The procedure for overseas Pakistanis vote is a complicated issue. Everyone bring petition to the court but no one knows the law," chief justice IHC remarked. "In the United States 13 states of America deny the right to vote to their overseas citizens," Justice Minallah remarked. "It is the mandate of the institutions to decide the procedure of vote," he added. The court adjourned further hearing of the case until June 03 (tomorrow).

It is to be mentioned here that the National Assembly on May 26 approved a bill, reversing reforms introduced by the previous PTI government for voting right to overseas Pakistanis. After the amendment, the overseas Pakistanis would not be able to cast their vote from abroad, however they could cast their votes while residing in Pakistan. Moreover, it has been suggested that reserved seats should be introduced for Pakistani diaspora and the matter was sent to a standing committee for a final approval.

Week-long-polio immunization drive concludes

ISLAMABAD: A week-long national immunization drive against polio concluded on Thursday during which over 43 million children under the age of five years received lifesaving vaccines across the country.

The campaign was synchronized with Afghanistan so that children on both sides of the border received vaccines at the same time and are protected from polio. Over 340,000 trained and dedicated polio workers were engaged in the vaccination drive to inoculate the children at their doorstep. A supplementary dose of Vitamin A was also administered to the eligible children.

Dr Shahzad Baig, Coordinator of the National Emergency Operations Centre, Polio Eradication Initiative (PEI), expressed satisfaction over the successful conclusion of the immunization campaign.

"Pakistan has made enormous progress over the last 18 months, but we need to drive even harder to achieve the results we want. We need to ensure all eligible children are vaccinated during each campaign to build their immunity against polio," Dr Baig said.

He said that the programme has intensified its efforts to address challenges related to vaccine hesitancy, community engagement and service delivery, to counter the long-standing issues following the emergence of new polio cases in South KP.

There have been six cases reported in North Waziristan recently after a gap of 15 months. The programme has taken various initiatives to reduce the risk of virus transmission, focusing on specific geographical areas.

Horrible Golden Temple massacre

he death, destruction and sacrilege caused during Operation Bluestar pierced the heart not only of the Sikhs but also of many Punjabi Hindus. The devastation it caused in the personal lives of so many millions has still not been fully recorded and acknowledged because the political divide over the attitudes towards Operation Bluestar has overshadowed the human stories. In a bloody climax to two years of fighting between the Indian government and Sikh separatists, Indian army troops fight their way into the besieged Golden Temple compound in Amritsar-the holiest shrine of Sikhism-and kill at least 500 Sikh rebels. More than 100 Indian soldiers and scores of nonbelligerent Sikhs also perished in the ferocious gun and artillery battle, which was launched in the early morning hours of June 6. (Sikh groups dispute this figure and say thousands died, including a large number of pilgrims who were there for an important Sikh festival). The army also attacked Sikh guerrillas besieged in three dozen other temples and religious shrines throughout the state of Punjab. Indian officials hailed the operation as a success and said it "broke the back" of the Sikh terrorist movement.

The Sikh religion, which was founded in the late 15th century by Guru Nanak, combines elements of Hinduism and Islam, the two major religions of India. The religion is centered on the Indian state of Punjab in northern India, where Sikhs comprise a majority and speak Punjabi. In the 1970s, agricultural advances made Punjab one of India's most prosperous states, and Sikh leaders began calling for greater autonomy from the central government. This movement was largely peaceful until 1982, when the Sikh fundamentalist Jarnail Singh Bhindranwale and his followers launched a separatist campaign in Punjab.

Employing terrorism and assassination, Bhindranwale and his guerrillas killed scores of political opponents and Hindu civilians in the name of establishing an autonomous Sikh Khalistan, or "Land of the Pure." Most Sikhs did not support Bhindranwale's violent campaign, in which the extremists also assassinated several Sikhs who spoke out against the creation of Khalistan. To appease the Sikhs, Indian Prime Minister Indira Gandhi nominated Zail Singh to be the first Sikh president of India in 1982, a significant choice because the Sikhs comprise a small percentage of India's overall population. Most Sikhs distrusted Singh, however, because as Indian head of state he generally supported Gandhi's policies. Meanwhile, the separatists occupied the Golden Temple and other Sikh holy sites and turned them into armed bases.

The Golden Temple, known as the Harmandir in India, was built in 1604 by Guru Arjun. It was destroyed several times by Afghan invaders and rebuilt in the early 19th century in marble and copper overlaid with gold foil. The temple occupies a small island in the center of a pool. There are a number of other important buildings in the 72-acre temple compound, including the Akal Takht, which is the repository for Sikhism's Holy Book of scriptures and the headquarters of the religion.

To suppress the separatist revolt, which had claimed more than 400 Hindu and Sikh lives and virtually shut down Punjab, Prime Minister Gandhi ordered Indian troops to seize control of the Sikh bases by force in June 1984. On June 1, army troops surrounded the Golden Temple and exchanged gunfire with the rebels, who were heavily armed and commanded by a high-ranking army defector. The Sikhs refused to surrender, and in the early morning of June 6 army forces launched an assault on the temple compound. By daylight, the Sikhs were defeated.

Global Maritime Security Initiatives

he current international situation complicated. The COVID-19 pandemic continues to spread, and the crisis in Ukraine looms large. Unilateralism and hegemonism go hand in hand. In the maritime field, traditional and non-traditional security challenges are emerging one after another, and maintaining the global maritime order faces continuous and severe challenges. At this moment, improving global maritime security governance has become increasingly urgent. The implementation of the global security initiative proposed by China in the maritime field should be a preferred path.

In the face of these challenges, I believe that exploring the implementation of China's first-ever Global Security Initiative in the maritime domain will have great benefits in helping achieve common maritime security around the world. Therefore, we should first adhere to the general principle of settling maritime disputes and conflicts by peaceful means, including dialogue, consultation, and diplomatic efforts. Historical experience has shown that this is still the most effective way to maintain world peace and stability. This principle should become the bottom line acknowledged by all countries to achieve common

maritime security. Second, we should try to enhance the governance of global maritime security through "bilateral cooperation first, multilateral second." We can start with the relatively easy bilateral cooperation, based on which we need to gradually expand the scale of cooperation and eventually build a multilateral cooperation mechanism that substantially benefits all participants. In this process, certain countries may attempt to divide the region and exclude the majority of regional countries from the multilateral mechanism based on ideology. We should pay extra attention to such a practice and resolutely oppose the "pseudo-multilateralism" that creates exclusive cliques.

Third, we should adhere to the purposes and principles of the UN Charter to strengthen global maritime security governance in various forms and means. The institutional design of the UN Charter highlights the goals of common security and permanent peace for mankind. In recent years, China has deeply participated in the negotiations on new rules to maintain the maritime order. This includes agreements on the conservation and sustainable use of marine biodiversity in areas beyond national jurisdiction and regulations on the exploitation of minerals in the international

The implementation of the Global Security Initiative in the field of oceans is a matter of peace and prosperity of oceans all over the world. Only by resolving maritime disputes a peacefully, promoting maritime cooperation under the concept of a maritime community with a shared future, as well as proactively strengthening the international order and rules of maritime security governance, can we truly safeguard the common maritime interests of mankind and realize the beautiful vision of lasting peace and universal security.

Maritime insecurity is also

compounding the terrorist threat emerging from the Sahel. These growing and interlinked threats call for a truly global and integrated response. A response that addresses these challenges directly as well as their root causes-including poverty, a lack of alternative livelihoods, insecurity, and weak governance structures. Maritime security is also being undermined by challenges around contested boundaries and navigation routes, and depletion of natural resources through illegal or unreported fishing.

Maritime security is a global issue with numerous stakeholders having varying interests. Cooperation and coordination are required on a multilateral and bilateral basis along with international organizations and

Key among these groups is the International Maritime Organization (IMO). National Security Presidential Directive 41/ Homeland Security Presidential Directive 13 establishes U.S. policy guidelines to enhance national and homeland security by protecting U.S. maritime interests. The National Strategy for Maritime Security (NSMS) and its eight supporting plans, including the Department-led International Outreach Plan, implement this policy directive. . Piracy, particularly off the coast of Somalia, has become an urgent maritime security matter. Attacks on shipping vessels can be expected to increase without enhanced international efforts. Pirates have received million dollar ransoms for the release of hostages, and Somali-based pirates have disrupted critical humanitarian aid deliveries to Somalia. An international Contact Group on Somali Piracy has been established to facilitate discussion and coordinate the activities of states and interna-

nongovernmental organizations. piracy off the coast of Somalia pursuant to UN Security Council Resolution 1851.

UN Office on Drugs and Crime (UNODC) reported that a 2009 programme, initially established to address the Somali piracy threat, is now its largest initiative, with a budget that has grown from \$300,000 to over \$230 million. The Global Maritime Crime Programme encompasses some 170 personnel based in 26 countries who provide capacity building and support for legal reform, simulated trials and maritime training centres. Yet, the challenges to maritime security continue to grow, and our responses must keep up. The UN agency chief encouraged the Security Council to take action towards implementing the related legal framework, building capabilities, expanding partnerships and promoting crime prevention response. There is dire need to reduce vulnerabilities. Pirates, criminals, and terrorists exploit poverty and desperation to seek recruits, gain support, and find shelter. To counter these threats, we need to raise awareness and educate people, especially youth, while providing alternative livelihoods and support for local busi-

NATO in post Ukraine war

any people claim that the world before the war in Ukraine will never be seen again. It certainly seems that, instead of reducing nations' reliance on NATO, the Russia-Ukraine conflict has actually reinforced the need for the transatlantic alliance, even among traditionally neutral countries. If the pandemic ushered in second thoughts about the benefits of globalization, the war in Ukraine has put defense policies and the need to rearm and cement alliances to ensure nations' security individually or as part of blocs at the forefront of the travails of most Western countries.

Clearly, NATO is not going anywhere anytime soon, as Western countries are scrambling to increase their defense spending and improve their armies' readiness and capabilities for what looks like a new cold war.

So, thanks to Russia, countries are rushing to abandon neutrality and are making bids to join NATO, the EU and other structures in a bid to shield themselves from the winds of change blowing from the east. Alarmingly, the tenets of sovereignty, the right to self-determination, nonaggression, respect of international laws, interdependence and the promotion of a quasi-liberal economy have been shaken. Therefore, the next decade is likely to witness a shift toward militarism, power posturing and the shrinking of neutrality as more European states look to join the NATO alliance, a military behemoth we all thought was "brain dead," as French President Emmanuel Macron said in and the rule of law, refraining from the use 2019. Moscow has long been apprehensive of NATO's enlargement and, though its Ukraine operation was started in an attempt to deter further enlargement, the invasion has actual-

various security umbrellas. Individual states are also increasing their defense spending, while NATO Secretary-General Jens Stoltenberg expects the summit in Madrid at the end of June to be a "historic" opportunity to strengthen the alliance in the face of Russian aggression and to "chart the way ahead for the next decade," including welcoming new members like Sweden and Finland.

To remain relevant, NATO needs to redefine its strategic priorities, which Stoltenberg said should include facing Chinese ambitions, the rise of anti-democratic states, climate change and instability in Africa. This is all in addition to the pressing issue of finding the necessary consensus among member states to continue their support for Ukraine in a way that deters further aggression from Russia.

It was France's withdrawal from the alliance's military command structure in 1966 that pushed it to produce a report that guided its philosophy for the next 50 years. The 1967 report produced by then-Belgian Foreign Minister Pierre Harmel called for the pursuit of a "two-track approach," combining strong military deterrence with the willingness to embrace detente and dialogue with the Soviet Union. The alliance's drive for a quasi-stable world did not deter NATO from welcoming old Warsaw Pact nations through its Partnership for Peace program, which Moscow itself joined in 1994. The NATO-Russia Council, whose work has been suspended since Russia's annexation of Crimea in 2014, promoted partnership and cooperation to strengthen security and stability in the Euro-Atlantic sphere. Its principles included calling for the respect of democracy, pluralism of threats or force, the prevention of conflict, and cooperation in peacekeeping under the UN's authority.

ly served to refocus states' efforts to be part of a new strategic review in order to realign its priorities so that it can survive and stay relevant in the long term. Challenges such as the changing nature of warfare, asymmetric wars, hybrid conflicts, the taming of cyberspace, terrorism, migration and climate change, while ensuring a technological edge, are the issues in play if the alliance is to remain relevant. Most pressing though is to find a formula to end the conflict in Ukraine that will not reward Russia for its invasion, while providing its current or future leadership a ladder on which it can climb down and return from the cold, maybe through refraining from calling the current war "a battle between democracy and autocracy," as it has been framed by US President Joe Biden. This might alienate countries like China, which can play a role in persuading Russia to change course, despite the many lines crossed on the leadership level that cannot easily be uncrossed.

Even if Russian President Vladimir Putin is persuaded to end the war by Ukraine ceding territory, which could be seen as a form of appeasement, it is going to take decades to return to the relatively stable Russian-NATO relations that existed before February's invasion. And though everything must be done to avoid a new cold war, Russia is unlikely to see the sanctions against it removed soon. So, it could continue as it did in the past decade — testing NATO and Western resolve through countless soft-power disinformation campaigns and direct action like cyberattacks on infrastructure. This is why NATO will remain a cornerstone for Western countries to adapt to and deal with the challenges that could be seen as existential to peace, stability and the freedom of the world generally and to Western countries specifically.

Europe returns to nuclear power

s energy prices soar in Europe, whispers are growing louder about something unthinkable to many since the '70s: a return to nuclear power. Due to strenuous efforts in de-carbonisation and the fight against global warming, some leaders and even environmentalists were already quietly including nuclear power among possible solutions in the energy mix of the future. Now the conflict in Ukraine is drawing energy use and autonomy into even sharper focus. Reliant on gas and oil from Russia, Europe is feeling the squeeze as it supports Ukraine. Not only is energy much more expensive, it has been cut off entirely to some countries. The invasion "redefined our energy security considerations", said Fatih Birol, head of the International Energy Agency. "I would expect that nuclear may well make a step back in Europe and elsewhere as a result of the energy insecurity." Belgium's Energy Minister Tinne Van der Straeten called the invasion of Ukraine "a life changer". He now embraces further use of nuclear power.

It's a tough spot for Germany – 34 per cent of its oil and 55 percent of its gas comes from Russia. A complete cut-off of supplies would plunge Germany and the rest of Europe into recession. Despite opposition, several countries are ploughing ahead in full support of nuclear energy, but the industry has notoriously long lead times. France, which already generates 70 per cent of its energy through nuclear power, is determined to get its Flamanville plant online in 2024 after a cost overrun of 12 billion euros and a delivery date 10 years late. Finland's most modern nuclear power plant, which started operating last month, was supposed to be finished in 2009. To emphasize

the UK's renewed interest in nuclear energy, Prime Minister Boris Johnson visited the country's Hinkley Point nuclear plant this month, but it will be at least four years before it goes online.

Yet even before a Russian energy crunch threatened Europe, French President Emmanuel Macron vowed to double down on the country's commitment to atomic power, calling for a "renaissance" in the nuclear industry. In the lead-up to his campaign and re-election as president, Macron announced a vast programme to build up to 14 new reactors, saying it would help make France carbon neutral by 2050. Promising to ensure safe operations, Macron said French nuclear regulators were "unequalled" in their professionalism. He said the decision to build new nuclear power plants was a "choice of progress, a choice of confidence in science and technology". Tom Greatrex, chief executive of the UK's Nuclear Industry Association, agrees with the French position, contending that nuclear energy is not only carbon-free, but is also consistent and reliable, making it perfect for backing up intermittent new energies. By its very nature, power generated by the wind and sun varies a great deal.

He notes that the International Energy Agency and the Intergovernmental Panel on Climate Change have included nuclear power in their projections for a net-zero future. "The best time to build a nuclear power station was 10 years ago," Greatrex says. "The econd-best time is now." We will need clean energy for many centuries to come, he notes, adding that "it's not as if de-carbonization stops in 2030." Ironically, possible interrupted maintenance at the Chernobyl nuclear disaster site in Ukraine was high among the concerns over the Russian invasion. With concerns over Chernobyl now easing, leaders and consumers are clamouring for a solution to their energy needs and nuclear has taken on a renewed shine.

 $\mathsf{KARACHI} :$ Speakers Tuesday on the concluding day of World Islamic Finance Forum (WIFF-2022) emphasized on promoting Islamic social values for conversion of conventional finance system and the economy to a true Islamic ones, along with making required legislation, coming with revised financial policies and restructuring of financial institutions.

PSDP volume likely upto Rs 700b in budget 2022-23: Ahsan Iqbal

Planning Minister says efforts will be made to raise up to Rs200b more through public-private partnership

ISLAMABAD: Federal Minister for Planning, Development and Special Initiatives, Prof. Ahsan Iqbal on Thursday said that the volume of the Public Sector Development Program (PSDP) is likely upto Rs 700 billion in Budget (2022-23), which will increase more development opportunities in the country.

Together they advanced as far as the Eastern Conference finals three times in four seasons before finally reaching the NBA Finals this season, Smart winning the NBA Defensive Player of the Year award and serving as an outspoken leader.

"Over time, you learn, you make mistakes, you argue, you fuss, you fight," Brown said. "But once you've been together for so long with a core group, and you've been in the Celtics organization as long as Smart has been, you find different ways to be an example.

Smart notably called out Tatum and Brown early in the season, but his example has helped the two top scorers to find their own voice in the locker room as well as showing off their skills on the court.

"Marcus is emotional as a player in the things he says and the way he plays and wears it on his sleeve," Celtics coach Ime Udoka said.

"Nothing said publicly had not been said privately. Although it may rub people wrong because it was said publicly, that was something we were working on behind the scenes every day.

"Marcus, as well as the others, their leadership and being vocal has been invaluable to the group. Jayson and Jaylen have grown in that area and do it their own way. That mix of leadership and different styles benefits our team.'

Argentina to prepare in Abu Dhabi

PARIS: Argentina will be based in Abu Dhabi as they prepare for this year's World Cup finals in Qatar after the Argentina Football Association (AFA) entered into a strategic cooperation agreement with Abu Dhabi Sports Council (ADSC).

The two-time World Cup winners will play friendlies in Abu Dhabi as part of their preparatons for what is likely to be superstar Lionel Messi's final chance to win the trophy — he will be 35 by the time the tournament kicks off.

Messi came closest to lifting it when Argentina lost to Germany in the 2014 final in Brazil.

"After months of joint-work exchanges, ADSC together with the AFA, a long-term agreement has been consolidated," read a statement by the ADSC.

"Abu Dhabi will host the Argentine national team preparing camp for the 2022 World Cup, which will include friendly matches in November.

"As part of Argentina's collaboration with the UAE, the Super-Copa Argentina finals will be played for four consecutive years in Abu Dhabi starting from this January 2023 until the year 2026.

The Argentine Football Association thus becomes the first federation in Latin America to export a high global impact sporting event to the Middle East region."

Argentina have been drawn in Group C opening their campaign against Saudi Arabia on November 22 before facing Mexico (November 26) and rounding off their group matches against Poland November 30).

The quadrennial global football showpiece gets underway on November 21 and runs till December 18.
