US announces \$1m aid for Pakistan

WASHINGTON/ISLAM-ABAD: The United States has announced another \$1 million in aid to Pakistan to deal with floods and other natural disasters. US Secretary of State Antony Blinken wrote on the social networking website Twitter that Washington stands with Pakistan in this hour of difficulty and offered help to the flood victims. He said that \$100 000 was provided as immediate aid to Pakistan. Blinken further stated that the US has announced to give another \$1 million to Pakistan to deal with natural disasters. "We will continue to work with Pakistan to mitigate the effects of the climate crisis," he said. The official retweeted an earlier tweet by the US embassy in Islamabad according to which the US will deliver \$100,000 "to support flood relief efforts and humanitarian assistance to vulnerable communities in the worst-affected districts".

Rs.494.7b Exports up by 32.49% in July

ISLAMABAD: The exports from the country in rupee term witnessed an increase of 32.49 per cent during the first month of current fiscal year (2022-23) as compared to the corre-

sponding month of last year, Pakistan Bureau of Statistics (PBS) reported. The exports during July 2022 were recorded at Rs. Rs.494,720 million as against the exports of Rs.373,412 million in July 2021, showing an increase of 32.49 per cent, according to provisional data released by PBS. On month-on-month basis, the exports from the country however declined by 17.05 percent when

compared to the exports of Rs. 596,433 million in June, 2022. The main commodities of exports during July, 2022 were knitwear (Rs. 95,439 million), readymade garments (Rs. 66,835 million), bed wear (Rs. 55,735 million), cotton cloth (Rs.39,934 million), rice others (Rs.20,414 million), towels (Rs.16,450 million), cotton yarn (Rs.15,660 million), madeup articles, excluding towels & Bedwear (Rs.12,008 million), rice Basmati (Rs.9,996 million) and vegetables (Rs.9,661 million).

Review policies, there is still time: Imran Khan tells 'neutrals'

Says dictators always want to control media, afraid of free speech

ISLAMABAD: PTI chairperson Imran Khan told the "neutrals" to review their policies as there is still time left to make changes and the decisions taken behind closed doors are not in the country's interests. Speaking during a seminar related to freedom of expression, the former prime minister said that the establishment imposed these "thieves" upon Pakistan. "How did the establishment let them [the current government] rule us knowing about the foreign conspiracy? This is because they have the most power right now," said the former premier. "No matter how much you [the establishment] call yourself neutral, the nation will blame you for imposing this government on us," he added.

The former premier said that it the establishment] is forcing us to accept these thieves and for that, they are spreading fear among the nation. "They are calling our MNAs and pressuring us to accept this government," he revealed. Imran Khan said that the dictators always wanted to control media as they were afraid of the freedom of speech. The PTI chief said that on several occasions across the globe, attempts were made to control the masses as in monarchy and dictatorship, such rulers wanted to even control the thoughts of the humans.



"They want to control the minds for imposing their rules but not improving their societies. It is a historical fact that only those nations became stronger who allowed the freedom of expression," said Khan.

"I always try to get lessons from my mistakes. I have closely observed British and Pakistan societies. In Pakistan, there are different laws for rich and poor people. Only an independent individual can collect big achievements but a slave cannot. Slavery is a kind of mindset." "Whenever I talk about real independence, there is a background of getting freedom for my nation. I have never gotten afraid of independent media. Only dictators want to control

media because they are afraid of free speech." "[Senior journalist] Najam Sethi had been tortured for three days when he launched criticism against [former prime minister and Pakistan Muslim League Nawaz (PML-N) Quaid] Nawaz Sharif. These people are afraid of being exposed for their corruption and they choose to break the law."

"I have fought a character assassination case in the United Kingdom (UK). If the freedom of speech is allowed in the UK, then there are some laws to discourage character assassination. Najam Sethi had also levelled allegations against me when I was the prime minister. Despite being the PM, I did not get justice.



Forex reserves rise by *\$67m*

KARACHI: The country's foreign exchange reserves held by the State Bank of Pakistan (SBP) reversed the downtrend after it rose by 0.85%. On August 12, the foreign currency reserves held by the SBP were recorded at \$7,897.3 million, up \$67 million compared with \$7,830.3 on August 5, data released by the State Bank of Pakistan (SBP) on Thursday showed.

Overall liquid foreign currency reserves held by the country, including net reserves held by banks other than the SBP, stood at \$13,613.3 million. Net reserves held by banks amounted to \$5,716 million. Last week, the central bank had predicted the reserves to rise as it said that debt repayments were expected to moderate during the next three weeks of this month. It should be noted that with the current foreign exchange reserves position, Pakistan has an import cover

of fewer than 1.13 months. Mover, it is also worth mentioning that the Sensitive Price Indicator (SPI) based weekly inflation for the week ended on August 11 for the combined consumption group, witnessed a decrease of 0.08% as compared to the previous week. SPI for the week under review in the above-mentioned group was recorded at 209.01 points against 209.17 points registered in the previous week. APP

The registration requirements have been designed to reduce barriers to entry, in terms of minimum paid up capital and solvency requirements. The minimum capital requirements have been set at Rs100 million for non-life digital-only business and Rs250 million for life digital-only business, whereas for non-life and life microinsurers, the capital requirements have been set at Rs80 million and Rs150 million, respectively.

He further said that US scrapped three joint communiques which were singed between US and China and it puts pressure on developing countries who have working relations with Beijing. Adding further Zamir said that West's investment in not only South China Sea but across the world are strategically and politically driven. Washington's main focus is on investment in arms harming peace of Taiwan and US China relations.



US is pursuing intentional aggression in the south-China sea mainly Taiwan and it is least concerned about harsh consequences faced by Taiwan like it is least concerned about Ukraine. Apart from international politics there is internal politics at play by US at the expense of Taiwan which is mid-term elections, said Assadi. In his concluding remarks Zamir said that Washington needs introspection rather than putting global peace at stake.

Indian colonialism in IIOJK

'ndian occupation authorities' move to grant voting rights to Indian citizens ordinarily residing in the Indian Occupied Jammu and Kashmir (IIOJK) is the beginning of India's settler colonialism in IIOJK with true colours. People in Jammu staged protest demonstrations against the announcement by the Modi regime to include Indian citizens in voter lists of occupied Jammu and Kashmir. One year after US' withdrawal from Afghanistan

ugust 15, 2021 represents a national tragedy for many Afghans. an inglorious event for the US and its Western allies, a turning point for regional stability and global security. Since its inception as a modern nation-state in the early twentieth century, Afghanistan's stability and pros-

perity have been held hostage by its internal fissures and global actors. From European colonial powers' competition in the 19th century, the Cold War rivalries of the Eastern and Western blocs, to global Jihad against the secular world, Afghanistan has been dragged into regional and global battles. The US has been a leading actor in Afghanistan's multi-faceted conflict and a contributor to Afghans' miseries. The US was the key support-

er of the Mujahideen groups during the Soviet intervention in Afghanistan in 1980s, alongside other anti-Soviet allies. The Western-supported war succeeded in toppling Afghanistan's secular and leftist government, accelerating the collapse

of the Soviet Union and its Eastern bloc. The Arab Mujahideen then turned their rage and ambition against the West, which culminated in the September 11 attacks. The terrorist attacks on the US soil brought back the US into Afghanistan. While US' primary objective was Al Qaeda-centric, it initially recognized the importance of building a modern, moderate and democratic Afghan polity, supported by regional and international stakeholders.

Only a functioning, modern, inclusive and moderate government in Afghanistan will end the Afghan peoples decadesold miseries, while protecting its neighbors, advancing global security and empowering nascent secular forces in the Islamic World. Pax Americana could not sustain such a polity. This endeavour urgently requires UN's strong leadership to initiate an inclusive political process to bring together all Afghans including the Taliban, regional and global stakeholders to map a meaningful political process. Instead of its provocative gestures in Taiwan, the US should learn lessons from its costly Afghan intervention and humiliating departure by



How to save the oceans

arlier this summer, the UN convened its Ocean Conference in Lisbon, Portugal. The goal was "to propel much-needed science-based innovative solutions aimed at starting a new chapter of global ocean action." The world needs a "sustainably managed ocean," according to the UN's undersecretary-general for legal affairs, Miguel de Serpa Soares, who hailed the conference as an "enormous success." If only. The ocean's importance cannot be overstated. It is the planet's largest biosphere, hosting up to 80 percent of all life on Earth. It generates 50 percent of the oxygen we breathe and absorbs a quarter of all carbon dioxide emissions, essential for climate and weather regulation. And it is also economically vital, with roughly 120 million people employed in fisheries and related activities, mostly for small-scale enterprises in developing countries.

Yet, over the last four decades, the ocean has come under unprecedented pressure, largely owing to the rapid growth of commercial maritime activity. This growth is particularly significant in exclusive economic zones, known as EEZs, which are contiguous areas of territorial water that stretch some 230 miles from countries' coastlines. The principle of national sovereignty over EEZs was enshrined in the UN Convention on the Law of the Sea in 1982. In the years that followed, governments sold off vast tracts of ocean territory through state licenses and concessions, effectively handing over management of marine ecosystems to the private sector. Policymakers apparently reasoned that corporations would have a financial interest in adopting responsible business practices in order dation of marine ecosystems is not exactly

were extracting so much value. Instead, widespread oil and gas exploration, industrial fishing and frenetic maritime trade have, as UN Special Envoy for the Ocean Peter Thomson recently put it, caused "the ocean's health" to "spiral into decline."

In fact, beyond Colombia's recently announced plans to create four new marine-protected areas, no binding commitments were made. And, tellingly, the deadlock on deep-sea mining was not broken. Whereas many advanced economies, including Japan and South Korea, support the controversial practice, Pacific Island countries like Palau and Fiji have demanded an industry-wide moratorium, citing the lack of environmental data. The key takeaways from the conference was that the UN remains committed to incremental change, with the private sector firmly in control. This is reflected in an emphasis on "natural capital" solutions, which involve putting a price on nature in order to save it. The neoliberal policymaking that created today's crisis has undergone an ideological makeover.

Where shareholder capitalism failed to ensure self-regulation by private owners, "stakeholder capitalism" supposedly will succeed, because companies will balance the competing interests of investors, workers, communities and the environment. It is not hard to see why stakeholder capitalism is so appealing: It gives the impression that we can have our cake and eat it. But when it comes to the ocean, the cake is already past its expiration date. Given current technological constraints, protecting the ocean from further degradation precludes any additional maritime industrialization. Why does the UN - or anyone, for that matter – believe that private companies will become responsible stewards of the planet? The rapid degrato preserve the resources from which they new information, yet corporations have only

increased their damaging activities.

Realistically, stakeholder capitalism will merely defer difficult decisions about profit maximization in a climate-constrained world to future generations. Now, the world has an opportunity to embrace a more promising approach to protecting the ocean: The Intergovernmental Conference on Marine Biodiversity of Areas Beyond National Jurisdiction. The meetings, which resumed in New York this week, are expected to produce a legal framework for governing all marine areas beyond coastal countries' EEZs. The high seas comprise 64 percent of the ocean's surface area and host the largest reservoirs of biodiversity on Earth. The number of species they support is enormous, with many more expected to be discovered. And they are getting busier - and becoming more threatened — by the day.

Protection of the high seas has long been overseen by a patchwork of international agencies

As a result, just 1.2 percent of this fragile ecosystem is currently safeguarded against exploitative commercial activity. As Guy Standing, a professorial research associate at the University of London, recently told me, there is little reason to believe that the conference will do much to "roll back the power of oligopolistic corporations" in nonterritorial waters. Instead, it will turn out to be just another opportunity for the UN to peddle the narrative that the profit motive, which is largely responsible for destroying the ocean, can spur the necessary action to save it. As Standing puts it, if we are going to save our oceans, we must reverse their privatization. That means pushing for binding commitments, effective regulation and reliable enforcement. Ukraine War & left behind disabled people

n July, Russian mortars rained down on a psychiatric home in northern Ukraine, while dozens of elderly and disabled residents were sleeping. Flames soon swept through the facility's dining room, and its dormitory and administration buildings were wrecked. Miraculously, only three people were injured. But it marks the latest in a series of deadly attacks in which some of Ukraine's most vulnerable have been caught up in a savage conflict far beyond their control. Before the Russian invasion, there were around 2.7 million people with some form of physical or intellectual disability in Ukraine, according to Inclusion Europe, an EU disability organisation.

The violence and destruction that ensued after Russian tanks rolled across the border have only strained what was described as an already "dire situation" for these men, women and children.

"People with disabilities were under pressure before the war, experiencing prolonged stigma, isolation and barriers to accessing community support," said Inclusion Europe. Although exact statistics are hard to come by, many of Ukraine's disabled - especially those with the most severe disabilities - have not been able to flee the war and are struggling to find safety. According to Karolina Kozik, an assistant researcher at Human Rights Watch, one reason is that many disabled people need special accessibility cars or ambulances, which are not readily available in a war zone, to take them to safety.

"Both national and local authorities did not pay enough attention to the needs of people with disabilities when planning escape routes and evacuation corridors," she told Euronews, adding that her organisation has been helping with evacuations and medical services "without any support". Ukraine's cabinet of ministers says it extended all social benefits, including disability and care allowance for persons with intellectual disabilities, and coordinated the efforts of ministries

to evacuate them, including those placed in boarding schools, psychoneurological and other institutions. Both disabled people and the elderly face serious risks in any armed conflict - and Ukraine is no exception.

When violence does erupt on their doorstep, Kozik says people with physical disabilities, especially those in wheelchairs, may be unable to escape or access bomb shelters, while those with hearing difficulties cannot heed warning sirens when the shooting starts. Even if people with physical or intellectual disabilities are spared the direct brush of conflict, they seldom escape the impacts of war. "The mental health impact of any conflict on anyone is enormous," Kozik told Euronews. "For people with disabilities, it can cause even more trauma and psychological distress." "For example, for some people with intellectual disabilities it might be difficult for them to understand what's happening and any change in their everyday life can have an enormous impact on mental health and well-being."

On 1 March, a shell hit the V. Korolenko boarding school for blind children in Kharkiv, Ukraine's second-largest city in the northeast. "Glass shards flew everywhere, children fell to the floor, they were terrified," said Valentina Butenko, the director of Right to Choose, a group that works with disabled Ukrainians. "One girl was injured, and the director of the school sustained a head wound from a glass shard. All the schools' children have since been evacuated." Owing to their conditions, disabled people struggle to access vital services and humanitarian aid during wartime, though both Ukraine and Russia are obligated under international law to ensure their safety. In this void, care responsibilities fall on their families, especially mothers, according to Inclusion Europe, which said they are mostly "just stay [ing] in their homes hoping for the best".

"Unfortunately, as horrible as it might sound, people with disabilities are often an afterthought in these kinds of situations. They are a marginalised group, even when there is no war going on," said Kozik. "It's a humanitarian crisis within a crisis," she added. Courtesy Euronews

Pak-Iran FTA to be finalized in six months

Naveed Qamar says Pakistan is committed to take all possible measures to increase bilateral trade volume to the level of \$5b

ISLAMABAD: The 21st Session of Pak-Iran Joint Economic Commission was hosted by Pakistan from August 16-18, 2022. During the meetings, Federal Minister for Commerce, Syed Naveed Qamar said that Pakistan and Iran enjoy multi-dimensional relations. Pakistan highly values its friendly and brotherly relationship with neighboring country Iran, which is time tested. The two countries have complete trust, mutual understanding and convergence of views on all bilateral, regional and international issues

The Federal Minister for Commerce expressed these views while meeting with Iranian Minister for Roads and Urban Development Rostam Ghasemi along with a delegation of 57 dignitaries from Iran during the 21st Session of Pak-Iran Joint Economic Commission. Secre-



tary, Economic Affairs Division, Mohammad Humair Karim and other senior officers of Ministry of Economic Affairs Division were

also present.

Federal Minister for Commerce, Syed Naveed Qamar said that although current trade volume between the two countries does not commensurate with the true potential of the two countries, yet Pakistan is committed to take all possible measures to increase the bilateral trade volume to the level of \$5 billion. In order to increase bilateral trade both sides expressed their desire to finalize and sign the Free Trade Agreement within the next six months. It was also discussed that the two sides decided to work together to opertionalise the Barter Trade as per the Agreement signed between Quetta and Zahidan Chambers. Both sides further agreed to discuss removal of Tariff and Non-Tarrif Barriers to enhance bilateral trade. On the sidelines of the JEC, the apex Chambers of Commerce from the two sides decided for more frequent business to business integrations.

Moreover, in order to facilitate trade an additional border crossing point at Gabd (near to Gwadar)-Reemdan has recently been operationalized by Pakistan. In addition, the purpose of agreement on International Transport between Pakistan and Iran aims to facilitate trade traffic from Turkey to Pakistan through Iran, while Iranian goods and passengers can have access to China through Pakistan. Pakistan will have the benefits of access to other Central Asian Republics and Europe through Turkey with operationalization of the decisions taken in the 21st session of JEC.

Syed Naveed Qamar further stated that the Quetta-Taftan Road is trafficable, however for further improvement of road various, projects are being undertaken. 

Irfan grabs another Guinness World Record

ISLAMABAD: Pakistan's acclaimed martial artist Irfan Mehsood has achieved another feat by bagging his 54th Guinness World Record of doing the most push-ups with one leg raised in one minute, carrying a 100lb pack.

"I broke the record of a Syrian named Muhammad Abdul Kader Feido who did 51 push-ups in one minute while I was able to do 52," he told APP. Irfan, who attempted the record in Dera Ismail Khan in May this year, holds 29 Guinness World Records in the most push-ups category and was also the record holder in Most Jumping Jacks category at the world level.

He said he was also the only athlete to break world records using 80 to 100 Pounds weight. "I'm the only Pakistani athlete to break most of India's world records. I have so far broken records of nine countries including India, USA, UK, France, Philippines, Iraq, Egypt, Italy and Spain," he said.

Irfan, who was inspired by seeing videos of record holders and reading several editions of the Guinness World Record books, said he trained four to five hours daily for every record he attempted until he felt he could break the one he was aiming for. "My aim, through breaking records, is to promote my country while also advocating a healthy lifestyle and staying active," he said. APP

Thiem, Venus, Kenin among US Open wild cards

NEW YORK: Dominic Thiem, the 2020 champion, and Grand Slam title winners Venus Williams and Sofia Kenin were among those named as wild cards for the US Open main draw.

The US Tennis Association announced the recipients ahead of the August 29 start of the year's final Grand Slam tournament at New York. Austrian Thiem, the former world number three now ranked 228th, has returned to competition after a long layoff due to a wrist injury. Williams, 42, has won seven Grand Slam singles titles, including back-to-back US Open titles in 2000 and 2001.

She returned to competition after missing nearly a year due to injury. Her sister Serena, a 23-time Grand Slam singles champion who turns 41 next month, has hinted at retirement after the US Open. Kenin, the 2020 Australian Open champion, has been ranked as high as fourth in the world but is recently back from an injury layoff and now ranks 412th. US women's wild cards along with Kenin and Venus Williams included CoCo Vandeweghe, Elizabeth Mandlik - the daughter of 1985 US Open champion Hana Mandlikova - Peyton Stearns and Eleana Yu.



"With my team of lawyers we are exhausting all avenues to mount my defence." Tramadol is only banned in competition and while Quintana has been disqualified from the Tour after testing positive for the substance on both July 8 and 13, he will not be banned from future races.

The UCI said Quintana "has been sanctioned for an infringement of the in-competition ban on using tramadol... with the aim of protecting the safety and health of riders in light of the side-effects of this substance".

The governing body added that "the analyses of two dried blood samples... revealed the presence of tramadol and its two main metabolites". Quintana has 10 days to appeal the decision to the Court of Arbitration for Sport (CAS), the UCI said.

"As this is a first offence, Nairo Alexander Quintana Rojas is not declared ineligible and can therefore participate in competitions," it added. Quintana's Arkea-Samsic team said they were aware of the decision but would "make no further comment".

The team did not say whether Quintana would still take part in the Vuelta but the Grand Tour's race director, Javier Guillen told Spanish news agency EFE that he "can start the race, according to the rules". "The rider and the team will decide what they are going to do," added Guillen.

On Tuesday, the Breton outfit announced Quintana had signed a contract extension until 2025. Quintana was the first Colombian to win a Grand Tour when he claimed Giro d'Italia glory in 2014 before adding a Vuelta triumph two years later.

Dubai airport gears up for supporters

DUBAI: Dubai International Airport, a major aviation hub, is gearing up to help ease transit travel for World Cup supporters ahead of the tournament starting in November, its director said.

The first World Cup ever held in a Middle Eastern country is set to kick off in Qatar on November 20 and will last until December 18. Gulf states have agreed to ease administrative procedures for fans in transit, in particular through the United Arab Emirates.

"We are actually putting together some immigration procedures which actually should make that transition between the two countries a lot easier," Dubai Airports chief Paul Griffiths told AFP. He said online check-in will mean normal procedures can be bypassed "and then you can get in and out very quickly". Pre-pandemic, Dubai was the world's busiest airport for international passengers.

Without specifying figures, Griffiths said there would be "quite a number of flights every day during the World Cup, ferrying fans to and from Doha", the Qatari capital, following requests by several airlines. He said he also expected many people to "be going back and forth and enjoy their leisure time in Dubai and going back and forth just for the matches".

Pichardo wins Euro triple jump gold

champion Pedro Pichardo added European triple jump gold to his accolades in Munich on Wednesday while Dutchwoman Femke Bol kept her bid for an audacious track double on course.

Cuban-born Pichardo, who has competed for Portugal since 2019, dominated the field with a best of 17.50 metres, Italy's Andrea Dallavalle claiming silver with 17.04m and France's Jean-Marc Pontvianne bronze (16.94).
