ISLAMABAD: The Islamabad High Court (IHC) on Thursday rejected the reply of PTI Chief Imran Khan and decided to indict him on September 22, in contempt of court case with regard to his threatening remarks about Additional District and Session Judge Zeba Chaudhry.

Chief Justice Athar Minallah remarked the reply submitted by the PTI chief was unsatisfactory. A very serious offense had been committed but it seemed that he (Imran Khan) didn't understand the seriousness of the situation, the court said. The respect of the judiciary was bigger than the ego of someone, he observed, adding that it was a criminal contempt case.

A five member bench headed by Chief Justice Athar Minallah and comprising Justice Mohsin Akhter Kayani, Justice Miangul Hassan Aurangzeb, Justice Tariq Mehmood Jahangiri and Justice Baber Sattar heard the contempt of court case against Imran Khan who appeared before the court amid foolproof security arrangements in place.

At the outset of hearing, the chief justice remarked that there was a legal procedure if someone was affected by a judge's decision. Addressing Imran's lawyer, the chief justice said the court had told you last time that District Judi-



ciary was a red line for us.

The decisions of the Supreme Court related to contempt of court were a binding on us and we had to obey law, Justice Minallah observed and asked whether you had tried to justify the objectionable remarks in the answer.

Imran Khan's lawyer Hamid Khan said we had tried not to justify but to xplain it.

The chief justice said place and time of the insulting statement were very important. Whether your reply was as per the directives of the top court, he sked the lawyer.

Justice Minallah asked that whether a former prime minister could give justification of not knowing the law. There was so much division in the society that followers of political parties used to insult opponents in public places, he said, adding that the female judge could also face the situation somewhere. #### UK's Queen Elizabeth II dies at age 96



LONDON: Queen Elizabeth, Britain's longest-reigning monarch and the nation's figurehead for seven decades, has died aged 96, Buckingham Palace said on Thursday. "The Queen died peacefully at Balmoral this afternoon," Buckingham Palace said in a statement. "The King and The Queen Consort will remain at Balmoral this evening and will return to London on Friday."

Her eldest son Charles, 73, automatically becomes king of the United Kingdom and the head of state of 14 other realms including Australia, Canada and New Zealand.

Her family had rushed to be by her side at her Scottish home, Balmoral Castle, after doctors expressed concern about her health. She had been suffering from what Buckingham Palace has called "episodic mobility problems" since the end of last year, forcing her to withdraw from nearly all her public engagements.

Queen Elizabeth II. who was also the world's oldest and longest-serving head of state, came to the throne following the death of her father King George VI on February 6, 1952. Agencies

Gives go ahead for fertilizer import

ISLAMABAD: The Economic Coordior of life, property, livestock and standnation Committee (ECC) of the Cabinet here on Thursday approved funds for relief and rescue of flood-affected people and also gave go ahead to Trading Corporation of Pakistan (TCP) for Urea fertilizer imports.

According to press statement issued by the finance ministry, Federal Minister for Finance and Revenue, Miftah Ismail presided over the meeting.

The ECC approved funds amounting to Rs. 3 billion for National Disaster Management Authority (NDMA) to meet its growing expenditure on account of procurement of rescue, relief and rehabilitation of the calamity stricken population across Pakistan. NDMA briefed the meeting that in

the aftermath of devastation caused by floods across the country, millions of people have suffered in terms of loss

NDMA was tasked by the prime minister to coordinate with PDMAs and to proactively undertake rescue and relief operation in the affected areas, the statement added.

The committee while considering emergency situation, approved Supplementary/ Technical Supplementary Grant of Rs.540 million in favour of Utility Stores Corporation (USC) for provision of essential commodities in flood affected areas.

The meeting was apprised that the Utility Stores Corporation, in collaboration with provincial governments, is actively participating in relief operation for supply of essential food items in flood affected areas across Pakistan.

Due to emergency situation and based on the preliminary need assessment, 113,700 ration bags amounting to Rs. 540 million would be disbursed.

Meanwhile, the Ministry of National Food Security and Research tabled a summary for allocation of PASSCO's local and imported wheat sock among recipient agencies.

It was briefed that PASSCO serves as a strategic organization to procure wheat from Punjab, Sindh and Baluchistan to build strategic reserves and to supply wheat to recipient agencies in case of emergency.

Every year, on the request of recipient agencies, PASSCO makes allocation of wheat from its stocks. PASSCO held wheat stock of 2.499 MMT, including 1.232 MMT carry forward stocks.

## Floods in Pakistan: \$350,000 from UNESCO for heritage recovery

UNESCO is deeply concerned by severe and unprecedented monsoon rainfall

PARIS/ISLAMABAD: As UN Secretary-General António Guterres started a three-day visit to Pakistan, UNESCO announced the mobilization of an emergency amount of 350,000 USD to help recovering flood-damaged cultural heritage sites. The Organization is also working in the field of education, to quickly provide distance learning solutions.

UNESCO is deeply concerned by severe and unprecedented monsoon rainfall, which has caused widespread flooding and landslides in 72 districts across Pakistan since June 2022. Around 33 million people have been impacted, and some 6.4 million people are currently in need of assistance. The floods have resulted in a significant loss of life, as well as loss of livelihoods, shelter and social and cultural life.

"First of all, our thoughts are with the families who have lost a loved one, the injured, all those who have been forced to leave their homes and with the authorities. UNESCO stands with them," said Audrey Azoulay, Director-General.

Cultural heritage has also been damaged by the floods, including the UNESCO World Heritage sites 'Archaeological Ruins at Moenjodaro' and 'Historical Monuments at Makli, Thatta'. Karez in Balochistan, a traditional irrigation system on Pakistan's World Heritage Tentative List, the Amri site museum and the Sehwan folk and craft museum, both in the Jamshoro District, have also been reported as damaged by the recent floods.

Those companies (77% of the sample) that have adopted the Task Force on Climate-related Financial Disclosures (TCFD) Recommendations are significantly better prepared to comply with the proposed new disclosure requirements. However, even these companies will need to significantly increase their climate-related reporting to meet the new requirements of the proposed standard, which the ISSB aims to finalise by the end of this year.

Commenting on the research, ACCA's head of Pakistan, Assad Hameed Khan says: 'The colossal impact of recent floods in Pakistan is a reminder on the national climate action urgency. Thus, it is imperative for companies to adopt ESG focused (sustainable) practices and initiate substantive action related to climate change and strengthen reporting through robust climate-related disclosures.

# Mosque to Mosque Movement-unique example to support flood affectees

Jamia Masjid Rehmatul lil Alameen located in sector F-8/4 launches initiative "2kg Rice Movement" for restoration, rehabilitation of flood victims

he disastrous flood of July 2022 in Pakistan will ever remember in the history of the country. This flood has beaten all the records of previous floods like 1992, 2001, 2010, and so on. Although the history of our country is full of natural calamities, especially the earthquake of October 2005, it is still fresh in the minds of the people despite the passing of more than one decade.

The relief, rescue, and rehabilitation operation for the affectees of these natural calamities carried out by the public and private sector of the country, local and international NGOs, and social and religious welfare organizations is still continuing with full determination.

The initiatives taken by the government of Pakistan, and national and international donor organizations have set a unique example of sympathy, brotherhood, and humanity. They have not only provided them relief items like food items, pure drinking water, cloths, blankets, tents, medicines, and construction items for building the damaged houses but also launched movements to reconstruct the fully or partially damaged educational institutions and holy mosques in flood-hit areas of the country. These are the unique examples set by these donors.

Jamia Masjid Rehmatul lil Alameen located in sector F-8/4 of federal capital Islamabad's Khateeb Dr Ubaid Ur Rahman Bashir has announced to launch a movement named "Two Kg rice movement" objects for the restoration and rehabilitation of flood affectees. The decision of launching this movement was taken after witnessing the video clips of flood-hit areas and their miserable condition. The worshipers (Nimazis) of this mosque have announced to donate Two Kg of rice per person in the Jamia Masjid Rehmat lil Alameen to provide food to flood affectees. So far 70 thousand Kg rice was donated by the prayer of this mosque and other people of the area. With this donation, the mosque is providing cooked food to various flood-hit villages at different 40 locations and approximately 10 thousand affectees are being supplied cooked food to these people.

When this announcement was made by Dr. Ubaid-ur-Rehman, a prominent religious scholar, the Khateeb of mosque, the residents of the twin cities (Rawalpindi and Islamabad) donated 30 tons of new and used clothes for flood affectees. They are still donating clothes and edible items including rice, dry ration like ghee, cooking oil, sugar, flour, pulses, and even toys for their children.

As the news of looting the trucks of relief items for floodhit areas were highlighted by the print and electronic media, the management of Jamia Masjid Rehmatul lil Alameen has decided to launch "Mosque to Mosque movement" which is a unique idea in the history of the country because mosques have a huge network in the country.

Through Jamia Masjid Rehmatul lil Alameen some forty mosques located in various parts of the country including Dera Ghazi Khan, Rajanpur, Khuzdar, Taunsa Sharif, Larkana and some mosques of Sind and Baluchistan provinces have been installed traditional Islamic "Dastarkhawan" where cooked food is being served to flood affectees with honor, respect and dignity. The affectees instead of standing in long queues waiting for food, respectfully sit on these "Dastarkhawans" and food is served to them with respect which is the traditional way of Islamic hospitality.

It is the best example for other mosques in the country to adopt this method or way to maintain the relief activities for flood-hit people. The Jamia Masjid Rehmatul lil Alameen has borne the responsibility of mosques in forty villages in flood-hit areas and if the two percent mosques of in the country would be active in this regard, the food issue of the flood-hit people would be resolved on a permanent basis respectfully.

Distribution of food items to flood affectees through mosques would not only overcome the incidents of looting the relief items trucks but it will also ensure the fair and just distribution of flood aid. So it is the need of hour to distribute this aid through clerics of the mosques to remove the

fake flood victims from the scene.

The Jamia Masjid Rehmat lil Alameen is being presented as a role model for other mosques in the country. More than seventy mosques in the flood-hit areas have been drowned in flood water and Jamia Masjid Rehmat lil Alameen is providing food to them on a daily basis. The data of the widows and orphans are being collected through the clerics of the mosques

of flood-hit areas to provide them relief items and financial assistance. Some people have donated unstitched ladies' clothes for flood affectees. It is also decided to distribute these unstitched women clothes to young girls whose marriage is being held in near future.

So the Prime Minister of Pakistan Mian Muhammad Shahbaz Sharif and Chief Ministers of provinces is humbly requested to provide data on mosques of the respective provinces. All the mosques can easily overcome the crises of floods. Only mosques can fulfill the three basic requirements of flood affectees which include food, medicines, and tents.

So, it is humbly requested that the Government of Pakistan launch a relief and rehabilitation movement for flood affectees through mosques. It is the best time to prove ourselves as a self-restraint nation before the international



community. The clerics of the mosques, and religious scholars should play their due role in this regard.

It is worth mentioning here that Jamia Masjid Rehmatul lil Alameen has dispatched 13 trucks loaded with relief items which include cloths, tents, blankets, food items like rice, pulses, cooking oil, flour bags, and medicines to flood-hit areas. Approximately eight thousand families in flood-hit areas have been provided clothes so far. Besides this, cooked food is being provided to some 35 thousand people every three days. The flood aid is being provided to flood affectees without discrimination of creed, gender, color, caste and faith. Even the minorities of the Sind and Baluchistan provinces which include Christian, Hindu, Sikhs and Parsis and others can contact Jamia Masjid Rehmat lil Alameen administration to get relief items. This mosque would certainly provide food to their worship places of minorities including Churches, Mindars and Gurdawaras.

It is humbly suggested that the network of mosques in the country be organized on the scientific basis and all the flood aid and donations received from local and international donors should be distributed through mosques in the flood-hit areas without discrimination of color, creed, caste and faith. It is the prime responsibility of religious scholars, and prayer leaders of the mosques to promote this ideology

We should distribute this aid to actual flood affectees in a transparent way as this aid is a deposit of Allah Almighty. Mosques can distribute this aid in a transparent, sophisticated, and civilized way where self-respect of the receivers will never be hurt and only the righteous will receive it without any botheration or inconvenience.

It is also requested of the authorities concerned of the Ministries of Interior and Religious Affairs to provide data of mosques on the internet so that relief activities could be continued without any hurdle.

There is a dire need for five items for flood affectees immediately which include food, medicine, tents, house building and restoration of infrastructure in flood-hit areas. Out of these five items mosques can provide three items namely food, mosques and tents and the remaining two items would be provided by the government on a priority basis. The affectees are provided construction items for the building of their damaged houses and measures should be taken immediately for the restoration of infrastructure in those areas. The government should start a movement for the building of damaged houses and restoration of infrastructure to improve their condition. It is the best solution to problems being faced by the affectees.

## Redefining US, **Pakistan ties**

t is a satisfactory statement from the United States and a positive gesture that the United States is extending its full support and solidarity with Pakistan during the difficult time of devastating floods. It means that Pak-US relations are heading in the positive direction. The United States also expressed willingness to support the current regime in power in Pakistan. The United States is the sole superpower and can support Pakistan in revival of its economy and transfer of technology in many fields. It is a great development that the United States announced aid in millions as humanitarian assistance to support people and communities affected by flooding in Pakistan. There is no doubt that Pakistan needed sustainable relations with the United States based on mutual respect and trust.

Senior Policy Adviser to the US Secretary of State Derek Chollet held meeting with Prime Minister Muhammad Shehbaz Sharif. The PM said Pakistan is committed to deepen and widen its ties, especially in the areas of security, health, climate change, trade and investment. On behalf of the Biden Administration, Derek Chollet affirmed that the U.S. would stand by Pakistan in the wake of this immense challenge, extend vital support, and help affected people rebuild their lives and communities. He expressed heartfelt condolences and sympathies to the Government and people of Pakistan at the precious lives, resulting from the riverine floods.

The international community is coming forward to support Pakistan in provision of relief to flood-affected people in the country. Pak-US relations were on the low level in the past few years but the need of the hour is to bring the bilateral relations towards normalcy. The strong bilateral relations between both the countries are in the national interests of Pakistan and the United States as well. At this point of time, the United States is a big market for Pakistani exports. During the visit of foreign minister to the United States the superpower reiterated the commitment that it will continue to work bilaterally on ways to grow investment and trade opportunities to build a prosperous and stable Pakistan.

On the other hand, the U.S. administration has announced the approval of the potential sale of F-16 aircraft sustainment and related equipment to Pakistan in a deal valued at up to \$450 million. "The State Department has made a determination approving a possible Foreign Military Sale to the Government of Pakistan of F-16 Case for Sustainment and related equipment for an estimated cost of \$450 million," the department said. The Defence Security Cooperation Agency (DSCA) delivered the required certification notifying Congress of this possible sale on Wednesday. This is a positive development between the two countries and this should be a new beginning to reinforce closer broad-based relations between Pakistan and the US. The proposed sale will continue the sustainment of Pakistan's F-16 fleet, which greatly improves Pakistan's ability to support counterterrorism operations through its robust air-to-ground capability," the State Department said, adding that Pakistan will have no difficulty absorbing these articles and services into its armed

## Social research key to designing impactful policies

ocial research is playing an increasingly central role in crafting impactful public policies. Societies are at the heart of policymaking, so interweaving public interest with policy design is a powerful way to unveil many advantageous opportunities for fine-tuning solutions. As such, there are plenty of strategic advantages for establishing dedicated social research units within governmental agencies.

Engaging in social research revolves around understanding the interplay of the needs, attitudes, motivations and behaviors of constituents on a variety of issues, which could later translate into actionable strategies and solutions. For instance, many strategies are concerned with promoting specific desirable behaviors that would prove optimal for all parties involved, such as healthy lifestyles or financial planning. Deep-diving into common obstacles or motivations will help policymakers design ways to facilitate the adoption of such practices.

To illustrate a point in practice, social researchers in many

measure attitudes toward parenting and its relation to fertility rates in order to craft suitable work-life balance policies and care services that could help elevate both employment and fertility rates. Social research was also critical during the COVID-19 pandemic to understand factors related to vaccine hesitancy, hygiene practices and infection causes in order to design effective outbreak responses.

Interestingly, a salient theme imprinting much social research recently is understanding the multifaceted ways in which the pandemic has disrupted and remodeled society. Within the plentitude of social research are stories of individuals and communities who have permanently changed the way they work, have a renewed appreciation for social connections and have increased their reliance on digital platforms to access education, e-commerce or get medical advice. Such implications are transforming how economies and societies function, necessitating agile governmental interventions in order to remain competitive.

The UK government's experience with social research is worth

mentioning in this context. Currently, more than 2,400 social researchers are employed across various departments with the aim of publishing insightful research and advice that can be translated into support for policy solutions and interventions. For example, a recent survey by the Department for Work and Pensions examined how separated parents were able to agree on child maintenance arrangements, what their common challenges were and how government interventions could ensure children receive essential services while their parents are in high conflict or facing complex circumstances

and financial constraints. In another example, the US-based Pew Research Center regularly publishes demographic research, social science research and public opinion polling in order to inform policymaking and public dialogue on key issues. The center's work covers an extensive list of topics, including demographic trends, the economy and employment, immigration attitudes, education, health policy, science and technology, and family and relationships. To illustrate, recent interesting publications discussed the top factors that an understanding of the social

ing in one's life, how populations are reacting to climate-related news stories, and consumer attitudes toward purchasing electric vehicles.

In another example, the center last month published survey results revealing the shifting priorities of Americans around nealth and social activities during the COVID-19 pandemic. More than a quarter of Americans stated that adopting a healthy lifestyle became more important to them, citing exercise, healthy eating and mental health as some key trends. About 21 percent of respondents revealed a newfound enjoyment for social activities, with many taking more time to engage in social gatherings with family and friends than before the pandemic. Interestingly, 9 percent of respondents showed a decreased valuation of their jobs, perhaps hinting at the many reasons the job market faced an exodus of competent employees seeking fulfillment elsewhere. Such insights could offer policymakers a plethora of policy roadmaps to explore in the future.


In a similar vein, the annual Australian Survey of Social Attitudes offers policymakers

contributed to finding mean- attitudes, beliefs and opinions of Australians on a variety of salient issues. Past surveys have explored topics such as the role of government, social networks and social resources, health and healthcare, the environment, and work orientations. By exploring this topic in greater depth, policymakers can also design preemptive policies addressing related issues, such as urban planning, housing needs, family-friendly employment policies, care services and immigration rules.

By delving into an illuminating collection of data-driven social research, policymakers can unravel a wealth of insights that can inspire practical policy solutions and opportunities.

## UK heading for costly storm unless Truss adapts quickly

f the new UK Prime Minister Liz Truss's history is anything to go by, the country must brace for more uncertainties during her premiership. Her beginnings were on the left in the footsteps of her left-wing parents, then she joined the centrist Liberal Democrats and even called for the abolition of the monarchy. Next she jumped ship to the Conservative Party, firstly as a pro-European, before she metamorphosed into a Brexiteer, right-wing populist, who was elevated to the role of foreign secretary under Boris

I would say that the UK must brace for what could be a costly storm unless the new PM, who is known for her pragmatism, changes and adopts a form of leadership that can put the country and its citizens first, with the Conservative Party and its rightwing, populist tribe behind her.

The UK as a nation has been standing at a crossroads since Brexit — not that anyone from the ruling Conservative party wants to admit it. Unless the new leader is ready to acknowledge the scale of the damage the divorce from the EU has dealt to the nation, its unity, its finances and its dented prosperity outlook, then her tenure as only the third woman to lead the country, after Margaret Thatcher and Theresa May, might be

Since the start of her campaign, Truss has been trying to emulate Thatcher's way of talking tough, adopting her doctrine of keeping the state small and the citizens respon-

acceptance speech, she praised her predecessor Johnson as "someone admired from Kviv to Carlisle." But now that she is in the driving seat, her attention must be turned to healing the country's divisions. A YouGov poll in late August found that 52 percent of Britons thought Truss would make a "poor" or "terrible" prime minister, while 43 percent said they did not trust her "at all" to remedy the cost-of-living crisis.

Truss has a unique opportunity to refrain from being a Johnson continuity PM and to work to re-instill a sense of decency in the Cabinet, which was lost under Johnson, and restore trust. She must present a functioning government that is able to get things done efficiently.

The next big thing Truss must do is abandon boosterism and sloganizing in her approach to mending relations with the French first and the rest of the EU later. Her dig at Emmanuel Macron that "the jury is out" on whether he is a friend or a foe showed her to be less of a statesperson than the leader of the UK should be. Aligning British interests with those of its European neighbors could serve to mend the fences that have fallen since the Brexit withdrawal agreement storm. If anything, Russia's invasion of Ukraine has shown that Europe's liberal democracy and its peace and prosperity are at stake, and this applies not only to mainland Europe. The Russian leadership has singled out London as a target for retaliatory nuclear attacks by the Kremlin if the West continues to arm the Ukrainians — it did not mention Brussels or Paris in its threat.

Relations with the US are equally important, regardless of whether it is a Democrat Does Truss have what it takes to be the or a Republican who is in office. This high-

strong leader the country is craving? In her lights the need to settle the problem of the Northern Ireland protocol amicably, rather than unilaterally abolish it and risk alienating President Joe Biden's administration. which has often warned London about its duty to do everything possible to uphold the Good Friday Agreement that brought peace to the province.

> Solid relationships with Europe and the US, as the UK's true allies, will give more weight to Truss's leadership and words when she talks tough on Russia or China, or when she reaches out to revive old partnerships or create new ones in pursuit of the post-Brexit brand of "Global Britain."

> After 12 years in power, many in Britain could be right when they write off the Conservatives, claiming that they have reached the end of the road. This is Truss's chance. Her track record has shown her to be adaptable, in addition to having a sharp political instinct, as some who have worked with her have claimed. Some have even described her as a canny operator. All bets are currently stacked against her lasting long at the head of a divided Tory party and a divided if not totally broken Britain. Truss, unlike her idol Thatcher, who famously said she was "not for turning," actually needs to U-turn on her campaign promises and confirm a massive support package, including handouts, and rule out tax cuts if she is to have a chance at leading her party to victory at the next general election.

## Politics of hate prevent the discussion of big issues

merica is polarized and divided and the world must wonder whether or not it can fulfill its supposed role as "leader of the free world." What exactly that phrase is supposed to mean, I just do not know any more, given the internal fighting that dominates this country. President Joe Biden, a Democrat, last week gave a partisan speech that effectively blamed all of America's ills on the Republicans, further widening that divide. He said: "Too much of what's happening in our country today is not normal. Donald Trump and the MAGA (Make America Great Again) Republicans represent an extremism that threatens the very foundations of our republic."

The deep divides in the country have drawn in every voting constituency — and Arab Americans are no exception. Although they are concerned by Biden's failure to live up to his campaign promises, they have joined in the stampede to pillory Trump, attacking him personally and not addressing the issues. Rep. Rashida Tlaib, the daughter of Palestinian immigrants, has used hate politics in an attempt to energize the Arab American, Muslim and progressive communities, including by unleashing a profanity-laced speech attacking Trump hours after she was sworn into office.

Some think the politics of hate started when Trump appeared on the political scene. But the truth is that this divisive political phase began when a former Georgia history professor, Newt Gingrich, entered Congress in 1979 after transforming a Democratic district into a Republican one.

Prior to Gingrich's rise, former President Ronald Reagan — who won the support of both Republicans and Democrats, creating what we now refer to as "Reagan Democrats" - expressed how politics should never besmirch personalities. Speaking in 1985 at the presidential library named for one of his predecessors, John F. Kennedy, who was assassinated in 1963,

Reagan praised Kennedy, but then added this impor-

tant comment, which reflects the old manner of American politics that today is lost in the mire: "Which is not to say I supported John Kennedy when he ran for president, I didn't, I was for the other fellow. But you know it is true, when the battle's over and the ground is cooled, well it's then that you see the opposing general's valor."

That kind of political brilliance is no longer here in America. Gingrich set the tone, but many Republicans and Democrats have since fueled the growth of

President George W. Bush used anger to bring people together in the days after Al-Qaeda's 2001 terrorist attack that took the lives of nearly 3,000 people in New York, Washington and in a field in Pennsylvania. Bush declared in no uncertain terms to the leaders of foreign nations, and to the American people themselves: "Over time it's going to be important for nations to know they will be held accountable for inactivity. You're either with us or against us in the fight against terror."

And in her 2016 presidential election campaign against Trump, Hillary Clinton, the former first lady and New York senator, vowed to run a "positive campaign." But her campaign rhetoric fueled anger and was symbolized by her comment attacking those who supported her opponent as "deplorables."

Candidates use the politics of hate to rally their supporters, but also as a way to avoid a respectful discussion of the issues. The worst part of it is that the hatred is narrow in focus, usually against a single person, and not about the bigger issues that are more important and that might impact people's lives.

This is one reason why Arab Americans and American Muslims are powerless to change American policies no matter if those policies are Republican or Democratic — in an attempt to bring justice and fairness not only to their communities in the US, but to change unjust policies affecting the Middle East.

SHARJAH: UAE corporates have a more diversified funding base compared to their regional peers, said Fitch Ratings in a new report. Debt capital market (DCM) and equity capital market (ECM) issuances represented 32% of corporates' funding structure in the first half of 2022, compared with 2% for Saudi corporates in 2021. Bank borrowings financed 68% of corporates' funding structure, raising \$24 billion in the same period.

DCM issuances for corporates dipped to \$2.3 billion in the first half, after a 43% year-on-year increase in 2021 raising \$15 billion, according to Fitch's adjusted Bloomberg data for corporates with market presence. "We expect DCM issuances to remain low for the rest of 2022 but to grow in the medium term, supported by improved economic activity," the report said.

The proportion of Islamic facilities to UAE corporates' bank funding increased to 21% in 2021, albeit far lower than the 85% for Saudi corporates, due to the kingdom's dominant Islamic financing sector. Conventional bonds accounted for most issuances, at 96% in 2021 compared to 80% in 2020. Sukuk contributions to fixed-income issuances fell significantly to 4% in 2021 from 20% in 2020, due mainly to the introduction of AAOFI standards regarding tangibility requirements.

Small- to mid-size corporate issuers were the most affected by the Sharia standards, pushing companies to either opt for conventional notes or postpone sukuk transactions. "We expect the momentum of DCM issuances through international bond and sukuk notes to pick up after 2022. All UAE fixed-income issuances were raised on the international market and none locally. Conversely, Saudi corporates have access to a more developed local sukuk market." UAE has had a spree of IPOs mainly driven by government-related entities, raising nearly 9 billion in the first half of 2022. This is up from \$5 billion in 2021 and represents 79% of total fixed income and equity proceeds, largely due to record-low DCM issuance in the period.

Dubai banker leaves Credit



DUBAI: Dubai-based banker Sohaib Ahmed is leaving Credit Agricole to become Middle East head of Islamic finance at rival French lender Societe Generale, two sources familiar with the matter said.

Ahmed has worked at Credit Agricole for more than 15 years and at its Islamic banking business since April 2014, according to his LinkedIn profile.

Societe Generale confirmed the move but declined to comment further. Credit Agricole and Ahmed both declined to comment. SocGen's Islamic banking business offers a wider offering than Credit Agricole's, including structured products like derivatives, swaps and hedging, one of the sources said.

In June, Ishaq Dadabhoy left Societe Generale, where he was head of Middle East Islamic finance, to join Goldman Sachs' Dubai office as executive director of Islamic finance, according to his LinkedIn page.

Ahmed's role at SocGen will be slightly different to Dadabhoy's, one of the sources said. Ahmed is expected to take up his new role imminently, the source said.

#### Global halal economy to reach \$5trln by 2030: Frank ಟೆ Sullivan

DUBAI: The market for the global halal economy will likely witness impressive growth, reaching \$4.96 trillion by 2030 from \$2.30 trillion in 2020, says a new report.

The halal economy is experiencing an upward trend as the demand for halal products from both Muslim and non-Muslim nations increases, a recent analysis - Global Halal Economy Growth

The main factors driving the halal industry are favourable population demographics, government policies, and private sector initiatives. Growing non-Muslim demand for halal foods will be driven by its association with safe and healthy eating, while halal fashion and tourism should also find increasing acceptance among more conservative non-Muslim consumers, the report said.

"With higher levels of halal trade and Islamic finance potentially accelerating infrastructure development, the halal economy is poised to become more integrated with global trade and supply chains," said Neha Anna Thomas, Senior Economist at Frost & Sullivan.

"Further, governments are strengthening regulatory and policy support through national masterplans and certification scope expansion, which will boost the halal industry's growth."

Thomas added: "Transparency and traceability along the halal product value chain are crucial. Due to this, governments should encourage the adoption of advanced technologies such as blockchain and the Internet of Things (IoT) when developing halal economy masterplans, while businesses can partner with tech start-ups.

Global governments must seek to unify halal standards and accreditation processes to help reduce the number of certification requirements and promote halal commerce. Food manufacturers should collaborate with technology companies to improve traceability and transparency while increasing consum-

Global drug manufacturers and raw material suppliers should incorporate halal-certified products into their offerings, potentially through joint ventures, to tap into growing halal pharmaceutical demand from Islamic

## Sukuk documentation adapts to AAOIFI standards

ABU DHABI: Changes in global sukuk documentation linked to UAE Central Bank's adoption of the Accounting and Auditing Organisation for Islamic Financial Institutions' (AAOIFI) sharia norms have become standardised to some extent.

Fitch Ratings says that however, it is uncertain if additional changes will be seen in the near term and issuers have exhibited varying degrees of adaptation, while the practical effect of the new documentation has yet to be

A majority of Fitch-rated sukuk issued in 2021-9M22 have new clauses embedded in the documents, including defined tangibility events and the associated put options. The changes have been seen across sovereigns, financial institutions and corporate issuers. Non-compliance with AAOI-FI sharia standards and Higher Sharia Authority (HSA) guidelines could reduce sukuk demand, as a sizeable share of global sukuk investors, arrangers and issuers are based in the UAE and fall under UAE Central Bank's remit. In June 2022, Fitch updated its Sukuk Rating Criteria to take

This shift from sukuk to bonds partly retraced in H122, when sukuk issued by UAE-based entities rose by 88.4% compared to 2H21, while bond issuance increased by 9.2%.

KARACHI: Irfan Iqbal Sheikh, President FPCCI, has expressed his profound concerns that National Electric Power Regulatory Authority (NEPRA) is not looking after the interests of the people, the business community and the economy.

He added that the current practice of fixed charges based on 50% of sanctioned load defies all logic and fair practice; and, the past mechanism for fixed charges based on actual maximum demand (MDX) and the units consumed should immediately be reinstated for electricity billing. The fixed charges based on 50% of the sanctioned load instead of actual Maximum Demand is totally out-of-sync with the actual



consumption and ground realities of industries; a large number of which are dysfunctional or operating at their partial capacities due to floods and rains. Furthermore, industry is forced to work under an environment of insufficient

FPCCI Chief highlighted that the business environment of Pakistan is in stagnation due to the burgeoning cost of doing business; and, the NEPRA is not listening to the legitimate concerns of the business community. NEPRA has also abruptly cancelled a public hearing recently; further adding fuel to the frustra-

Opener Elgar said: "Runs are key. We have the 20 wickets covered with our bowlers but we need to give them the chance to strike well and bowl to something." Victory would take South Africa back to the top of the World Test Championship table. A win for England would give them a sparkling record of six wins in seven Tests under their new leadership pairing of Stokes and coach Brendon McCullum.
