

The apex court, in a written order issued today, termed the bill "interference with and intrusion into the independence of the judiciary."

The order stated that while the bill is "not yet law it is nonetheless, with exactitude, that what will have the force of law, when the act comes into being," adding that it could be considered and examined even at this stage.

"Prima facie, the bill seems to be open to question on the constitutional plane on several grounds which, inter alia, raise issues of a serious nature in relation to the independence of the judiciary," it added. The order stated that the

contentions raised disclosed that there was a "substantial, immediate and direct interference with the independence of the judiciary in the form of multiple intrusions, in the guise of regulating the pracand conferring upon it a jurisdiction that appears not to be permissible under any constitutional provision".

"Such intermeddling in the functioning of the court, even on the most tentative assessment, will commence as soon as the bill becomes the act. Accordingly, in our view an interim measure ought to be put in place, in the nature of an anticipatory injunction.

It concluded by stating, "The moment that the bill receives the assent of the president or (as the case may be) it is deemed that such assent has been given, then from that very moment onwards and till further orders, the act that comes into being shall not have, take or be given any effect nor be acted upon in any







Federal Board authorities change their attitude: Malik Abrar

ISLAMABAD: There has been a strong wave of concern in the private education sector against the irrational decision of the chairman of the Federal Board not to assign duties to the teachers associated with the private education sector in the matric annual examinations, who have demanded the government of Pakistan, especially the Ministry of Education, that the Federal Board Private teachers should also be given their legitimate right in examination duties to ensure transparency in



the examination system as well as to prevent possible violation of the rights of private students.

All Pakistan Private Schools and Colleges Association Central President Malik Abrar Hussain said that if the Federal Board authorities do not change their attitude, private educational institutions will not cooperate with the Federal Board authorities. About 70% of the registration fee is paid by the private sector. Regarding the duties in the examination centers of the annual matriculation examinations under the Federal Board, which are starting immediately after Eid-ul-Fitr, the Federal Board has for the first time refused to give examination duties to teachers belonging to private educational institutions. On the other hand, the roll number slips of the examination have not been released yet, which causes serious concern in the private education sector.

who have demanded from the concerned authorities to withdraw the policy of completely neglecting the important part of the education sector and include the teachers of private schools in the examination duties so that the students of the private sector can appear in the examinations. Exam transparency can be maintained along with avoiding obstacles. Malik Abrar Hussain, Central President of All Pakistan Private Schools and Colleges Association, said in his response to the media that if the Federal Board authorities do not change their attitude, private educational institutions will not cooperate with the Federal Board. In this regard, the elected representative of the Federal Board, Muhammad Ashraf Haraj, has also been informed by the private educational institutions. He said that the Chairman of the Federal Board has come down to arbitrary decisions and the appointment of the inexperienced Controller of Examinations Imran Ageel, who has completely failed to handle the examination system, has removed him. He said that a large number of private educational institutions across the country are affiliated to the Federal Board and about 70 percent of the educational institutions are from the private sector.A lot of revenue is also paid by the private sector. He said that the annual examinations are starting from April 27 but the roll number slips have not been released yet.

The people of the occupied state are defending the land through resistance movements but it is not sufficient but it needs a specific force and support of the world to liberate Kashmir







ISLAMABAD: Health activists have urged the government to remain steadfast on its decision to double the Federal Excise Duty (FED) on Cigarettes. In a press release shared by Society for the Protection of the Rights of the Child (SPARC), health activists shared that this decision can solve Pakistan's financial dejection, provided that the government is not mislead by the tobacco industry's misinformation campaign.

Malik Imran, country head, Campaign for tobacco-free kids (CTFK), mentioned that tobacco 615 billion which is 1.6% of industry Pakistan's GDP. Although tobacco industry is one of the revenue generated from the tobacco industry is 120 billion.

Therefore, the industry can't claim that it is fulfilling the duty. An industry which is causing such severe damage to people's health and finances, should not use victim card that it is being 'burdened' by taxes. Therefore, instead of listening to the misinformation spread by tobacco industry, everyone must appreciate government's decision which is in interest of Pakistan's health and economy. 
