

ISLAMABAD: A sessions court in Islamabad on Monday ordered the arrest of a Pakistan Tehreek-e-Insaf (PTI) leader in a sedition case.

A case was registered against Gill at the Kohsar police station, Islamabad. He was accused of creating a divide in the state institution. Additional sessions judg e Tahir Abbas Sepra took up the case of sedition against Gill.

At the outset of the hearing, the judge said Gill is deliberately delaying the proceedings of the case.

Upon his continuous absence from the proceedings, the court ordered Federal Investigation Agency (FIA) to arrest Shahbaz Gill and present him before the court if he appear at any airport in Pakistan.

The court also directed National Database and Registration Authority (NADRA) chairman to block the Computerized National Identity Card (CNIC).

The court also directed authorities concerned to fix notice of absconder at his Faisalabad residence. The details of properties under Gill's name in Faisalabad and Islamabad has also been sought by the court.

Pakistan conveys demarche to US envoy over Biden-Modi joint statement 😂 Spokesman Report

ISLAMABAD: Pakistan on Monday summoned United States (US) Deputy Chief of Mission to Foreign Office (FO) and conveyed a demarche regarding the US-India Joint Statement issued after a meeting between Indian Prime Minister Narendra Modi and President Joe Biden.

"The US Deputy Chief of Mission was called to the Ministry of Foreign Affairs (MoFA) this evening and a demarche was made to him regarding the June 22 US-India Joint Statement," the foreign office spokesperson said in a statement.

The FO spokesperson noted that Pakistan's concerns and disappointment at the unwarranted, one-sided and misleading references to it in the Joint Statement were conveyed to the US side.

"It was stressed that the United States should refrain from issuing statements that may be construed as an encouragement of India's baseless and politically motivated narrative against Pakistan," it added.

The statement concluded by saying that it was also emphasised that counter-terrorism co-operation between Pakistan and US had been progressing well and that an enabling environment, centered around trust and understanding, was imperative to further solidifying Pakistan-US ties.

Monetary policy: SBP hikes interest rates to 22pc in 'emergency meeting'

ISLAMABAD: The Mone-Policy Committee (MPC) of State Bank of Pakistan (SBP), in an 'emergency meeting', raised its key interest rate by 100 basis points (bps) to 22 percent, days after it announced to keep policy rate unchanged.

Taking to Twitter, the SBP's MPC explained that the potential upside risks to the inflation outlook had increased from its last meeting on June 12.

"MPC views that these risks are mainly coming from the implementation of new measures in the fiscal and external sectors, which are important in the context of completion of the ongoing IMF (International Monetary Fund) programme.

"MPC noted that today's action is necessary to keep the real interest rate firmly in positive territory on a forward-looking basis that would help in bringing down inflation towards the medium-term target of five to seven percent by the end of fiscal year

25," the central bank stated. In a press release issued today, the central bank stated that "two important domestic developments" since its June

12 meeting had slightly deteriorated the inflation outlook and could potentially increase pressure on the already stressed external account.

"First, there are certain upward revisions in taxes, duties and petroleum development levy rate in FY24 budget as approved by the National Assembly on June 25. Second, the SBP, on June 23, withdrew its general guidance for commercial banks on prioritisation of imports," the press release reads.

It added that while the MPC viewed these measures as "necessary" in the context of the ongoing IMF programme's completion, they had nonetheless increased the upside risks to the inflation outlook.

The committee said it was of the view that additional tax measures are likely to contribute to inflation both directly and indirectly, while the relaxation in imports may exert pressures in the foreign exchange market.

Pakistan likely to sign staff-level agreement with IMF today

ISLAMABAD: Pakistan is likely to sign the staff-level agreement with the International Monetary Fund (IMF) today.

According to sources, Pakistan has met 90 percent conditions for the staff-level agreement with IMF.

Sources said that Pakistan has also abolished the scheme to bring \$0.1 million to the country annually and the interest rate has been increased by one percent. The basic interest rate has been hiked from 21 percent to 22 percent.

The memorandum of economic and financial policies which includes nine tables has been sent to IMF and the financial experts of the IMF will analyze the memorandum now, sources added.

Source further revealed that talks for the staff-level agreement will take place tonight and Finance Minister Ishaq Dar will finalize the staff-level agreement with the IMF.

Earlier, Federal Minister for Finance and Revenue Ishaq Dar said that Paki-

stan has fulfilled all necessary conditions of the International Monetary Fund (IMF) and "no hurdle is now left" in the signing of a staff-level agreement. He noted that the government has introduced a number of changes to its fiscal 2024 budget in a last-ditch effort to clinch a stalled rescue package with the international lender.

For the fiscal year starting next month, the federal government will raise a further Rs215 billion in new tax and cut Rs85 billion in spending, as well as a number of other measures to shrink fiscal deficit, he said.

It is pertinent to mention here that Prime Minister (PM) Shehbaz Sharif met with IMF Managing Director Kristalina Georgieva on the sidelines of the Global Financing Summit in Paris.

During the meeting, the two exchanged views on the ongoing programs and cooperation between Pakistan and IMF. Recalling their recent telephone conversation on 27 May 2023, the premier apprised Ms. Georgieva of Pakistan's economic outlook.

Have Pakistan Army officials torched the Yadgar-e-Shuhada and vandalised them by their own hands?"

"Who was inciting people to increase arson in the country amid May 9 riots? A specific political group and its leadership had left no option other than spreading lies, discrimination and propaganda.

Human rights violations

DG ISPR rejected the reports of human rights violations in Pakistan.

He said that such narratives were mostly hatched in foreign countries.

"HR violations were aired in different ways like spreading old videos and photos on social media to defame Pakistan. Later, specific people, foreign agencies and NGOs were asked to give statements on the basis of hidden contacts or money."

'The government is fully aware and it briefed the foreign embassies and international media about the false propaganda of HR violations. The facilitators and planners of the May 9 riots cannot hide behind the propaganda of human rights violations. The time has arrived to eliminate the currency of lies."

"Social media propaganda is a serious issue and the government is working on it. The journalist community should also promote responsible journalism." He urged the authorities to devise mechanisms for ending impatience and turmoil in society.

ISLAMABAD: Minister for Information and Broadcasting Marriyum Aurangzeb on Monday announced finalization of the country's first-ever music policy draft, which would ultimately prove to be a big news for the industry.

The new policy incentives and initiatives would eventually boost the music industry since they would effectively redress piracy, copyrights and other pertinent issues, she said in a statement.

The minister said the music policy had been prepared in accordance with the international standards and also considering the relevant laws in vogue in the neighbouring countries

She said the artists' public 22-7 performance, production, -79 distribution, adaptation, duration, and mechanical and



communication rights were also brought into legal framework through the policy.

Through such measures, the problem of users and licensees would also be solved, which would give a boost to the music industry, she added.

The minister said the end of monopoly, the basic legal rights of music industry workers would also be protected under the proposed policy. All issues and demands of the

music stakeholders, including copyrights, would be resolved, she reiterated.

The policy, she said, would also protect the legal rights of music producers, singers, writers and lyricists, besides resolving the long-standing issues of the industry related to sales, copying and piracy.

The minister said the policy also included special measures to preserve classic music, and initiatives for local and folk

music to promote regional singers and artists.

She said under the policy, steps would be taken to not only preserve bust also promote Pakistan's musical heritage, which was rich being a unique combination of Sufi poetry, with classic and modern music.

Marriyum said music could be termed "the soul and spirit" of the Pakistani society, rather it was a national and cultural identity, which was being brought forward from generation to generation.

Since the 1970s, she said, "no policy parameters, including legislative and administrative, for the music industry have been introduced. The new policy will fully protect the copyright, which help compose quality music for masses

Both Pakistan and the music industry were suffering due to the theft of intellectual rights, she added.

Through our column, we request the Chief Minister, Commissionerand Deputy Commissioner Multan to address the concerns raised by the price control magistrate and provide essential items to the public, such as rice, lentils, meat, milk, yogurt, double roti (Bread), flour, sugar, ghee, and eggs at controlled and affordable prices. The CPO and DPOs should be directed to SHOs immediately register FIRs based on the appeals of price control magistrates and send the culprits to jail. Only through such practical actions can hoarders and profiteers be brought under legal jurisdiction. In this way, price control magistrates can work with honestly, unity and confidence. The Deputy Commissioner should hold a meeting on a regular basis, once a week, to assess the performance and mechanism of the price control magistrate. Officers who show good performance should be appreciated and rewarded with certificates and incentives to motivate them to work better among their contemporaries.



US Coast Guard opens probe into Titanic submersible implosion

The US Coast Guard has launched an investigation to identify the factors involved in the underwater implosion of the tourist submersible that killed all five people aboard amid a dive to see the century-old wrecks of the Titanic.

The announcement comes a day after the Canadian Transportation Safety Board said it was conducting an independent probe into the Titan's tragic fate, which has raised questions about the unregulated nature of such expeditions.

"My primary goal is to prevent a similar occurrence by making the necessary recommendations to enhance the safety of the maritime domain worldwide," Captain Jason Neubauer, the Coast Guard's chief investigator, said at a press conference in Boston.

The Coast Guard opened what it calls a marine board investigation on Friday, Neubauer said, and is working with the FBI to recover evidence, including a salvage operation at the debris site on the seabed about 1,600 feet (488 meters) from the bow of the Titanic wreck, about 2-1/2 miles (4 km) below the surface.

The findings will be shared with the International Maritime Organisation and other groups "to help improve the safety framework for submersible operations worldwide," Neubauer said

Faithful swarm from Makkah to Mina for Hajj climax



MINA: Hundreds of thousands of pilgrims walked or rode buses Monday to a giant tented city near Makkah for the climax of the annual Hajj that Saudi officials say could break attendance records.

After performing the ritual circumambulation of the Ka'abah at Makkah's Grand Mosque that Muslims pray towards each day, the faithful set off for Mina, about seven kilometres away, in suffocating heat.

Pilgrims in robes and sandals, many carrying umbrellas against the beating sun, undertook the journey on foot or crowded onto hundreds of air-conditioned buses provided by Saudi authorities.

They will spend the night in white tents in Mina, which every year hosts the world's largest encampment, before the Hajj's high-point on Tuesday: prayers at Mount Arafat, where the Holy Prophet Mohammed (PBUH) is said to have delivered his final sermon.

'My dream has come true," said Jamila Hammoudi, a 62-year-old Morrocan school teacher. "I will pray for everyone," she told AFP after arriving in the tented city.

Shortly after midday, pilgrims packed most of the tents, which contain two to three beds and are fitted with water and food.

Many were overcome by the experience as they fulfil a lifelong dream at the sites where Islam began.

Saudi officials say this year's Hajj - one of the five pillars of Islam - could be the biggest in history. After 2.5 million attended in 2019, numbers were capped in 2020, 2021 and 2022 because of the COVID pandemic.

The pilgrimage has seen multiple crises over the years, including militant attacks, deadly fires and a 2015 stampede that killed up to 2,300 people. There have been no major incidents since.

Stocks witness 1,372-point bull-run as IMF loan hopes rekindle 腾 TLTP

KARACHI: Pakistan Stock Exchange (PSX) witnessed a massive bull run on Monday after Saturday's revised budget rekindled hopes for revival of the stalled International Monetary Fund (IMF) loan programme, with the benchmark KSE-100 Index gaining 1,371.78 points (+3.42 percent) to close at 41,437.10 points.

The State Bank of Pakistan (SBP) on Friday announced the withdrawal of all restrictions on imports to facilitate the industrial sector and meet one of the IMF's conditions. All these steps ignited hopes of resumption of the IMF programme and resulted in across-the-board buying. The stocks witnessed the highest day-on-day points increase since April 2022.

The market opened on a bullish note and remained positive throughout the session. The benchmark index saw an intraday high of 41,491.87 points and an intraday low of 40,334.05 points. Among other indices, the KSE All Share Index gained 763.67 points (+2.73 percent) to close at 27,965.97 points, while KMI All Share Islamic Index gained 497.17 points (+2.43 percent) to close at 20,421.28 points.

Total volumes traded for the KSE-100 Index more than doubled to 122.32 million against 59.55 million a session earlier, showing an increase of 62.77 million shares. The overall market volumes increased by 84.49 million to 221.39 million shares against 136.9 million shares a session earlier.

Among scrips, WTL topped the volumes with 26.226 million shares, followed by FFBL (13.15 million) and SNGP (12.50 million). Stocks that contributed significantly to the volumes included WTL, FFBL, SNGP, OGDC, and TPLP, which formed around 31 percent of total volumes.

A total of 324 companies traded shares in the stock exchange as compared to 311 a session earlier. Out of traded companies, shares of 267 closed up, shares of 42 closed down while shares of 15 companies remained unchanged. A total of 94 companies traded shares in the KSE-100 Index against 90 companies a session earlier, out of which shares of 86 companies closed up, four closed down and four remained unchanged.
