Arrears: Chinese company warns to close Thar coal production work

KARACHI: Chinese coal company has cautioned to close coal production in Thar Coalfield over non-payment of arrears.

The production at Thar coalfield could be suspended after September 10, resulting in shutdown of 1320 megawatts power generation from the region, sources said.

The arrears of China Machinery Engineering Corporation have soared to US\$50 million, and delay in June to August payments causing difficulties for the company to perform its contract issues, sources said.

The firm's China head office has given deadline for recovery of all payables by October.

In the next four months more 30 million dollars would also require to be paid, and the contract period will by concluded in four months.

Chinese firm has informed the Sindh Engro Coal Mining Company in a letter that it could not continue coal production from Thar Coal Block-2 if the arrears would not be paid by September 10.



'President has no role in election date', Law ministry tells Alvi

ISLAMABAD: The Ministry of Law on Wednesday told President Arif Alvi that he has no role in the announcement of date for general elections "following the amendment in Elections Act".

The law ministry has forwarded its response to President Alvi's letter, seeking opinion on Election Commission of Pakistan's (ECP) stance that "only it had the authority to decide the election date".

In the letter, the Law ministry said that the right of the Election Act was a single authority can give date announcing the date of election rests with the Election Commission of Pakistan (ECP).

"According to Article 48(5) of the Constitution, where the National Assembly is dissolved by the President, he shall appoint a date for election and appoint a caretaker cabinet in accordance with the provision of Article 224 or as the case may be under Article 224-A," the ministry said in the letter.

Experts call for leveraging waste to energy for decarbonization of cement sector and industries

Spokesman Report

ISLAMABAD: Decarbonization of cement sector and other industries requires strengthening of the regulatory and policy ecosystem, innovative technologies to replace carbon-intensive cement and reliable and affordable alternate energy sources like waste to energy to offset carbon emissions from cement supply chain. These were the recommendations stressed by experts at a special guest lecture on "Charting the course of Decarbonization Driver's on Pakistan's Cement Industry" with Ahsan Anis, Chief Operating Officer, of Power Cement Limited. The event was jointly organized by Sustainable Development Policy Institute (SDPI) and Policy Research Institute for Equitable Development (PRIED).

Speaking at the session, Ahsan Anis, Chief Operating Officer, of Power Cement Limited apprised about the decarbonization initiatives being taken by Power Cement including a FLSmidth plant with 7700 tonnes/day production capacity since 2020 to increase efficiency, investment in solar, wind, and waste-to-energy power generation for sustainable, clean and affordable energy supply.

Dr Vaqar Ahmed, Joint Executive Director, SDPI stressed strengthening regulatory and policy support mechanisms to facilitate decarbonization in not just cement but other sectors producing the construction materials, and industrial input.

Highlighting the barriers hindering cement sector's decarbonization Dr Ankita Gangotra, Associate Industrial Innovation, Climate Program at World Resources Institute emphasized on creating awareness on clinker substitution, establishing performance standards to steer decarbonization of cement sector.

Sunil Dahiya, energy analyst at Centre for Research on Energy and Clean Air (CREA) remarked that lack of clarity on long-term expansion pathways for decarbonization hinder sustainable progress. He urged that governments must demonstrate political commitment by prioritizing consumption of low-carbon, construction in PSDP infrastructure projects and aligning public procurement with responsible consumption principles


Masses are being sacrificed for the interests of elite

Saifuddin Sheikh, Executive Director of Pakistan Economy Watch (PEW) on Wednesday that the integrity of the country and interests of the masses are being compromised for the sake of the elite.

The previous government has left after creating a crisis in the country and exposing people to unmanageable problems, he said.

The IMF will have no objection to reducing the price of electricity; therefore, people should not be misled on the issue of electricity rates, he added.



But the situation is otherwise in Pakistan, where the people are not given any facilities but are subjected to excessive taxation and the highest possible electricity tariff.

He said that if the IMF were asked to reduce electricity bills, it would have no objection, but the lender would demand a plan to cover the deficit, which would mean increasing the government's income.

Increasing government income will be very difficult as the tax-paying sector is already paying too much tax and cannot bear any more burden while collecting tax from the non-tax-paying sector was never a priority.

Similarly, the corrupt and ruthless elite will not be brought into the tax net in any case, even if it affects the integrity of the country, he observed. He said that the government would be left with the option of making gasoline more expensive and increasing the tax on imports to increase

He said that tax collectors are more interested in collecting benefits than fulfilling their responsibilities. They always avoid direct taxation, and they are totally dependent on indirect taxes, which means that even if these institutions are closed, the tax revenue of the government will decrease by only 10%. He said that the price of sugar had increased by 23 rupees in the

month of August, and now it has become more expensive than flour. India has banned the export of sugar, but its smuggling from Pakistan continues unabated because the smugglers pay the sugar mafia in dollars.

He noted that serving elites is the common agenda of all the administrations in Pakistan, and they have nothing to do with the welfare of

Online crime in **Southeast Asia**

undreds of thousands of people are being coerced in Southeast Asia by criminal gangs into carrying out online scams, often under the threat of torture, the UN Human Rights Office (OHCHR) has said. Many have been trafficked into working in online criminal-

ity and face serious violations such as torture or sexual violence, OHCHR, which is based in Geneva, said in a report.

"People who are coerced into working in these scamming operations endure inhumane treatment while being forced to carry out crimes," UN human rights chief Volker Turk said in a statement.

"They are victims. They are not criminals." OHCHR said that at least 120,000 people across Myanmar and another 100,000 in Cambodia may be held in situations where they are forced to execute lucrative online scams - from illegal gambling to crypto fraud. Other States including Lao PDR, the Philippines and Thailand have also been identified as the main countries of destination or transit.

The latest OHCHR report sheds new light on cybercrime scams that have become a major issue in Asia, with many workers trapped and forced to participate in scams targeting people over the internet. The report notes workers face a range of serious human rights violations, and many have been subjected to abuses such as torture, arbitrary detention, sexual violence and forced labour. Victims of such operations can be scammed for an average of \$160,000 each, often through sophisticated scripts sent via unregulated social media applications.

According to OHCHR, these victims come from across the ASEAN region as well as mainland China, Hong Kong and Taiwan, South Asia and even further afield from Africa and Latin America.

Turk called on States to ensure justice "for the people who have been so horrifically abused." Speaking in Geneva, Pia Oberoi, OHCHR's Senior Advisor on Migration and Human Rights in the Asia Pacific, said ongoing regional "economic distress" paired with the COVID-19 pandemic has meant there is a lack of regular and safe pathways towards decent work opportunities. "This has meant populations are more likely to rely on recruitment forums or intermediaries," so criminal gangs are increasingly targeting individuals through these platforms, suggesting victims are destined for real jobs.

"There weren't red flags being raised" – particularly for the more educated, multilingual young men who the report notes are frequent victims.

"It follows a pattern of how labour migration has taken place in the region, and also speaks to the sophistication of these fraudulent recruitments," added Ms. Oberoi.

According to OHCHR, the COVID-19 pandemic and associated response measures had a drastic impact on illicit activities across the region – with increased virtual work and the movement of businesses to less regulated spaces.

Ms Oberoi said the situation is "unfolding in locations where regulation is weak," such as conflict-affected border areas in Myanmar, "with little to no rule of law" and in "laxly regulated jurisdictions such as special economic zones in Laos PDR and Cambodia." This has exposed its distaste for CPEC. New Delhi views the Belt and Road Initiative (BRI) and CPEC as strategic challenges to its hegemonic ambitions and geo-political challenges against which India is making efforts to undermine CPEC and China's interests.

Russia claims Prigozhin plane may have been downed deliberately

The Russian government said on Wednesday that authorities looking into the cause behind the plane crash of mercenary Wagner chief Yevgeny Prigozhin are considering the possibility of the plane being downed on purpose.

This is the first explicit acknowledgement by the Kremlin that Prigozhin may have been assassinated.

"It is obvious that different versions are being considered, including the version-you know what we are talking about - let's say, a deliberate atrocity," Kremlin spokesman Dmitry Peskov told reporters when asked about the investigation.

When asked if the International Civil Aviation Organisation would investigate the crash, Peskov said that the circumstances made it different, though he cautioned that investigators had made no formal conclusions yet about what exactly took place.

Let's wait for the results of our Russian investigation," Peskov said. The private Embraer jet on which Prigozhin was travelling to St Petersburg from Moscow crashed north of Moscow killing all 10 people on board on 23 August, including two other top Wagner figures, Prigozhin's four bodyguards and a crew of three

The cause is still unclear, but villagers near the scene told Reuters they heard a bang and then saw the jet plummet to the ground.

The plane crashed exactly two months since Prigozhin took control of the southern city of Rostov in late June, the opening salvo of a mutiny which shook the foundations of President Vladimir Putin's Russia.

Russia has informed Brazil's aircraft investigation authority that it will not probe the crash of the Brazilian-made Embraer jet under international rules "at the moment", the Brazilian agency told Reuters.

Asked about that report, Peskov said: "First of all, the investigation is underway, the Investigative Committee is engaged in this.

People paying price of installing unnecessary power plants, says Mian Zahid Hussain

ISLAMABAD: Chairman of National Business Group Pakistan, President Pakistan Businessmen and Intellectuals Forum, and All Karachi Industrial Alliance, and former provincial minister Mian Zahid Hussain said on Wednesday that the power sector is destroying the economy and wiping out the middle class.

There will be no middle class in Pakistan if the electricity tariff is not reduced immediately, he said.

Mian Zahid Hussain said that if the price of electricity can vary in different states and provinces in neighbouring India, why is it not possible in Pakistan? Talking to the business community, the


Power houses are manufactured locally in India while in Pakistan everything is imported, he said, adding that wind, solar, and hydropower are also cheaper in the neighbouring country, and payments to the investors are made in local currency, while in Pakistan we are forced to pay in dollars.

In addition, other countries in the region have not seen massive currency devaluation and skyrocketing interest rates, while in Pakistan, the rupee is depreciating due to an annual gap of \$20 billion in revenue and expenditure.

Due to the difference in income and expenditure, the country remains under pressure, and electricity also becomes expensive. Line losses, unpaid bills, and electricity theft are also veteran business leader said that the policy of rampant in Pakistan, he said.

The business leader said Rs 800 billion worth of electricity is stolen per year, and honest consumers of electricity have to pay

for these losses.

only 2600 MW of electricity is generated from supply of electricity; consumption of electric-increased, and the production of electricity from furnace oil should be completely banned.

Surplus electricity should be provided to industries at cheap rates in the winter. Cheap electricity should be added to the energy basket, he demanded.

17.5% GST is being levied on electricity bills which is 5% in neighbouring India and 10% in developed countries. People's income in Pakistan is lower than in developing countries, while amenities are lower than in Africa, and GST on electricity bills is higher than in Japan, China, Australia, and South Korea, which is surprising.

Mian Zahid Hussain said that the IMF has prohibited Pakistan from selling electricity at a loss, but it has not imposed any restrictions on GST, so this cruel tax should be reversed immediately.

England's women cricketers awarded match fee parity with men

England's women cricketers will be paid the same match fees as their male counterparts, the England and Wales Cricket Board announced on Wednesday.

The pay increase, which follows similar moves in New Zealand and India, will take effect immediately, beginning with the Twenty20 series against Sri Lanka, which starts on Thursday.

The change was recommended by the Independent Commission for Equity in Cricket report in June, which said "wome receive an embarrassingly small amount compared to men".

The report said match fees for the England women's team were a quarter of those paid to the men's team for white-ball games while

the figure was just 15 percent for Tests. ECB chief executive officer Richard Gould said the recent "thrilling" Ashes series against Australia, watched by record-breaking crowds, showed the growing popularity of the women's game.

"We all want cricket to be the team sport of choice for female athletes and — with the investments we are making and increasingly lucrative opportunities around the world – we are seeing cricketers become some of the highest-earning female athletes in UK team sports," he said.

"However, we know there is still much further to go as we ultimately strive for equality across the game."

Australia retained the Ashes after the multi-format series ended in a draw. England captain Heather Knight

described the equalising of match fees as "fantastic to see".

"The direction of travel for the women's game has always been the most important thing, creating a sustainable product that people want to watch and play and I'm sure this will make cricket an increasingly attractive sport to girls and young women as we continue to grow the game," she added.
