## Xi, Biden hold phone talks



BEIJING: Chinese President Xi Jinping spoke with U.S. President Joe Biden on the phone Tuesday at the request of the latter. The two presidents had a candid and in-depth exchange of views on China-U.S. relations and issues of mutual interest.

President Xi noted that his San Francisco meeting with President Biden last November opened a future-oriented San Francisco vision. Over the past months, their officials have acted on the presidential understandings in earnest. The China-U. S. relationship is beginning to stabilize, and this is welcomed by both societies and the international community. On the other hand, the negative factors of the relationship have also been growing, and this requires attention from both sides.

President Xi stressed that the issue of strategic perception is always fundamental to the China-U.S. relationship, just like the first button of a shirt that must be put right. Two big countries like China and the United States should not cut off their ties or turn their back on each other, still less slide into conflict or confrontation. The two countries should respect each other, coexist in peace and pursue win-win cooperation. The relationship should continue moving forward in a stable, sound and sustainable way, rather than going backward.

President Xi underlined three overarching principles that should guide China-U. S. relations in 2024. First, peace must be valued. The two sides should put a floor of no conflict and no confrontation under the relationship, and keep reinforcing the positive outlook of the relationship. Second, stability must be prioritized. The two sides should refrain from setting the face of "Taiwan independence" separatist



relationship back, provoking incident or activities and external encouragement and crossing the line, so as to maintain the overall stability of the relationship. Third, credibility must be upheld. The two sides should honor their commitments to each other with action, and turn the San Francisco vision into reality. They need to strengthen dialogue in a mutually respectful way, manage differences prudently, advance cooperation in the spirit of mutual benefit, and step up coordination on international affairs in a responsible way.

President Xi stressed that the Taiwan question is the first red line that must not be crossed in China-U. S. relations. In the support for them, China is not going to sit on its hands.

He urged the U.S. side to translate President Biden's commitment of not supporting "Taiwan independence" into concrete actions. The U.S. side has adopted a string of measures to suppress China's trade and technology development, and is adding more and more Chinese entities to its sanctions lists. This is not "de-risking," but creating risks. If the U.S. side is willing to seek mutually beneficial cooperation and share in China's development dividends, it will always find China's door open; but if it is adamant on containing China's hi-tech

development and depriving China of its legitimate right to development, China is not going to sit back and watch.

President Xi stated China's position on Hong Kong-related issues, human rights, the South China Sea, and other issues.

President Biden reiterated that the United States does not seek a new Cold War, its objective is not to change China's system, its alliances are not targeted against China, the U.S. does not support Taiwan independence," and the U.S. does not seek conflict with China.

The two presidents also exchanged views on the Ukraine crisis, the situation on the Korean Peninsula, and other issues.

Earlier, DIG Operations Islamabad, Shehzad Bukhari in his statement before the IHC said apart from eight IHC judges, four SC and four LHC judges have also received 'suspicious letters'.

DIG Operations Shehzad Bukhari was summoned to Islamabad High Court by CJ Justice Aamer Farooq after six judges of the high court received 'suspicious letters' on Tuesday.

Upon being asked, where the letters were posted? the DIG operations said letters were 'dispatched from Rawalpindi GPO'.

## PHC CJ decries 'discrimination' in SC judges' appointment

PESHAWAR: In a letter to Chief Justice of Pakistan (CJP) Justice Qazi Faez Isa, Peshawar High Court (PHC) Chief Justice Mohammad Ibrahim Khan has expressed dismay over alleged discrimination in the appointment of Supreme Court judges'

The PHC chief justice said that he was writing to CJP Isa regarding the alleged discrimination and favouritism in the appointment of judges in the Supreme Court of Pakistan.

Justice Khan said that despite four vacancies in the top court, Justice Naeem Akhtar Afghan was appointed as the SC judge while his name was not considered for a position at the Supreme Court.

Expressing dismay that the only judge appointed to the top court was from the same prov-



ince CJP Qazi Faez Isa hailed from i.e., Balochistan, he said that his name was not considered despite seniority, availability and eligibility.

He raised questions over ignoring his name for appointment as the SC judge despite being the second most senior chief justice among all of the high courts.

In the letter, Mohammad Ibrahim Khan said being a member of the Judicial Commission and the Supreme Judicial Commission, he expected to be included in the list for elevation to the Supreme Court of Pakistan.



According to details, on the instructions of Prime Minister of AJK crack down operation had been contained with full pace against the tax evading cigarette manufacturing factories in the areas of AJK. In this regard raids were conducted on gowdowns and different offices of National Tobacco Company, Walton Tobacco Company and Chinar Tobacco Company in Mirpur, Bhimber and Barnala.

During a raid on Walton Tobacco Company, government authorities have seized 10 cartons of illegal cigarettes, 10 bags of tobacco to prepare 100 million cigarettes and 19 cigarette paper rolls and other related material.

In another operation, government authorities raided godowns of National Tobacco Company, Bhimber and seized 3,811 cartons of illegal cigarettes and more than 384,000 kgs of raw tobacco.

In another operation, authorities had raided a house which was taken on rent by National Tobacco Company. During raid, the authorities seized 85 cartons filter rods, 67 cartons cigarette paper, 17 cartons illegal cigarette, 16 cartons cigarette tape, 10,000 kgs of raw tobacco and other raw material.

In a separate raid at Chanar Tobacco Company, Barnala the authorities confiscated 731 bags of tobacco.

It is pertinent to mention that the AJK authorities had increased its crackdown operation against cigarette manufacturing factories involved in tax evasion in the premises of AJK.

At the moment, AJK tax authorities are losing billions of rupees annually only due to tax evasion in the cigarette sector of AJK. These illegal cigarettes which are manufactured in AJK are smuggled to the various areas of Punjab. It is interesting to mention that despite passing of last final date, track and trace system had not been implemented in the cigarette factories located in the areas of AJK.

### **Pakistan rebuts India's** claim of Kashmir being its 'integral part'

akistan Tuesdav hit back at India for claiming Kashmir to be its 'integral part, saying that repeating a wrong position would not make it acceptable at any forum. "Let me reaffirm that Jammu and Kashmir is an internationally recognized disputed territory and is not, by any means, a so-called integral part of India", Pakistani delegate Gul Qaiser Sarwani said, while responding to comments by India's representative during the general debate of the UN Disarmament Commission, which began its 2024 session on Monday.

The Indian representative, who was was reacting to Pakistani Ambassador Munir Akram's speech to the Commission on the opening day, claimed that Jammu and Kashmir was an "integral part' of India, and accused Pakistan of being involved in terrorism. The Indian representative also accused Pakistan of misusing the forum by raising the Kashmir dispute. In his speech, besides other issues, Ambassador Akram had highlighted that Kashmiris and Palestinians were among the peoples still denied the right to self-determination, asserting that India's large-scale arms acquisitions plus its set of aggressive military policies has turned the security environment in South Asia "volatile and explosive". Exercising his right to reply, Sarwani, the Pakistani delegate underscored that Jammu and Kashmir is an internationally recognized disputed territory and not an "integral part of India", and that Ambassador Akram's remarks were completely relevant to the work of the Commission. "Contrary to India's assertion, the situation in the Indian illegally occupied Jammu and Kashmir, India's massive arms build up, aggressive posturing, and war-fighting doctrines are completely relevant to the Commission's work, as they carry grave implications for regional and international peace and security – and hence impinge on efforts towards disarmament," Sarwani added. The Pakistani delegate said that his country was facing a significant threat of terrorism, which is orchestrated, supported and financed by its Eastern neighbour (India), a well-known state sponsor of terrorism whose terrorist network has gone global, reaching countries far beyond its borders. Sarwani reiterated Pakistan's stance on the longstanding Jammu and Kashmir dispute, emphasizing that it remains on the agenda of the UN Security Council and that its final disposition is to be determined by its people through a UN-supervised plebiscite. On the programme of work of the Conference on Disarmament (CD), Sarwani expressed Pakistan's concerns over India's emphasis on the Fissile Material Cut-off Treaty (FMCT), which disproportionately affects Pakistan's nation-

# Threatening letters: The Perilous Path of Pakistan's Judges

serious allegations raised by six judges regarding attempts to intimidate them into favorable rulings. At the outset, the Chief Justice and the government exchanged mutual praise for addressing the matter seriously, with the constitution of a one-man commission. Expressing regret over conspiratorial statements against Syed Tassadaq Jilani, who felt intimidated, recused himself from this significant responsibility.

The initial two hours of the session were dedicated to providing a thorough explanation, aimed at dispelling any perception that the Supreme Court was avoiding its responsibility. Despite this, the Chief Justice unequivocally affirmed the independence of the judiciary and vowed to defend it vigorously. The discussion also addressed long standing issues that have been overlooked, including instances where the Supreme Court's orders have been obstructed. Specifically, recent bail orders issued by the Supreme Court were frustrated by frivolous and illogical Magistrate's Preventive Orders (MPOs) issued by deputy commissioners.

One judge made a striking statement, acknowledging the intimidation, coercion, and blackmail faced by the judiciary to sway decisions according to certain interests. This candid admission highlighted the need to confront the reality of these challenges rather than turning a blind eye. Although the attorney general reflected the full cooperation of the government to proceed with the impugned case, it was evident that the jurisdiction of the civil idation tactics.

er, was met with a chilling response. Anonymous letters filled with threatening poisonous powder arrived, target-

ing all judges of the Islamabad High Court and today two judges of the Lahore High Court also received the same threatening letters, adding to the atmosphere of fear and intimidation.

However, conveniently, during the hearing of the suo moto case, the Supreme Court did not make even a passing reference to this stunning development. It is evident that such serious threats are not only targeting the judges of the High Court but also the judges of the Supreme Court who are currently hearing the impugned case.

It serves as a brazen warning that any attempt by the Supreme Court to challenge or investigate alleged interference from powerful entities will be met with intimidation and threats. This act seeks to undermine the authority and independence of the judiciary, signaling that even the highest echelons of the legal system are not immune to coercion and intim-

Additionally, it reflects a broader assault on the rule of law and the principles of democracy, as it seeks to silence judicial scrutiny and accountability. The message is clear: any attempt to uphold justice and transparency will be met with severe consequences, creating a climate of fear

and intimidation within the judicial system.

My sympathies also go to the CJSC who finds itself in an extraordinarily challenging position, torn between the imperative to safeguard the judiciary's independence and credibility and the immense pressure exerted by various political interests seek-

ing to exploit the situation for their own gains. With the integrity of the judiciary hanging in the balance and the hopes of 250 million citizens relying on the court's ability to deliver justice, the Chief Justice bears the weighty responsibility of liberating the judiciary from the grip of intimidation and restoring its capacity to administer impartial justice.

However, he is keenly aware of the delicate equilibrium necessary to maintain positive relations with the establishment, crucial for ensuring the safety of judges and their families. Yet, the Chief Justice faces an unparalleled dilemma: how to address the presence of unscrupulous elements within the intelligence agencies when no individual, entity, or institution possesses the authority to compel these operatives to adhere to the constitution and the law of the land.

to provide clarity on the term "Establishment." When the judiciary refers to alleged interference from intelligence agencies in its core functions of dispensing justice fairly, transparently, and without bias or fear, it pertains to a small faction within these agencies. These individuals may disregard the constitution, the rule of law, and the welfare of the Pakistani people. Their actions aim to manipulate the judiciary for what they perceive as the greater good and in the greater national interest, but they overlook that true progress and prosperity of any country can only be achieved through a judiciary that operates freely, fairly, and transparently and without facing any undue influence.

The six judges who bravely stepped forward as whistleblowers have rendered invaluable service to both the judiciary and the nation. Their decision to speak out, despite the grave risks to their own lives and those of their loved ones, underscores the immense pressure they must have endured in carrying out their duties. Ultimately, they reached a point where they could no longer bear the burden alone and turned to the Chief Justice of the Supreme Court for assistance. It's essential to recognize that the Chief Justice, like any human being, is vulnerable to the same dangers faced by those who spoke out. Moreover, while the constitution of Pakistan ostensibly extends its protections nationwide, analysts suggest there are areas where its authority is challenged, posing additional complexities and risks.

**Bhutto is Alive** 

O years after Bhutto's execution, 9 members of the Supreme Court of Pakistan pronounced the decision that Bhutto was killed unjustly. This writ was filed in the Supreme Court of Pakistan in 2011 by the current President of Pakistan Asif Ali Zardari, the son-in-law of Zulfiqar Ali Bhutto Shaheed. And after 13 years, the Supreme Court declared Bhutto's execution as a "judicial mistake" and declared it unfair. Before Bhutto came to power, prominent columnist Mehmood Sham had an interview with Bhutto in 1969, in which Bhutto made education a priority for the country and the nation and said, "Education should be free for the development of the country. In this regard, free education will be our first step. Secondary education should be free. Our effort will be to make education and health as cheap as possible".

In short, the educational reforms that Qauid e Awam Zulfiqar Ali Bhutto Shaheed brought to power could not be done in the 77-year history of Pakistan. Today's youth needs to study the Bhutto era reforms, let's take a look at only the education sector among these reforms:

When Shaheed Zulfigar Ali Bhutto government was established, 6,500 elementary schools, 900 middle schools, 407 high schools, 51 Intermediate Colleges and 21


junior colleges were established. In 1974, the Bhutto government established the Abbasi Shaheed Hospital in Paposh Nagar Karachi, Sindh Medical College Karachi on 7 April 1973, Chandka Medical College Larkana on 20 April 1973 and Bolan Medical College Quetta in 1972, Punjab Medical College Faisalabad, Allama Iqbal Medical College Lahore (then Lahore Medical College) on 2 May 1975. The Bhutto government established Hayat Shaheed Teaching Hospital Peshawar (now called Khyber Teaching Hospital) in 1976. Instructions were issued to the hostels that fans, water coolers and pay telephones must be provided in every hostel within minimum time. After the 1977 elections, plans were made to add seven thousand new hostel seats to the existing accommodation.

For the first time during Bhutto's reign, agricultural land was limited to 150 acres of irrigated land and 300 acres of non-irrigated land. Huge tax concessions were also introduced for small landowners. Bhutto upgraded many dams and barrages. The Bhutto government initiated schemes to deal with water bodies and salinity. In 1976, the Bhutto government established the Federal Flood Commission (FFC), and banks to ensure 70 percent.

was tasked with research into the national flood prevention plan, flood forecasting and flood water utilization. The Bhutto government launched a program to make the country self-sufficient in rice, sugar, wheat and industries. Bhutto's nationalization of industries greatly benefited the poor masses, but deeply upset the powerful landlords. Chiefdom system was abolished in Balochistan. KESC was created and kept under full government control without any private influence. The Bhutto government also established these institutions:


Atomic Energy Commission of Pakistan, Port Qasim, Pakistan Steel Mills, Heavy Mechanical Complex Taxila (HMC), Company for Pak Air Force in Kamra (PAC) and several cement factories. The Bhutto government gave the Constitution of Pakistan in 1973 and during his tenure the National Identity Card was introduced for the nation. His govt. creat-

ed millions of jobs for skilled workers in the Gulf countries. Throughout Bhutto's tenure, despite the global oil crisis of 1973 and the absence of USAID and US sanctions, the economy's growth rate remained at equilibrium levels compared to the 1960s. Bhutto's policies benefited the poor and the working class more when absolute poverty levels fell sharply. The land reform program provided economic assistance to landless tenants. Development expenditure increased, particu-



larly in health, education, construction of roads, railways and airports. In order to maintain the flow of investment, foreign companies and industries in Pakistan were exempted from nationalization. Addressing investors at the Lahore Chamber of Commerce in 1973, Bhutto said: "Public sector or state sector activity prevents the concentration of economic power in a few hands, and protects small and medium-sized entrepreneurs from the clutches of giant corporations and vested interests.

In July 1973, Bhutto founded the National Development Finance Corporation (NDFC) with an initial government investment of Rs 100 million. NDFC is currently the largest development finance institution in Pakistan. 42 projects funded by NDFC have contributed Rs. 10,761 million and 10,761 million were generated in Pakistan's GDP, 690 million in after-tax profits and 40,465 jobs. The Bhutto government reduced the level of private and public investment in the economy from Rs. 17,000 million in 1974-75 from over Rs.7000 million in 1971-72. Bhutto amended banking laws to force



# Zulfikar Ali Bhutto didn't get fair trial, Pakistan court says in history-correcting verdict

Family and political supporters allege judges came under pressure from military ruler to sentence Bhutto to death

The Pakistan Supreme Court said on Wednesday former Prime Minister Zulfikar Ali Bhutto, hanged in 1979 following one of the country's most controversial legal cases, did not get a fair trial, a verdict widely seen by the ex-premier's family and political associates as a "correcting of history."

Bhutto was hanged on April 4, 1979, in Rawalpindi District Jail, where he had been confined since his conviction on charges of conspiring to murder a political opponent. The charismatic, Western-educated leader who founded the Pakistan Peoples Party (PPP) served as the fourth president of Pakistan from 1971 to 1973, and later as the country's ninth prime minister from 1973 to 1977. He was ousted in a military coup by General Mohammad Zia-ul-Haq on July 5, 1977, following an election in which Bhutto is widely charged with having rigged the vote.

Legal experts have for years questioned Bhutto's trial both in the Lahore High Court and the Supreme Court, and raised questions on the conduct and procedure of the hearings, as well as on the fact that they took place while Paki-

stan was under military rule. Analysts argue this is the reason Bhutto's death penalty judgment has never been cited as a precedent in any subsequent case in Pakistan's judicial history.

"The proceedings of the trial by the Lahore High Court and of the appeal by the Supreme Court of Pakistan do not meet the requirements of the fundamental right to a fair trial and due process enshrined in Articles 4 and 9 of the constitution," the chief justice said while announcing the unanimous opinion of the court under its advisory urisdiction.

The guilty verdict against Bhutto is still considered one of the most controversial milestones in Pakistan's history. His family and political supporters allege the judges came under pressure from Zia to sentence Bhutto to death.

Before his hanging, Bhutto was first declared guilty in 1978 by the Lahore High Court. His appeal in the Supreme Court was then dismissed with a 4-3 erdict.

The decision to hang Bhutto was made by General Zia despite a flood of petitions for executive clemency from dozens of world leaders, including US President Jimmy Carter, Russia's Leonid I. Brezhnev, Chinese PM Hua Guofeng and Pope John Paul II, besides thousands of Bhutto's Pakistani supporters.

Pakistani President Asif Ali Zardari. Bhutto's son-in-law, filed a presidential reference in 2011 to review the 44-yearold death sentence. Only six hearings



were conducted, the last of them in November 2012. A nine-member larger bench of the Supreme Court began rehearing the reference last December. Prime Minister Shehbaz Sharif, in a statement following the verdict, said the top court had set "a new tradition" through its opinion.

"The unanimous opinion of the Supreme Court in the Bhutto reference will help understand history at the national level through the right perspective," Sharif noted. "The process of national unity and development can be accelerated only by correcting the past mistakes and doing away with the bitterness."

The Bhutto family described the apex court's decision as "historic and bold," saving it has helped address the family's and the PPP's reservations after over four decades.

"This historic and bold opinion of the Supreme Court has helped correct the history besides addressing reservations of the family and the party," Zulfikar Ali Badar, PPP Chairman Bilawal Bhutto-Zardari's spokesperson, told Arab News

"The party leadership has welcomed the court's opinion," he said. "The party will announce a strategy on how to celebrate it after the court releases a detailed opinion on it."

Badar noted the court acknowledged its "historic mistake" and tried to correct it through a legal opinion. "The opinion is unanimous of all nine judges in the bench that is significant in many ways," he said.

Legal experts said that while the court gave an opinion on Bhutto's trial and procedural conduct, it had stopped short of giving its view on whether the ex-premier was guilty or not.

This is a legal opinion of the court which is obviously significant and historic, but the court has refrained from commenting on Bhutto's involvement in the murder case," advocate Usama Malik told Arab News.

"The court has, in fact, given an opinion against its own institution that should also be followed by other institutions to accept their past mistakes and correct the course."

He said the opinion remains "symbolic" if the Supreme Court fails to look into other important legal cases pending before it for adjudication, referring to a slew of criminal cases against former prime minister Imran Khan who has een in jail since August last year.

Former attorney-general of Pakistan, advocate Ashtar Ausaf, said the court's opinion was a "very significant" one as it had revisited a judgment that had been criticized all along.

"The conviction they say was a result of procedural impropriety and violated the right of Mr. Bhutto for a fair trial," he told Arab News. "This is a sad indictment of the criminal justice system that

was suffering even today."

He urged the government to request political parties to sit together and approve legislation that gets rid of "archaic and redundant" laws.

"The Supreme Court opinion is a wake-up call for all to do an introspection themselves," he said.

Salahuddin Ahmed, a legal expert and president of the Sindh High Court Bar Association, cautioned that the Supreme Court could only offer an advisory opinion in response to the presidential reference but not set aside the earlier verdict.

"It may, however, opine that the earlier verdict suffered on account of bias of one or more judges," he explained. "If so, it will not automatically set aside the earlier verdict but it will certainly give judicial acknowledgment to the widespread public and historical opinion that the Bhutto trial and execution was flawed and orchestrated by General Zia, the then military dictator.

"In my view, acknowledging and correcting the past judicial mistakes is important to correct the course going forward," Ahmed added

"The decision in the Bhutto murder trial cannot be reversed, but in Pakistan's political history, it will be proven that at another time, Pakistan's judiciary supported anti-democratic forces," academic and historian Dr. Riaz Ahmed Sheikh told Arab News a day before the SC verdict in the case.



Nearly 10 million devices hacked in 2023 by cybercriminals: *Kaspersky* 😂 PPA

ISLAMABAD: Nearly 10 million devices fell victim to data-stealing malware in 2023, Kaspersky Digital Footprint Intelligence has revealed, drawing from insights gathered from infostealer malware log files traded on underground markets. According to Kaspersky's data, 443.000 websites worldwide have experienced compromised credentials in the past 5 years. The.com domain leads to compromised accounts with nearly 326 million logins and passwords for websites on this domain were compromised by infostealers in 2023. While the compromised accounts of.pk domain in Pakistan reached 2.4 million.

Latest reports on data stealing shows a 643% increase over the past three years. The actual number of infections is likely to be even higher than 10 million. According to Kaspersky's assessment of infostealer log-file dynamics, the number of infections that occurred in 2023 is projected to reach roughly 16,000,000.

With cybercriminals pilfering an average of 50.9 login credentials per infected device, the threat posed by data-stealers is growing for both consumers and businesses. In light of this growing threat, Kaspersky has launched a dedicated web page to raise awareness of the issue and provide strategies for mitigating associated risks.

Threat actors either utilize these credentials for their own malicious purposes, including perpetrating cyberattacks, or sell or distribute them freely on dark web forums and shadow Telegram channels. These credentials may encompass logins for social media, online banking services, crypto wallets, and various corporate online services, such as email and internal systems.

"The dark-web value of log files with login credentials varies depending on the data's appeal and the way it's sold there. Credentials may be sold through a subscription service with regular uploads, a so-called 'aggregator" for specific requests, or via a "shop" selling recently acquired login credentials exclusively to selected buyers. Prices typically begin at \$10 per log file in these shops.

The Island nation wrapped up the win in the opening session of the fifth day of the final second of the two-match series at Zahur Ahmed Chowdhury Stadium and clinched a comfortable 2-0 series sweep.

Sri Lanka still has two home series left in this cycle; they are slated to play two Tests at home against New Zealand later this year and a two-match series against Australia in early 2025.

Their next assignment, however, is a three-match away series against England, commencing in August.

Reacting to the substitution, Gul accused that the all-rounder made the concussion rule an excuse to save himself.

"We don't know what kind of injury he has sustained, but questions arise when you fall, claim to have a concussion, escape from the team, and go outside. The physio checks you, and then after a while, you come out.

"There, you chat with people and then leave. When the match gets tight, and you realize it is going in our favour, you sit outside in the dugout, cheering.

"It means you've made an excuse; you've saved yourself. So, people will definitely question it," Gul had said.

However, in a recent interview with a local cricket website, Umar Gul revealed that he apologized to Shadab Khan after the Pakistan Super League (PSL) season nine.

After the PSL, I approached him [Shadab] immediately because the real story was that he had suffered from concussion twice in a year, and the third time it occurred during the World Cup. The doctor advised rest to prevent any serious consequences," Gul said.

"When I found out about it and when I met him for the first time in the training camp, I went straight to him and apologised. I said, 'Shadab, it was never my intention to hurt you, and obviously being a Pakistani, I felt at that time that the team needed you.' So, for the team's requirement, I said this, otherwise Shadab is a great guy and we have good relations, our families have good relations too, but obviously I felt by the statement I had given, and I apologised to Shadab for it," he added.

Meanwhile, Shadab Khan spoke highly of Umar Gul for accepting his mistake and wished the latter well for his future.

# Taiwan hit by strongest quake in 25 years, four deaths reported

ISLAMABAD: A 7.2 magnitude earthquake rocked Taiwan on Wednesday, the strongest tremor to hit the island in at least 25 years, killing four people, injuring dozens and sparking a tsunami warning for southern Japan and the Philippines that was later lifted.

Taiwan's government said four people had died in the mountainous, sparsely populated eastern county of Hualien where the epicentre was, with more than 50 injured.

At least 26 buildings have collapsed, more than half in Hualien, with about 20 people trapped and rescue work on-going, it said.

Taiwan television stations showed footage of buildings at precarious angles in Hualien, where the quake struck just offshore around 8am (0000GMT) as people were going to work and school.

The quake had a depth of 15.5km (9.6 miles), according to Taiwan's Central Weather Administration.

"It was very strong. It felt as if the house was going to topple," said 60-year-old Taipei hospital worker Chang Yu-Lin.

Japan's weather agency said several small tsunami waves reached major damage and the city's MRT parts of the southern prefecture of Okinawa, and later downgraded the tremor.

The Philippines Seismology Agency also issued a warning for residents in coastal areas of several provinces, urging them to evacuate to higher ground.

Taiwan also issued a tsunami warning, but reported no damage from that, and the Pacific Tsunami Warning Center in Hawaii later said the risk of damaging tsunami waves had passed.

Aftershocks could still be felt in Taipei, a Reuters witness said, with more than 25 aftershocks registered, according to Taiwan's central weather administration.

Chinese state media said the quake was felt in China's Fujian province, while a Reuters witness said it was also felt in Shanghai.
