Former Pakistani Prime Minister Imran Khan's detention is arbitrary and in violation of international law, a U. N. human rights working group said in an opinion issued on Monday, adding the jailed politician should be released immediately.

The Geneva-based U.N. Working Group on Arbitrary Detention said that the "appropriate remedy would be to release Mr. Khan immediately and accord him an enforceable right to compensation and other reparations, in accordance with international law."

The U. N. working group said Khan's legal woes were part of a "much larger campaign of repression" against him and his Pakistan Tehree-e-Insaf (PTI) party. It said that in the lead up to the 2024 elections, members of Khan's party were arrested and tortured and their rallies were disrupted. denies that the elections were rigged. Khan has been in jail since last August and was convicted in some cases ahead of a national election in February. He is also fighting dozens of other cases which are continuing. Khan and his party say the charges were politically motivated to thwart

his return to power. In recent months, Pakistani courts have suspended Khan's jail sentences in two cases about the illegal acquisition and sale of state gifts, and also overturned his conviction on charges of leaking state secrets.

However, he has remained in prison due to a conviction in another case in which a trial court ruled that his 2018 marriage was unlawful. Khan also faces a trial under anti-terrorism charges in connection with violence in May last year.

Khan came to power in 2018 and was ousted in 2022 after falling out with Pakistan's powerful military. He alleged the U.S. and Pakistani military played a role in his ousting through a parliamentary no-confidence vote. Both deny the accu-

Multiple legal cases were brought against Khan after he was ousted which disqualified him as a candidate in February's election.

Despite not running himself, candidates backed by Khan secured the highest number of seats, but the Pakistan Muslim League-Nawaz (PML-N) and Pakistan Peoples Party (PPP) formed a coalition government.

The U.S., Britain and the European Union expressed concern about reported irregularities in the elections and urged a probe while United Nations Secretary-General Antonio Guterres expressed concern about violence and the suspension of mobile communications services during the elections.

Clause D of Resolution No. 199 passed in 2020 also provides guidance for the same constitutional amendment and subsidiary legislation, but so far no progress is seen from the government in this direction, which is a matter of concern.



CAIR calls on US to act on new reports of Israeli torture of **Palestinian detainees**

he Council on American-Islamic Relations (CAIR), a prominent Washington-based Muslim advocacy organization, Monday called on the Biden administration to take action following new reports of Israeli torture of Palestinian detainees.

Upon his release on Monday—without any charges from Israeli detention, Gaza's al-Shifa Hospital Director Muhammad Abu Salmiya reported that Palestinians in Israel's prisons were facing daily abuse.

"There was almost daily torture. Cells are broken into and prisoners are beaten. Several inmates died in interrogation centers and were deprived of food and medicine," Abu Salmiya said.

He said even medical staff were responsible for abuse and neglect, with some detainees' limbs amputated due to poor medical care. He said detainees survived on nothing but bread for two months.

A lawyer, who visited one Israeli detention center, said the "situation there is more horrific than anything we've heard about Abu Ghraib and Guantanamo".

CNN and the New York Times have reported on rape and sexual assault at the same detention center.

Last month, CAIR said it made a similar demand after growing reports of the systematic torture of Palestinian detainees by Israeli forces after a Palestinian journalist from Gaza described the torture, abuse and rape that he and other detainees were subjected to at an Israeli detention camp.

"The Biden administration must take concrete action to end the widely-reported torture and abuse of thousands of Palestinian detainees being held by the genocidal Israeli government. These ongoing human rights abuses are made possible by the Biden administration's complicity in the Israeli genocide and by decades of systematic dehumanization of the Palestinian people. Both the torture and the dehumanization must end.'

On Sunday, CAIR condemned both newly-revealed Israeli use of Palestinian civilians as "human shields" and recorded remarks by a top Israeli official calling for the summary execution or starvation of Palestinian pris-

In video aired exclusively by Al-Jazeera, Palestinian prisoners were shown being forced to search homes for bombs or tunnels, and while Israeli troops sought protection from being fired on, they forced handcuffed and nearly-naked prisoners to search buildings.

Over the weekend, CAIR's New York chapter said a false claim by the far-right Israeli government's new consul general that New York is under threat of "Muslim occupation" would likely lead to more hate crimes targeting ordinary Muslims and Arab-Americans.

Last week, CAIR condemned Israel's blocking of Palestinian mothers from accompanying their children who left Gaza to Egypt for cancer treatment.

The constitutions and laws of these countries ensure that all public services and government institutions operate strictly within legal boundaries, serving the people who are the ultimate paymasters for all state institutions and their functionaries, from the President down to the peon.

Even countries that profess socialism have realized that their source of power lies in their citizens' ability to generate wealth. This wealth creation is only possible when the entire government machinery is holistically, ideologically, and administratively focused on creating enabling conditions for their people to realize their full potential. By creating wealth and paying taxes, citizens make the government wealthy, which in turn uses this wealth to further empower the people and leverage resources from other countries to fuel their growing and prospering economies.

In contrast, countries like ours often operate oppositely. Government officials, who enjoy powers, perks, and privileges because of the hard-earned wealth of individuals from peons to chief executives of multinational companies, often fail to honor and uphold the dignity, privacy, and private lives of these citizens. Instead. they treat them disrespectfully and violate their basic human rights, guaranteed by the constitution, with total impunity. This disregard for citizens' rights undermines the fundamental principles of governance and erodes public trust in state institu-

In civilized countries, the right to privacy and protection from unlawful surveillance is a cornerstone of democratic values and human rights. Governments in these nations are bound by stringent legal frameworks and oversight mechanisms to ensure that any surveillance activities are conducted lawfully, transparently, and with respect for individual freedoms.

However in extreme exigencies the intelligence agencies need surveillance of

ivilized countries uphold the their own or citizens of the foreign countries, they do so after following stringent legal procedures to obtain permission. In the United States, the Foreign Intelligence Surveillance Act (FISA) and the USA PATRIOT Act require agencies to seek warrants from the Foreign Intelligence Surveillance Court (FISC) or a federal judge, with oversight from congressional committees and the Department

In the United Kingdom, the Investigatory Powers Act mandates that surveillance warrants be authorized by a Judicial Commissioner and a Secretary of State. overseen by the Investigatory Powers Commissioner's Office (IPCO).

European Union member states adhere to the General Data Protection Regulation (GDPR) and the European Convention on Human Rights (ECHR), requiring national court approvals and oversight from bodies like the European Court of

Human Rights (ECtHR) and the European Data Protection Supervisor (EDPS).

For example, Germany's Bundesnachrichtendienst (BND) requires G10 Commission approval, and France's intelligence activities are overseen by the Commission Nationale de Contrôle des Techniques de Renseignement (CNCTR). In contrast, China's National Intelligence Law and Cybersecurity Law allow the Ministry of State Security (MSS) to conduct surveillance with administrative approval and limited transparency, emphasizing state security. Each approach reflects the country's balance between security and privacy and the extent of judicial and public oversight to prevent abuse.

In Pakistan, the legal framework governing the surveillance of citizens by intelligence agencies includes several key laws and regulations. Article 14 of the Constitution of Pakistan guarantees the inviolability of the dignity of man and,

provides a constitutional safeguard against unlawful interference in an individual's private life. Section 54 of Pakistan Telecommunication (Re-organization) Act, 1996 allows interception of communications only if authorized by the federal government for national security or emergency purposes, following prescribed procedures. Investigation for Fair Trial Act, 2013 requires a warrant issued by a High Court judge, based on reasonable grounds related to terrorism, espionage, or serious crime. It also emphasizes the need for judicial oversight to ensure surveillance activities are lawful and not arbitrary. Section 39 of the Pakistan Electronic Crimes Act

(PECA), 2016 permits the retention, acquisition, and disclosure of traffic data by service providers for up to one year under specific conditions read with Section 29 permitting the retention, acquisition, and disclosure of traffic data by service providers for

up to one year, subject to production of a warrant issued by the court.

Article 17 of the International Covenant on Civil and Political Rights (ICCPR) Protects individuals from arbitrary or unlawful interference with their privacy, family, home, or correspondence and ensures the right to legal protection against such interference.

But in total disregard to the laws of the country, international law and best practices, the high court declared that the intelligence agencies of the country in collaboration with the Pakistan Telecommunication Authority (PTA) and telecom companies, were reportedly engaged in unauthorized mass surveillance of over 400,000 citizens without proper legal authorization or judicial oversight.

The most serious aspect of the judgment is the word "mass surveillance" which is a far more serious crime than individual surveillance if done without following a

subject to law, the privacy of home. It lawful procedure. It involves monitoring large segments of society indiscriminately, infringing on the privacy rights of many innocent individuals and creating a pervasive sense of being constantly watched. This can lead to self-censorship, stifling free expression and personal freedoms. Additionally, mass surveillance provides extensive data that can be misused for political, social, or economic control, increasing the risk of data breaches and unauthorized use of personal information. It undermines democratic value, violates constitutional and human rights on a large scale, posing significant ethical dilemmas by treating all citizens as potential suspects without due cause.

The impugned judgment has significant implications for upholding the privacy rights of citizens and the democratic and constitutional process in Pakistan. It mandates enhanced accountability and transparency by requiring the federal government, specifically Prime Minister Shehbaz Sharif and cabinet members, to report on the legal framework and implementation of the surveillance system, ensuring compliance with legal boundaries and constitutional provisions.

By demanding detailed reports from the PTA and telecom companies, the judgment emphasizes judicial oversight to prevent unauthorized surveillance and protect citizens' privacy under Article 14 of the Constitution.

Holding top officials responsible for mass surveillance promotes accountability, strengthens the rule of law, and prevents abuse of power, thereby safeguarding the integrity of the democratic process.

This proactive judicial stance enhances public confidence in the judiciary and may prompt legislative and policy reforms to create clearer, more robust laws balancing national security needs with individual privacy rights, reinforcing the democratic fabric of the country.

Additionally, the Alternative Dispute Resolution legislative framework of Pakistan is faced with multiple challenges. It has been suffering from case backlog and non-availability of ADR oriented infrastructure and human resources. It is informal and traditional in nature. Interestingly, AI has capacity to improve the ADR methods like mediation, arbitration and mini-trials. It has ability to evaluate

the nature of disputes and suggest fair settlements. Thus the burden on courts can be reduced in true sprits.

Sadly, the legal system of Pakistan is experiencing poor documentation management system. It is lacking track and tracing mechanism. The record rooms and branches of the court are based on manual methods for recordkeeping. These are heavily burdened. There is no mechanism to preserve

the documents and other evidences in times of natural calamities. Individuals are unable to easily access the required documents. Undeniably, steps have been taken towards digitalization but these are insufficient and insignificant. However, AI tools can result in better case prioritization, assigning cases to judges, scheduling hearings, managing court calendars and allocating resources. Thus, timely and effective justice delivery is ensured to all and sundry.

Furthermore, many people have lost faith and confidence in the judicial system of Pakistan because of unnecessary delays, widespread biases, poor perfor-

Conversely, AI can track the progress of the cases and make court proceedings transparent. It helps to identify biases, analyze data objectively, monitor judicial performance, and ensure accountability. This is how public trust can be increased through AI.

AI can be vital to strengthen cyber security and data protection in the judicial system of Pakistan. It can protect sensitive judicial data from cyber attacks. It ensures secure storage and prevents unauthorized access. It can monitor suspicious activities and identify malware and vulnerabilities. It is crucial for safe-

guarding integrity of the legal proceedings. Thus, sensitive data is safeguarded

in the event of cyber attacks. The crux of the matter is that AI has potential to radically transform the legal system of Pakistan. FBR imposes regulatory duty on 657 luxury goods, over 2,000 items to

ISLAMABAD: The Federal Board of Revenue (FBR) has announced a significant increase in customs duties on a wide range of imported goods, effective July 1, 2024. This move aims to generate additional revenue for the government and potentially curb the import of luxury and

non-essential items. The most notable change is the imposition of a 2% additional customs duty (ACD) on over 2,200 items, including components for the assembly of vehicles, tractors, and other machinery.

This ACD applies to goods previously subject to zero percent duty. Additionally, the FBR has levied regulatory duties (RD) ranging from 5% to 55% on 657 luxury and non-essential items.



Without a goal to his name at the Euros, the all-time men's leading international goalscorer with 130 strikes has at times appeared desperate.

"I will always do my best for this shirt, whether I fail or not, and I'm going to do this my whole life," Ronaldo told Portuguese television channel RTP.

"I've been doing this for 20 vears – as you saw I missed the
