Israeli war in Gaza is a 'war on women,'

ore than 10,000 women have died in the Israeli war in Gaza, over 6,000 families have lost their mothers, and nearly one million women and girls "have lost their homes, their loved ones, their life memories," the head of the U. N. women's agency in the occupied Palestinian territories

"Wars are never gender neutral, but no doubt in Gaza one million women and girls are bearing the worst brunt of nine months of war," Maryse Guimond, the UN Women Special Representative in the Occupied Palestinian Territory, told reporters at UN Headquarters in New York on Thursday,

"They are losing their lives, they are sick, hungry, exhausted, holding families together despite their constant fear and loss," she said via video link from Jerusalem.

Ms. Guimond recently concluded a week-long mission to Gaza – a place she has visited more than 50 times in her six years in the job, including after previous escalations.

She said she was not prepared for "the total destruction and inhumanity" that she saw this time, her voice choking up with emotion.

"What I witnessed defied my worst fears for the women and girls I have been working with for so many years," she said. "It was unbearable to witness the daily escalation of violence and destruction of a war on women with no end in sight."

The UN Women Representative said she entered a world of devastation and total deprivation when the fence at the Kerem Shalom border crossing closed behind her.

"I cannot underline enough the impact that this war has had on women and girls. I barely recognized women who I knew before the war. The last nine months is embedded on their faces, on their bodies."

Ms. Guimond explained that Gaza is "a war on women" simply because of the numbers who have been killed and injured, and the overall level of devastation that women there are facing.

"We have never seen this before," she said.

Conditions in the enclave are dire. More than half a million women "are severely hungry, eating the last and the least of their families, skipping meals and not eating healthy foods for months and months," she said, citing UN Women data.

Furthermore, people are "living in overcrowded spaces, where infectious diseases are much more rampant". Because there is no water, women have been forced to shave their heads to avoid infections.

"I could not recognize the Gaza I knew," Ms. Guimond said. "Homes, hospitals, shops, schools, universities have been destroyed. Crowds of men, women, children trying to survive and in makeshift tents and overcrowded shelters surrounded by rubble and total destruction."

As most hospitals are no longer functioning, access to healthcare and medical treatment is limited.

establishment, all other influential factors are turning against the government, which is now in a dire and ensnared position with no apparent way out. In its frustration, the government is making successive errors and issuing threats, claiming that any disruption to its rule would spell disaster for the country's stability and survival.

The fiery Chief Minister of Punjab asserted that any person or party attempting to derail the system would be dealt with severely, implying that the government will complete its five-year term regardless of mandate, legality, or constitutionality. She pledged to hold the Supreme Court accountable for restoring PTI as a political party, accused the judges of bias, and called for judicial accounta-

Mr. Sanaullah of PML(N), who prides himself on quelling the PTI's long march with force and using security forces to silence opposition, pledged to use all available government resources to obliterate the PTI. He termed PTI as "Fitna" (discord) and a threat to the country's safety, security, and integrity.

forward. They assert that the country is at a critical juncture where any political upheaval risks default. The government claims to have achieved significant economic stability, successfully securing immense pressure. The US Congress a staff-level agreement with the IMF for a \$7 billion loan, improving foreign reserves, reducing inflation, and boosting the stock exchange. They argue that these achievements validate their competence to govern,

and therefore, all alleged transgressions should be forgiven, if not, the country's survival will be at stake. The narrative of PTI is

fundamentally opposed

to that of the ruling elite. They argue that even if the government were to achieve miraculous economic feats, it lacks legitimacy due to a stolen mandate. Therefore, the opposition is determined to use all available means to dislodge what they consider an illegitimate

government, regardless of the cost. However, interestingly, the indicators the government once touted in its favor are turning against it one by one both internally and externally.

Internally, the judiciary has become completely independent. It first restored PTI as a party and allocated reserve seats to it. It is likely to frustrate the government's attempt to appoint retired judges or lawyers as presiding officers in the election tribunals, arguing that the amendment in the Election Act made in 2024 will apply to the next elections. This means that tribunals will make their decisions based on Form 45, which could allegedly result in the demise of PML(N), PPP, and MQM in the parliament.

The government has been touting the boom in the Pakistan Stock Exchange (PSX) as a key indicator of economic

points today (July 19, 2024), closing at 73,252.56 amid political and economic uncertainties.

Externally, the government is under passed a resolution deeming the 2024 elections highly rigged and demanded an independent inquiry and the release of the PTI founder. This was echoed by a UN independent group based in Switzerland.

> Recently, the European Parliament discussed the elections, expressing serious concerns over widespread rigging and human rights violations, emphasizing the need for Pakistan to uphold democratic principles and human rights.

In the economic and financial sector, the recent Fitch report, vehemently rejected by the Planning Minister, has added further pressure on the government. Fitch painted a dismal picture of the country's economic and financial status and highlighted significant political instability. The report projected that the PML-N-led coalition government would remain in power for the next 18 months, predicted longer jail terms for Imran Khan, and mentioned the possibility of a military-backed technocratic government.

This step will be necessitated, if the election tribunals through their rulings return the stolen mandate to PTI which being unacceptable, the establishment could directly take over the government, dissolving existing political structures and appointing technocrats to key positions. The establishment, in collaboration with compliant political forces, could push for legal changes or emergency measures to justify the appointment of a technocratic government. It may leverage the judicial

The ruling elite's narrative is straight-revival, but the KSE-100 index lost 501.46 rulings to disqualify elected officials and pave the way for a technocratic administration.

Unfortunately, all parties are calling the others to back off from their positions in the national interest without yielding any ground themselves. They define national interest through their own lenses, forgetting that upholding the national interest primarily involves following the constitution and establishing the rule of law in the country.

If sanity prevails, the government should allow the Election Commission and judiciary to independently reconfigure the election results based on Form 45 and accept the decision. The establishment should reconsider any unconstitutional roles, and the civilian bureaucracy should act as true public servants to resolve issues faced by the people. The opposition should refrain from taking the law into their own hands and seek justice through constitutional means. Success would depend on all stakeholders simultaneously reverting to their constitutional roles; otherwise, nothing will make sense.

However, given the current backdrop of political maneuvering, judicial interventions, and international scrutiny, expecting all parties to align constitutionally may be overly optimistic. The entrenched interests and historical patterns of behavior suggest that while the path of constitutional adherence is clear, achieving it requires unprecedented cooperation and goodwill from all involved parties. Without this, the cycle of political instability and institutional distrust is likely to continue, making the sensible suggestion appear impractical in a system where entrenched interests often move counterclockwise.

ith the advent of the internet. spreading agenda, whether positive or negative, has become incredibly easy. content uploaded or shared online can reach millions of users worldwide within minutes. This rapid dissemination poses significant challenges, particularly in controlling highly sensitive content such as blasphemy, violence, harmful, and indecent material that can significantly impact society. As an Islamic country, Pakistan is particularly affected by such unlawful content, facing unique challenges due to the spread of blasphemy and indecent material online. To mitigate the uploading and sharing of unlawful content, it is essential for every citizen to be informed about local laws and the reporting mechanisms available with Social Media companies and regulators.

In the online world, timely identification and removal of unlawful content is crucial in minimizing its impact. Although social media companies use Artificial Intelligence (AI) algorithms for this purpose, these systems are still evolving and require time to become fully effective. As a result, companies currently depend on a complaint-based mechunlawful content, and content of unlawful content directly to on society at large.

moderators review the reported content to determine whether it should be removed or geo-fencing. Effective results cannot be

achieved without active public participation. To facilitate the instant reporting of unlawful content to the PTA, a state-ofthe-art and user-friendly Complaint Management System (CMS) has been developed. It is accessible online at https://complaint.pta.gov. pk/RegisterComplaint.aspx, with a mobile app available for download on both the Playstore and Appstore. User can lodge complaints by selecting relevant category, such as Against the Glory of Islam, Hate Speech, Anti-State, Child Abuse or Indecent/Immoral content. The PTA team thoroughly analyzes each complaint and takes up the matter with the concerned social media platform for its prompt removal. For public guidance on lodging accurate complaints, a video titled "How to Report Unlawful Online Content" (https://www.youtube. com/watch? v=ZggEw2e5Gdw) has been uploaded on PTA's official YouTube channel (@ptaofficialpk).

Social Media companies strive to ensure a safe platform for users through self-regulation, which involves establishing community guidelines and standards. It is essential for the public to familiarize themselves with these guidelines, as they provide a framework of rules for uploading and

social media platforms is crucial for its prompt removal, and these platforms encourage users to lodge complaints directly with them.

The PTA has provided a list URLs (https://www.pta. gov.pk/assets/media/sm_platforms 09032020.pdf) for major social media platforms where complaints can be lodged directly to platform. Additionally, WhatsApp, known for its end-to-end encryption, encourages users to report unlawful content within the app by long-pressing the message and selecting the 'report' option.

In a culturally rich and diverse nation like Pakistan, where individuals embrace various religious beliefs and sects, it is paramount to avoid uploading or sharing content that offends the sentiments of others. Knowledge of local laws is crucial to avoid legal consequences for uploading unlawful content. The Prevention of Electronic Crimes Act (PECA) Section 37 deals with the removal of unlawful online content related to the glory of Islam, particularly in cases of blasphemy, and Section 11 addresses hate speech and criminalizes any online content that promotes or is likely to promote interfaith, sectarian, or racial hatred.

PTA encourages online users to use digital space responsibly and to report any unlawful content directly to the relevant social media company or to PTA for timely removal. This collective effort will help minimize anism, where the public reports sharing content. Timely reporting the negative impact of such content

Afghanistan's Economy Struggles Amid Reduced Aid and Narcotics Ban

he fifteenth report from the United Nations Analytical Support and Sanctions Monitoring Team sheds light on the evolving landscape in Afghanistan under the Taliban's rule. Hibatullah Akhundzada, the Amir of the Taliban, has solidified his grip on power, marking a significant transition from insurgency to de facto governance. This consolidation of power brings both stability and challenges, impacting Afghanistan and its regional dynamics profoundly. Under Akhundzada's leadership, the Taliban have brought a semblance of stability to Afghanistan.

Internal peace has improved, corruption has decreased, and opium cultivation has seen a decline. These changes have bolstered the fragile Afghan economy and provided a modicum of public services. However, the governance model remains deeply rooted in a strict interpretation of Islamic law, which raises questions about its long-term viability in addressing Afghanistan's multifaceted challenges. The report highlights the Taliban's limited ability to manage critical issues such as mass migration, natural disasters,

water management, climate change, and the humanitarian crisis. Additionally, the Taliban's efforts to combat terrorism, particularly against ISIL-K and Tehrik-e Taliban Pakistan (TTP), are met with skepticism. While there have been some successes, the Taliban's overall counter-terrorism capabilities are questioned, and their support for TTP is a point of concern for neighboring

Afghanistan's economy, while not collapsing, is struggling under the weight of reduced international aid and the challenges of transitioning from an insurgency to a governing authority. The Taliban's ban on opium cultivation, though intended to curb the narcotics trade, has left farmers without viable alternatives, leading to unrest in regions like Badakhshan Province. The trade in narcotics persists due to sizeable stockpiles, and senior Taliban figures continue to profit from it. The Taliban's governance approach, characterized by tight control and limited adaptation, is not meeting the expectations of the Afghan population or the international community. The needs of women, ethnic and religious minorities, and broader human rights concerns remain largely unaddressed.

The Taliban's non-participation in international dialogues,

such as the Doha II meeting, underscores their insular approach and reluctance to engage with the global community. The report underscores the persistent threat Afghanistan poses to regional and global security. The Taliban's tolerance of various terrorist groups allows these entities to use Afghanistan as a base for operations, projecting threats into neighboring countries and beyond. The ongoing humanitarian crisis, coupled with the management of regional water rights, further complicates the security landscape.

Member States have expressed concerns about the disproportionate spending on security and armed forces by the Taliban.

The ambitions to acquire new military capabilities and the challenges in controlling small arms and light weapons add to the apprehensions about the Taliban's true intent. The potential for terrorist access to these weapons poses a significant threat to regional stability.

The Monitoring Team's report provides several recommendations for improving the implementation of sanctions and addressing the complex challenges posed by the Taliban's governance. There is a need for clarity in

handling asset freeze exemption requests and a more robust approach to the arms embargo. Engaging the Taliban in a multilateral framework to address these issues and foster international recognition is crucial. As Afghanistan navigates this turbulent period, the international community must remain vigilant and proactive in addressing the evolving threats and challenges.

The Taliban's rule, while bringing some stability, is fraught with complexities that require a nuanced and coordinated response to ensure regional and global security. The fifteenth report from the UN Monitoring Team paints a detailed and sobering picture of Afghanistan under the Taliban. The consolidation of power by Hibatullah Akhundzada has brought both stability and significant challenges. The international community must continue to monitor the situation closely, ensuring that efforts to address terrorism, humanitarian needs, and regional security are sustained and effective. The road ahead for Afghanistan is fraught with uncertainty, and it is imperative that global stakeholders remain engaged and responsive to the evolving

Today is about the brave and noble Palestinian people and their absolute, non-negotiable right to freedom from colonial control and violence. The Court said this right must no longer be denied or deferred.

Current electricity rates make business impossible, says Mian Zahid Hussain

ISLAMABAD: The chairman of the FPCCI Advisory Board and National Business Group Pakistan, President Pakistan Businessmen and Intellectuals Forum, and All Karachi Industrial Alliance, as well as former provincial minister Mian Zahid Hussain, said on Friday that it is impossible to do business in the current situation.

IPPs are draining the country's treasury; they receive an annual payment of 2000 billion rupees as a capacity payment, despite energy sectors. We need to revise contracts the fact that the closed factories do not generate electricity.

According to Mian Zahid Hussain, the economy can improve if closed IPPs become operational and industries receive electricity at reasonable rates.

The veteran business leader told the business community that setting the electricity tariff for the industries at 25 rupees, or nine

cents per unit, could increase exports to six billion dollars.

Otherwise, the inability to purchase electricity at Rs 60 per unit will force a record number of businesses to close this year, which will impact both government revenues and employment.

He noted that the system will need to run on loans until business and industry become the most profitable sectors of the nation.

Mian Zahid Hussain said that there is an urgent need for reforms in the power and with IPPs and conduct a forensic audit of all private power projects.

It is necessary to deal immediately with electricity theft, line losses, and bill defaults. The mafia has a high level of involvement in many important matters, such as electricity, the budget, and the tax system, and they will not tolerate any work that contradicts their interests, he observed.



The business leader said that due to a lack of reforms, many important institutions in in efforts to widen the tax net, digitising the the country are collapsing, while the FBR has once again failed to meet its revenue target tax base, reduce corruption, and create transin the last financial year.

Mian Zahid Hussain said that the FBR has collected Rs 9.3 trillion against the original target of Rs 9.4 trillion. Top officials are adamant that our system has the capacity to collect more than Rs 24 trillion.

The claims made by FBR to achieve the tax targets are for the revised target, which was Rs 9.252 trillion.

Mian Zahid Hussain stated that improving the FBR system necessitates the appointment of appropriate individuals, the implementation of a digital system to record the economy, and the prioritization of transparency.



(retd) Mushir Alam and Justice (retd) Maqbool Bagar were also being considered for the ad-hoc role before they declined the offer.

Justice Alam retired from the Supreme Court on Aug 21, 2021; Justice Baqar, who served as the Sindh chief minister during the last caretaker set-up, retired on April 4, 2022; Justice Miankhel retired on July 13, 2022; and Justice Masood on March 10, 2024.

Earlier on Thursday, the Pakistan Bar Council called for the formation of more courts in the country through a constitutional amendment. The council has also expressed

support for the appointment of ad hoc judges to help expedite the decision-making process in cases.

"Currently, a significant amount of the Supreme Court's time is spent hearing political cases, and the establishment of a constitutional court would help alleviate this burden," the PBC viewed.
