

## Strong lobby opposing Operation Azm-e-Istehkam: DG ISPR

ISLAMABAD: Pakistan Army said on Monday that it had conducted over 22,000 intelligence-based operations in the ongoing year to eliminate terrorism in the country.

Addressing a press conference on Monday, Director General Inter-Services Public Relations Lieutenant General Ahmad Sharif Chaudhry said that there had been a noticeable increase in the propaganda against the army.

DG ISPR said that a total of 398 terrorists have been killed while 137 officials were martyred. He added that over 112 operations have been conducted each day in 2024.


Answering a question about Operation Azm-e-Istehkam, DG ISPR said that the decision was taken in a meeting where all stakeholders were present.

He added that the operation is a comprehensive effort against terrorism and was needlessly politicised.

"The stakes are very high," DG ISPR said, adding that a lobby does not want revised National Action Plan to succeed.

Chaudhry read out PM Shehbaz Sharif's statement regarding the operation, clarifying that there was no kinetic operation planned that will require displacing any population.





He added that while over 22,000 operations have been conducted in Khyber Pakhtunkhwa and Balochistan, there are a total of 22 courts to deal with the arrested terrorists.

DG ISPR also said that there was an entire spectrum of illegal activities, including businesses, that was facilitating terrorism.

He added that the excuses of missing persons and 'peace marches' were suddenly raised as soon as the operation was announced. He said that no one was advo-

cating for an increase in counter terrorism departments and courts. In response to a question about Bannu, DG ISPR recounted the terrorist attack followed by the peace march a day later.

He added that there were 'certain elements' that were armed and had raised slogans against the state. He said that the protestors had even looted the supply depot.

The DG ISPR said that the army had responded as per SOPs.

Without naming the Pakistan Tehreeke-Insaf, he said that a party was trying to protest even though it was responsible for civil administration.

Chaudhry also recounted that PTI had responded to May 9 by questioning why the army had not responded. He also criticised courts for being 'lenient' towards those involved in May 9.

DG ISPR also called for stringent laws against 'digital terrorism' that he said was playing a large part in the propganda against the army.

He added that nowhere in the world was there a free pass on disinformation and courts handed out strict punishments.

Chaudhry said that there should be legislation to control disinformation and digital terrorism to stop people behind anonymous profiles from spreading propaganda.

### Pakistan face overall 38% increase in energy prices, 62% increase in capacity charges causing tariff hike

ISLAMABAD: The Speakers at a panel discussion underscored that Pakistan is facing an overall increase of 38 percent in energy prices along with a 62 percent rise in capacity charges leading to tariff hikes in the country that could be overcome through an independent power consumer model promoting individual power generation.

The Sustainable Development Policy Institute (SDPI), as part of its Monday Seminar series, under the auspices of the Network for Clean Energy Transition (NCET) conducted a panel discussion on "Pakistan's Electricity Tariff Structure: Insights and Key Determinants" here at the SDPI conference hall

Dr. Khalid Waleed, Research Fellow at SDPI, detailed Pakistan's consumer categories and tariff-setting mechanisms, highlighting how the tariff structure is designed to reflect various consumer types and usage patterns. Residential consumers, classified under category A-1, the overall power tariff.

make up 89% of the consumer base and account for 48% of the total consumption. This trend is opposite to the global pattern where industries are the main consumers of electricity. In Pakistan, however, commercial consumers (A-2) represent 9% of the consumers and 7% of the consumption.

He further explained the mechanism behind the high electricity bills. In Pakistan, the capacity charge, encompassing fixed operational and maintenance costs, return on equity, debt servicing, insurance, working capital financing fees, and procurement and construction costs, is higher than the generation charge. The Energy Price (EP), which includes fuel cost and variable operational and maintenance expenses, is projected to increase from 0.84 trillion Rs in FY24 to 1.16 trillion Rs in FY25, translating to a rise from 10.94 Rs/unit to 15.65 Rs/unit. The Capacity Price (CP) is anticipated to grow from 1.847 trillion Rs in FY24 to 1.95 trillion Rs in FY25, contributing to 18.39 Rs/unit or 60% of

Another reason for the increased electricity bills is the various taxes imposed. He explained that in Pakistan, electricity bills include several taxes, including an 18% General Sales Tax (GST) from the federal government and an Electricity Duty from provincial governments of 1.5% for residential customers and 2% for commercial customers.

Dr. Musarat Jabeen highlighted the concept of the independent power consumer (IPC) model, advocating for solar energy initiatives and encouraging everyone to generate their own energy to promote sustainability.

Engr Ahad Nazir, Associate Research Fellow and Head Center for Private Sector Engagement at SDPI highlighted that all energy-generating plants are paying fixed tariffs regardless of production and output.

Engr. Ubaid ur Rehman Zia, head of energy unit at SDPI mentioned that the tariff structure reflects the complex interplay of power sector policies and regulations, market dynamics, and



regulatory frameworks. The structure and determinants of these tariffs have far-reaching implications, affecting not only household budgets but also the competitiveness of businesses and the overall economic stability of our country.

Zainab Babar, Research Associate at SDPI

said that the problem is circular with challenges deep-rooted in the broader energy structure of the country. She said that several key issues in the current system, such as the burden of high-capacity payments and dollar indexation, make electricity unaffordable for many consumers.

Contracts with IPPs, should be revised and made public: Atif Ikram

ISLAMABAD: President Federation of Pakistan Chamber of Commerce and Industry Atif Ikram Sheikh has said that it is necessary to review the agreements with IPPs. The government should bring the agreements with IPPs to the public. Expensive contracts are the cause of electricity crisis today, people and business circles have suffered severe problems due to expensive electricity bills, he expressed these views while talking to a delegation of the business community.

Federation President Atif Ikram said that the reason for the high electricity bills is the agreements made with the IPPs. The power plants of the PPPs are running at



less than 10% capacity and the government is paying the full amount. On one hand, the circulating debt is increasing, on other hand, the public is being burdened.

Atif Ikram said that the price per unit of electricity in Pakistan was already higher than other countries in the region, now the living and business conditions of the common people in Pakistan have become disturbed. ### Israeli strikes on Yemen



N Secretary-General Antonio Guterres has responded to Israel's airstrikes on the Yemeni port city of Hudaydah, which reportedly killed at least six people and injured more than 80, by calling for all parties involved in the conflict to "exercise utmost restraint".

In a statement, the UN chief noted that Israel had claimed responsibility for the strikes, which took place on Saturday, as a response to previous attacks on Israel by the Houthis – formally known as Ansar Allah – a group which controls swathes of territory in Yemen, including Hudaydah.

The strikes came after a drone attack on the Israeli city of Tel Aviv on Friday killed one person and wounded 10 more. The attack was claimed by the Houthis and led to a senior Israeli Government minister vowing to "settle the score". The Israelis strikes on Saturday hit electricity infrastructure and a refinery, creating a large fire.

Efforts to mediate between the Houthis and Yemeni government have stalled in recent months and, following the onset of the war in Gaza in October, the Houthis pledged to attack what they deemed to be pro-Israeli shipping interests along the Red Sea coast, as a demonstration of solidarity with the Palestinians in Gaza.

In turn, a United States (US)-led coalition defending shipping in the Red Sea has continued to strike areas controlled by Houthis in Hudaydah, the capital Sana'a and Ta'iz.

The Houthis reportedly warned that the group's response to the Israeli airstrikes "will be huge" and that the group would continue to attack Israel and that there would be no "red lines".

The Yemeni conflict, which began in 2015, has been

## **Technical Courses Should be** Taught to Students of Religious Schools

he holy book says: "Indeed, Allah does not change the condition of a people until they change what is in themselves." In our country, religious schools (madrasas) are a blessing, ensuring the transfer of Islamic knowledge. Education is not just about letters, words, and books but about developing minds and intellect in a way that nurtures natural talents and emotions to benefit humanity.

Madaris have been playing a significant role in the education system of Pakistan. Around three Million students are enrolled in 35000 Madaris, براری (estimated 2019) out of which 26,160 Madaris are registered with provincial / areas government under the society act. About 25000 Madaris are affiliated with their respective Masalik Boards i.e. five different organizations / boards (examining bodies) working under the supra-body of Madaris "Ittehad Tanzeemat-ul-Madaris Pakistan (ITMP). The question arises, what can be done so

that students graduating from madrasas can earn a livelihood? They didn't study religion to make a living out of it. For Muslims, gaining knowledge is a duty that benefits both this life and the hereafter.

The curriculum of religious schools has always been debated, even by those unfamiliar with the books. Why is that? When madrasa students step into practical life after 8 to 11 years, they face economic challenges. Their degree mainly qualifies mosques. For instance, if there are 100

students in a Hadith class, only 10 might be able to read Arabic text independently, and out of those, only 2 might speak Arabic fluently. This is similar to English schools where even teachers may struggle with proper English.

In 1937, during a conference in Aligarh, Maulana Syed Hussain Ahmad Madani emphasized the importance of this issue for religious institutions. The complaint is that good scholars are not being produced, but little attention is paid to the reasons. Scholars should be freed from poverty and made capable of earning their livelihood independently, giving them freedom and confidence.

In Pakistan, except for Jamia Tur

ized its curriculum and presented it akin to Oxford University, madrasa leadership remains hesitant to make decisions in this matter.

No one denies the importance of techthem for roles as imams or preachers in nical education. This education is not an obstacle in the way of religion and sects.


That's why Technical Education is crucial for a society's educational and economic stability, but sadly, in Pakistan, technical education gets less attention than general education, and even less in madrasas. Recently recognizing

the importance of technical education, a positive development has been announced recently. "Nizamul-Madaris Pakistan" has started offering 17 technical courses to madrasa students with the help of the Directorate of Religious Education and NAVTTC. These courses include IT, e-commerce, mobile phone repair, general electrician, digital marketing, Amazon, virtual assistant, and auto mechanics. Ghulam Qamar, the director, expressed satisfaction with

Rasheed in Karachi, which has modern- the successful launch of these courses and emphasized that the government wants madrasa students to be skilled and dignified citizens.

Dr. Mir Asif Akbar, the chief of Nizamul-Madaris Pakistan, mentioned that thousands of students in Lahore, Sheikhupura, and Nankana Sahib are benefiting from these courses. This trend of integrating technical education in madrasas will have significant positive outcomes. Courses like cooking and fashion designing should be included specifically for female students.

The future of madrasa students is a matter of concern for all thinkers and our religious leadership. If we do not provide opportunities for their progress and fulfill their worldly needs in a dignified manner, two outcomes are likely: either they will abandon their studies for other fields after a few years, or they will resort to unacceptable means to survive in the religious field, such as selling amulets or begging. If this issue is not addressed, the role of religious schools in societal reform will be greatly diminished. Therefore, madrasa students should be taught technical skills to become economically self-sufficient and serve Islam selflessly.

sources such as social media, news outlets, and public databases to gather intelligence on the activities and intentions of anti-state actors. Geospatial Intelligence (GEOINT) includes analyzing imagery and geospatial data obtained from satellites, drones, and other platforms to gather insights into the geographical aspects of anti-state activities. These intelligence disciplines collectively contribute to a comprehensive monitoring framework that enhances national security by providing early warnings, strategic insights, and actionable intelligence to preempt and mitigate threats posed by anti-state elements.

Various surveillance and monitoring technologies are employed for these purposes. Closed-Circuit Television (CCTV) is used to monitor public spaces, borders, and critical infrastructure to detect suspicious activities and potential threats. Biometric Identification utilizes technologies such as legal frameworks that define the parameters for

Social Media Monitoring analyzes social media platforms to detect radicalization trends, propaganda dissemination, and recruitment efforts by extremist groups. International cooperation and information sharing play pivotal roles as well. Joint Operations and Task Forces collaborate with allied nations and international organizations to exchange intelligence, conduct joint operations, and coordinate responses to transnational threats. Information Exchange shares intelligence, analytical assessments, and threat indicators with partner countries to bolster collective security measures against antistate elements.

Voice Interception utilizes specialized equipment and software to intercept and record phone conversations in real-time or retrospectively, providing insights into intentions, plans, and operational activities. Data Mining and Analysis employs data analytics and machine learning algorithms to sift through intercepted communications, identifying keywords, phrases, and suspicious behaviors indicative of anti-state activities. These techniques and processes are crucial for enhancing national security efforts by enabling early detection, thorough analysis, and effective response to potential threats posed by anti-state actors. Cross-platform surveillance integrates the interception of phone calls with monitoring of other communication channels like email, instant messaging, and social media to compile comprehensive intelligence profiles.

In the global campaign against threats posed by anti-state elements, numerous countries have instituted rigorous measures to trace and intercept phone calls as integral components of their national security strategies. These efforts are pivotal for gathering intelligence, preventing terrorist attacks, disrupting criminal networks, and safeguarding national interests.

The United States maintains robust legal frameworks and advanced technological capabilities to monitor and intercept communications of individuals and organizations considered threats to national security. Agencies such as the National Security Agency (NSA) operate under the authority granted by the Foreign Intelligence Surveillance Act (FISA), allowing them to obtain warrants for surveillance targeting foreign powers or their agents. ISLAMABAD: Pakistan on Monday welcomed the advisory opinion of the International Court of Justice (ICJ) on Israel's unlawful policies and practices in the Occupied Palestinian Territory and called for its immediate and full implementation.

It said the ruling clearly established that Israel's unlawful policies and practices in the Occupied Palestinian Territory were in breach of Israel's obligation to respect the right of Palestinian people to self-determination.

"Israel is under an obligation to end its unlawful occupation; cease its illegal settlement activities; and to make reparation for the damage caused," it was asserted. The ICJ had ruled on the "Legal Consequences arising from the Policies and Practices of Israel in the Occupied Palestinian Territory, including East Jerusalem."

"It may be recalled that Pakistan had made a written submission to the ICJ on the case in July 2023, and later also shared a rejoinder with the Court. Pakistan also participated in the oral public hearing held by the ICJ on the case in February 2024. In its submissions to the ICJ, Pakistan reiterated its strong and unwavering support for the right to self-determination of the Palestinians and highlighted the illegality of the Israeli occupation," Foreign Office Spokesperson, said in a press statement.

The spokesperson further said that they hoped that the Court's ruling would be an important step towards ending the Israeli occupation, realization of the inalienable right of the Palestinians to self-determination, and creation of a viable, secure, contiguous and sovereign State of Palestine on the basis of the pre-1967 borders and with Al-Quds Al-Sharif as its capital.

### Bangladesh protests pause after top court scraps job quotas

DHAKA: Streets appeared calm in Bangladesh's capital on Monday a day after the Supreme Court agreed to scrap most government job quotas that had angered student-led activists and led to deadly protests.

Late on Sunday, protesters gave Bangladesh's government 48 hours to meet a string of new demands, including a public apology from Prime Minister Sheikh Hasina for the violence, and the restoration of internet connections disrupted during the unrest.

But on Monday, most appeared to be obeying a curfew in cities that had seen regular demonstrations after a high court in June reinstated old quotas that reserved many state jobs for descendants of freedom fighters and other groups.

A public holiday declared over the last two days was extended to Tuesday, according to a government notification.

"Normalcy will return within one or two days," Home Minister Asaduzzaman Khan told

reporters. Experts have blamed the unrest on stagnant job growth in the private sector and high rates of youth unemployment that have made government jobs, with their regular wage hikes and other privileges, more attractive.

Hasina, 76, who was sworn in for a fourth consecutive term this vear, has been accused of authoritarianism, human rights violations, and crackdowns on free speech and dissent in the past charges her government denies.

### CAT dismisses Neucon Pakistan's appeal upholding CCP's decision in fraudulent use of trademark case

ISLAMABAD: The Competition Appellate Tribunal (CAT) has dismissed the appeal filed by Neucon Pakistan, affirming the decision of the Competition Commission of Pakistan (CCP) regarding fraudulent use of trademark and labelling and packaging.

The CCP issued a Show Cause Notice to Neucon Pakistan after receiving a formal complaint from Ferozsons Laboratories Limited, the authorized distributor of Biofreeze Gel and Spray in Pakistan, a product originally developed by USA-based Performance Health Inc. Ferozsons alleged that Neucon was marketing a deceptively similar product under the name 'BYQFREEZ,' mimicking the trademark, packaging, and labeling of Biofreeze. Following a comprehensive inquiry, the CCP confirmed that Performance Health Inc. is the rightful owner of the Biofreeze trademark and that Ferozsons was the only registered distributor in Pakistan.

### England Cricket open to IPL investment in The Hundred



LAHORE: The England and Wales Cricket Board (ECB) chief executive Richard Gould confirmed on Monday they have held talks with Indian Premier League (IPL) owners about acquiring a stake in their domestic The Hundred competition.

The fourth edition of The Hundred, which features eight specially created teams – each with a men's and women's side - rather than the traditional 18 first-class English counties, starts on Tuesday.

Its future remains uncertain, with the ECB looking to secure private investment in a bid to cement its position in the global calendar and boost the finances of the domestic game.

The ECB are trying to balance a desire for a cash injection while retaining control of the Hundred by selling off a 49 per cent stake in each team to private investors, with host teams retaining the remaining 51 per cent of shares



But the hosts could sell part or all of their shares

"Control comes at different levels, it comes at team level and it comes at competition level - that's not something we are ceding control of," ECB chief executive Richard Gould told reporters during a conference call.

"Different investor groups have different needs, for some it is about control of what happens on the field, for others it's the commercial element.

"You're right about the strength of the Indian market — it represents probably 90 percent of the revenues coming into the ICC (International Cricket Council)

IPL teams moving outside of their home market into other national markets. I think that's to be welcomed," he added.

The cash-rich T20 IPL, a multi-million dollars spectacle underpinned by the mass enthusiasm for cricket in India, the world's most populous nation, has changed the sport's global landscape, with players no longer needing to go through the grind of five-day international Test matches in order to enjoy lucrative careers.

There is a view that IPL owners, such as the billionaire Ambani family who are in charge of the Mumbai Indians, would only be interested in full control of The Hundred team.

"There is certainly the opportunity for people to have potentially 100 percent ownership," said Gould.

is about health and safety these days and insurance companies are charging a fortune to indemnify sports clubs against accidental damage or injury to bystanders.

"If you buy a house next to a cricket ground then you've got to expect a few cricket balls in your garden.'

The West Sussex club was founded during George III's reign. The residential dwellings encircle the ground, which has brief boundaries. The club has installed nets, but the surrounding trees limit the heights.

The prohibition was supported by Mary Gill, 80, whose family has resided besides the Green in a Grade II-listed cottage for generations.

"I've lived here all my life and I think the ban is a good thing.

"It's a very small ground and can't accommodate the testosterone-fuelled young men who come along and just want to hit the ball as far as they can.

"My parents and grandparents lived in this house before me and cricket balls were always sailing over and causing damage. Over the years we've had tiles smashed off the roof, windows broken and all sorts.

India chief selector Ajit Agarkar dismissed the speculations that all-rounder Ravindra Jadeja was dropped for the upcoming threematch away ODI series against Sri Lanka.

Agarkar's clarification came in the wake of a report from the Hindustan Times that claimed that Jadeja is no longer part of the team's plans for the ODIs.

Days ago, India named a full-fledged squad for their upcoming three-match away ODI series against Sri Lanka with Jadeja a notable exclusion.

According to a source in the Board of Control for Cricket in India (BCCI), the national men's team's selectors, led by newly-appointed head coach Gautam Gambhir, want to provide ample opportunities to Axar Patel and Washington Sundar ahead of the ICC Champions Trophy 2025, scheduled to take place in Pakistan.

"There are only six ODIs, including the three in Sri Lanka, before next year's Champions Trophy. The selectors want to utilise the handful of games by giving more opportunities to Axar Patel and Washington Sundar," Hindustan Times quoted a BCCI source.

Meanwhile, Ajit Agarkar clarified that Ravindra Jadeja was rested, not dropped from the ODI squad. He then went on to term the all-rounder's exclusion a strategic move, made in light of a busy Test season. "It would have been really pointless to take both Axar and Jaddu for a three-match series," Agarkar said.

"He has had a terrific World Cup. Not at all dropped. Either of them wouldn't have featured in games had we taken him. There's a big test season coming up. I think probably we should have clarified it when the squad was announced. He is still part of the format. He is a very important player for us," he added.

Notably, Jadeja boasts a formidable all-round record in ODIs, scoring 644 runs at an average of 40 and a strike rate of 84 since India's gut-wrenching defeat against New Zealand in the ICC Men's World Cup 2019.

### PTI ban: PM Sharif 'summons' Federal **Cabinet meeting** tomorrow

Earlier, Information Minister Atta Tarar said there are credible pieces of evidence to support a ban on the PTI and cited the party's involvement in foreign funding, the May 9 incident, its role in the resettlement of terrorists in Pakistan, the cipher episode, and the resolution passed in the United States.

Addressing a presser, Atta Tarar said that Article 17 of the constitution empowers the federal government to ban a political party.

He stated that a reference under Article 6 will also be filed against former President Arif Alvi, former Prime Minister Imran Khan, and former Deputy Speaker Qasim Suri for violating the constitution when the assemblies were dissolved following the no-confidence motion against the then prime minister.
