

According to the draft bill, a proposal has been made to amend Section 2 of the 1997 Act to increase the number of SC judges. The proposal suggests that the SC would have a total of 22 judges, in addition to the chief justice of Pakistan.

The objectives of the proposed bill state that the increase in the number of top court judges would result in a "faster legal process, timely hearings, and judgments."

The text states that increasing the number of judges can reduce the excessive workload on individual judges and lead to more diverse rulings. 5 died, 3 injured as warehouse roof collapsed in Humak

ISLAMABAD, AUG 27 (APP): In a tragic incident on Tuesday, the roof of an under-construction warehouse in Humak collapsed, resulting in the deaths of five laborers and injuries to three others.

According to an Islamabad Capital Territory (ICT) administration spokesperson, eight workers were on site when the roof suddenly collapsed and they were buried under the debris.

The initial rescue operation led to the recovery of four bodies and three injured individuals, who were transported to a local hospital for medical treatment, he said.

He said rescue teams continued their efforts to locate one more laborer still buried under the rubble.

He said Deputy Commissioner ICT Irfan Nawaz Memon was present throughout the rescue operation, supervising the relief efforts alongside the Assistant Commissioner Rural and other officials.

Rescue officials reached at the scene soon after the incident, successfully pulling two workers out of the rubble in time to save their lives, he added.

Senators demand iron fist for terrorists

he women senators on Tuesday demanded the government to take the terrorists to task with iron hands for unleashing unmatched barbarism in the Balochistan province.

Speaking on the Balochistan carnage during the 342nd session of the Senate, Parliamentary Leader of Pakistan Peoples Party Parliamentarians (PPPP), Senator Sherry Rehman said there was no distinction between terrorists as good or bad as any hostile elements picking up weapons against the state were terrorists and country enemy.

She said the PPPP leadership faced terrorism and violence due to its leadership's strong stance against insurgency in the country. "Shaheed Mohtarma Benazir Bhutto was the only leader who announced to hoist Pakistani flag in Swat during the terrorists' insurgency and was martyred by the terrorists," she added.

Senator Rehman underlined that some 80,000 to 90,000 civilians and numerous soldiers of the armed forces and law enforcement agencies (LEAs) personnel had embraced martyrdom in the war on terror.

Pakistan, she said was alone in fighting a war against terror, and our society was penetrated through Afghanistan by insurgents and consequently, many terror groups emerged with different names at that time.

"Pakistan Armed Forces did the impossible counter-terrorism operations despite having the least knowledge of asymmetric warfare and learned through its experiences.

The then Prime Minister Yousaf Raza Gillani and Gillani and President Asif Ali Zardari took the government seriously on the matter of terrorism and took the opposition and political leadership into confidence. We paid a heavy price in that regard as PPP faced many martyrdoms and Gillani's son was abducted by terrorists," she added.

Pakistan Tehreek-e-Insaf (PTI), Senator, Dr Zarga Suharwardy Taimur said there was no second thought about taking terrorists to terms with iron hands.

The State and the armed forces of the country, the police force, and LEAs who rendered great sacrifices could easily tackle and were fully capable of controlling and stemming terrorism from the country, he added.

"This is the fifth insurgency in Balochistan and the first had occurred in 1970 and it was 26th August, the death anniversary of Nawab Akbar Khan Bugti. BLA an international insurgent organization had launched attacks on 10 districts for 20 hours and kept the security forces engaged," she said.

She said the Balochistan massacre was deplorable and the demonstration led by tribal women and girls in Gwadar was also regrettable. She queried that despite these crises why the quarters concerned were not paying heed to the pressing issues of the deprived areas of the country.

Jail Officers Required to Install Electricity Meters and Pay Utility Bills

news report has emerged in the media that "Jail officers" have ensure compliance with these orders.

According to the statistics, electricity been directed to install electricity meters and begin paying their utility bills in response to concerns raised by the Water and Power Development Authority (WAPDA). According to

an effort to curb this wastage, WAPDA has issued a directive that all jail officers should transition from paying fixed charges to using metered electricity. The deadline for compliance with this new requirement has been set for September 9th, emphasizing the urgency of addressing this issue. The move is intended

to promote more responsible electricity usage among jail officers and to reduce the financial burden on the public treasury.

the electricity bills for the homes of officers and personnel in the prison department were fixed. Under this arrangement, the monthly bill was set at approximately 18,000 rupees for a DIG-ranked officer, 15,000 rupees for a Superintendent of Jail, 12,000 rupees for a Deputy Superintendent, 8,000 rupees for an Assistant Superintendent, 7,000 rupees for a Head Warder, and 5,100 rupees for a Warder. However, WAPDA authorities prepared a report and sent it to the government, highlighting that these fixed charges are extremely low compared to the actual electricity prices and usage.

In response, the government has issued orders to install electricity meters in the homes of jail officers and personnel. The Inspector General (IG) of Prisons Punjab has been directed to

According to the statistics, electricity meters will be installed in 128 homes, including those of the DIG and Superintendent at the New Central Jail Multan, 57 homes at the District Jail, 44 at the Women's Jail, 67 at the District Jail Khanewal, 13 at Shujabad Jail, and other WAPDA, the excessive use of air conditioners and jails with residential housing. lation of meters by September 9th. Failure to do so will result in action against the respective jail's Superintendent. The record of officers and personnel residing in the jails has been prepared and sent to WAPDA authorities for this purpose.

According to the law, it is mandatory for every citizen who uses electricity to have an elec-

tricity meter installed at their premises. This requirement ensures that electricity consumption is accurately measured, promoting fairness It is important to note that for a long time, and transparency. The principle behind this law is to uphold the standards of justice by ensuring that each user pays for the exact amount of electricity they consume.

However, a surprising and concerning issue has recently come to light regarding the electricity supply to jails in Punjab. It has been discovered that electricity is being provided to these facilities without the use of meters. Instead of having their electricity usage accurately tracked, many jail officers and employees are benefiting from a system of fixed charges. This fixed billing system allows them to pay a set amount each month, regardless of how much electricity they actu-

This situation has led to significant misuse of electricity within the homes of jail employees. and corruption but also to electricity theft. It is Reports indicate that these employees are using essential to address and eliminate these issues.

air conditioners extensively, particularly during the hot summer months. Moreover, they are relying heavily on electric heaters for cooking food, including bread, tea, and curry. These appliances consume a substantial amount of electricity, far exceeding what would be covered by the fixed charges they are paying.

The absence of electricity meters in these residences means that the true extent of their electricity consumption is not being recorded. As a result, these employees are effectively using much more electricity than they are paying for, which leads to a significant financial loss for the government and, by extension, the public.

This situation is not only a violation of legal requirements but also a gross injustice to ordinary citizens. While regular citizens are required to pay for every unit of electricity they consume, jail employees are enjoying an unfair advantage by consuming electricity far beyond their fixed payments. This discrepancy creates an imbalance in the system, where the burden of these costs ultimately falls on the public treasury.

No doubt, the practice of supplying electricity to jails without meters is a serious issue that undermines the principles of fairness and justice. It not only results in significant financial losses but also perpetuates an unfair system that favors a select group over the general public. There is an urgent need for the authorities to address this issue by ensuring that electricity meters are installed in all jail facilities and that all users pay for their actual consumption, just as the law mandates for every other citizen.

Although WAPDA was slow to realize the need to install meters in jails, it is indeed the right decision. WAPDA should consider adding an electricity allowance to its employees' salaries instead of giving them free units. The provision of free units has not only led to political maneuvering

Al-Shifa saves 16000 premature babies from 'Alarming' rise in deadly lifelong blindness

ISLAMABAD: Through timely intervention, Al-Shifa Trust Eye Hospital has prevented sixteen thousand premature babies from developing irreparable damage to their eyes over the past eleven years.

Dr Wajid Ali Khan, the chief of medical services at Al-Shifa Trust Eye Hospital, said the growing incidence of retinal abnormalities among premature infants in Pakistan calls for urgent attention.

He said that the majority of premature babies who weigh less than 1.5 kilograms at the time of birth have a high risk of developing the disorganized growth of retinal blood vessels, which can cause vision problems, including permanent blindness.

Talking to media, he said that babies born prematurely have many obstacles to overcome in their first weeks, including abnormal eye development, which can be resolved through

screening and surgical procedures to help avoid serious eyesight problems.

He said the retina's blood vessels begin to develop three months after conception and complete their growth at normal birth. However, eye development can be disrupted if an infant is born prematurely.

"Latest studies have shown that keeping the oxygen saturation at a lower level can reduce the rate of advanced retinopathy," he said.

He said one in ten babies worldwide is born early, with a chance of eyesight issues. Therefore, parents must include a vision screening in their list of baby check-ups between six and twelve months of age.

He added that every premature infant deserves the constant attention of an ophthalmologist because they are at increased risk for eye misalignment, amblyopia, and the need for glasses to develop normal vision.

He said that in Pakistan, about 900000 babies are born annually, out



of which about 100000 are prematurely born, and eighty percent of them are prone to eye problems.

He added that the Al-Shifa Trust Eye Hospital Rawalpindi has over 40 highly qualified eye surgeons, and the Pediatric Department has some of the most senior eye specialists. The hospital has expanded, handling over 500 OPD

babies daily.

Dr. Wajid Ali Khan said that we had signed MoUs with the administrations of Fuji Foundation Hospital, Combined Military Hospital, and Benazir Bhutto Hospital, under which the trust will provide all the facilities, from transportation to screening and surgery, for premature babies born in these hospi-

He informed that Al-Shifa is the only hospital in the SAARC and among the few worldwide with the latest facilities and skills to treat newborns with Retinopathy of Prematurity (ROP).

Al-Shifa started screening and treating newly born babies, especially those under seven months, in March 2013 and has cured around 16000 babies in the last 11 years. He said the number is bound to increase as aware-

ness grows. He said we use Teleophtholmolgy to provide free guidance to all state-owned and private health facilities including those located in other countries.

lightning strikes in India: scientists

NEW DELHI: Climate change is fuelling an alarming increase in deadly lightning strikes in India, killing nearly 1,900 people a year in the world's most populous country, scientists warn.

Lightning caused a staggering 101,309 deaths between 1967 and 2020, with a sharp increase between 2010 and 2020, a team of researchers led by Fakir Mohan University in the eastern state of Odisha said.

"The results indicate a steady increase in lightning activity in India, positioning it as a major killer among climate change-induced natural disasters," it said.

While the report looked at data on deaths, not the number of strikes, it said "lightning activity in India is becoming increasingly unpredictable".

Data showed that the average annual fatalities per Indian state rose from 38 in the period 1967 to 2002, to 61 from 2003 to 2020 - a period when the

country's population has also rapidly grown to 1.4 billion people.

Lightning strikes are common in India during the June-September monsoon rains, which is crucial to replenishing regional water supplies. But scientists say their frequency is

increasing due to rising global temperatures, unleashing a cascade of extreme weather events.

Higher air temperatures create more water vapour, which after it cools at altitude, creates electric charges that spark lightning.

The high number of fatalities in India is also due to ineffective early warning systems and a lack of awareness of how to reduce the risk, the report added, published in the international journal of Environment, Development and Sustainability.

Mass fatalities from a single strike are common, such as when farmers shelter in groups from lashing rain under a tree.

ISLAMABAD: Former President of the Islamabad Chamber of Commerce and Industry (ICCI), Dr. Shahid Rasheed Butt, said on Tuesday that the reluctance of friendly countries to roll over debt for one year is making it difficult for Pakistan to get a loan from the IMF.

He added that Pakistan would face problems in getting loans from other sources unless it is under the IMF program.

Shahid Rasheed Butt said in a statement issued here today that Pakistan has fulfilled almost all the conditions of the IMF for obtaining the loan, except for debt rollover.


However, China, Saudi Arabia, and the United Arab Emirates have not yet extended the twelve billion dollar repayment period by one year, which is why the IMF is not lending.

A staff-level agreement was reached between the IMF and the government of Pakistan for a loan of seven billion dollars over thirty-seven months, but the international organization's executive board has not vet approved it.

Shahid Rashid Butt said that earlier, Pakistan had requested these three countries to increase the loan repayment period from three to five years, which was rejected. After that, there was a request for a one-year extension in the loan repayment period, on which they have been silent.

In addition, there is a two-billion-dollar shortfall in external financing, which is not going down well with the lender.

In these circumstances, Pakistan has no option but to take more loans to survive, for which efforts are being made. Until the loan is received, even the IMF will not help Paki-



stan, he noted. The business leader noted that Pakistan has

been critical to Western and Arab countries for many decades, so it did not face any problems obtaining loans. However, it is not given importance now, so the lenders' conditions are also getting stricter.

In 2020-21, fair living wage was around Rs46,000 for Karachi, Lahore, Islamabad and Rs39,000 for other cities. Currently, it is about Rs60,000.

In 2021, an average consumer had 33 percent discretionary income which is the income left after paying for essentials like housing and food. Today, that figure has dropped to just 8-10 percent which must be improved, he said.

He warned that the government must implement real reforms, adopt policies based on merit rather than political interests, increase exports, and become self-sufficient; otherwise, the country will go bankrupt.



Legendary England pacer James Anderson garnered massive praise on India's batting star Virat Kohli, terming him as the greatest finisher in white-ball cricket.

Anderson, who recently bid adieu to Test cricket, appeared in BBC's Tailenders podcast and talked about his admiration for Kohli's brilliance in run chases. "I do not know if there is been a better batter in the history

of the game batting second and chasing down scores than Virat Kohli," Anderson said. "His record at chasing is absolutely phenomenal. The number of hundreds he has scored in the second innings, chasing down scores is ridiculous.

Virat Kohli's records in run chase in white-ball cricket back James Anderson's remarks as the right-handed batter has scored 7,852 runs at an average of 64.36 with the help of 27 centuries and 40 fifties. "It is no surprise that when he gets in that situation, with his mentality, it is just like it is meant to be. His self-belief is so high," Anderson added.

When asked if James Anderson considers Virat Kohli the greatest white-ball batter of all time, the England legend refrained before mentioning Australia's Michael Bevan.

"I cannot say that. I was thinking more in terms of just chasing. Michael Bevan from Australia comes to my mind, particularly in the late 1990s and early 2000s - he was just phenomenal coming in at number six and doing that job," the England pacer added.

Kohli batting at number 3 gets those hundreds while Bevan was renowned for getting his 50s, 60s and being at the end, while Kohli gets the big score, to get his teams over the line. I honestly can't think of a better finisher and greater white-ball players than him (Kohli)," he concluded.


