# Pakistan, Malaysia agree to deepen trade, investment cooperation

ISLAMABAD: Pakistan and Malaysia on Thursday agreed to deepen bilateral cooperation in multiple areas including trade, investment, defence, and agriculture, besides reiterating their strong positions on regional issues including Gaza and Kashmir.

In a joint press stakeout following their one-on-one meeting and delegation-level talks, both prime ministers told the media that their discussions focused on strengthening the bilateral collaboration in multiple areas of mutual interest as well as

regional and international issues including Palestine and Kashmir.

As part of the efforts to boost bilateral trade, both leaders agreed that Pakistan would export Halal meat worth \$200 million per annum and 100,000 metric tonnes of Basmati Rice to

Total trade between Malaysia and Pakistan stood at USD 1.4 billion with the trade goods included palm oil, apparel, textiles, chemical and chemical-based products, and electrics and electronic products. Among South Asian countries, Pakistan is Malaysia's third-largest trading

In his remarks, Prime Minister Shehbaz told the media that besides discussing the export of Pakistan's Basmati Rice, two sides also discussed the possibilities of exporting Halal meat from Pakistan to Malaysia worth \$200 million per annum, and assured

#### Private schools, Metro Bus to be closed amid strict security for PTI protest in Islamabad

ISLAMABAD: Section 144, prohibiting gatherings, has been imposed in Islamabad, Rawalpindi, Sargodha and Attock, Pakistan, in anticipation of a Pakistan Tehreek-e-Insaf (PTI) protest planned for Islamabad on October 4.

A notification confirming the imposition of Section 144, effective from October 4 to 6, has been issued. Private schools in Islamabad will also remain closed on October 4.

Sources indicate that access to Rawalpindi will be restricted, with the Metro Bus service suspended and Motorways M1 and M2 completely closed. Access from Taxila, Chakrial, Rawat, and the Airport will also be blocked.

Law enforcement agencies have reportedly recommended a temporary shutdown of mobile networks to the

## SC overturns decision in 63-A case paving way for defecting votes to be counted

ISLAMABAD: The Supreme Court unanimously agreed on Thursday to review its 2022 ruling regarding the defection clause outlined in Article 63-A of the Constitution.

In its decision from May 17, 2022, the Court declared that votes cast against the parliamentary party lines in four specific situations mentioned in Article 63-A should not be counted. Today's ruling implies that in future legislative actions, votes from lawmakers who oppose party policy will indeed be counted.

The 2022 ruling on the presidential reference submitted by then-president Arif Alvi was a narrow 3-2 decision, authored by then-CJP Umar Ata Bandial, Justice Ijazul Ahsan, and Justice Munib Akhtar. Justices Mazhar Alam Khan Miankhel and Jamal Khan Mandokhail dissented, arguing that further interpretation of Article 63-A would be akin to "rewriting or reading into the Constitution." The Supreme Court Bar Association (SCBA), which initiated the petition, shared this viewpoint.

A five-member bench, led by CJP Isa and including Justices Mandokhail, Miankhel, Naeem Akhtar Afghan, and Aminuddin Khan, heard the review peti-

tion filed by SCBA in June 2022. Justice Afghan was added to the bench

after Justice Akhtar, who was part of the original panel, and senior puisne judge Justice Syed Mansoor Ali Shah opted out due to concerns over a recent ordinance affecting bench formations.

In a prior hearing, CJP Isa criticized the earlier larger bench's conclusions. On Wednesday, the Court dismissed objections raised by Zafar, counsel for Imran, regarding the bench's composition related to the ordinance.

During today's proceedings, Zafar expressed a desire to withdraw from the case if his client was not permitted to appear via video link. However, CJP Is a requested his assistance, to which

Justice Isa announced the unanimous acceptance of the SCBA's appeal, stating that a detailed verdict would follow.

## Fazl says constitutional amendment should be postponed

ISLAMABAD: Jamiat Ulema-e-Islam chief Maulana Fazlur Rehman has called for a postponement of the proposed 26th constitutional amendment bill. Addressing a press conference in Islamabad on Thursday, he criticized the current government, stating it lacks both popular mandate and the capacity for improvement.

Rehman urged the government to delay

the amendment until after the conclusion of the Shanghai Cooperation Organisation (SCO) conference. He expressed surprise at the government's haste in pursuing the amendment, drawing a comparison to the extensive deliberation that preceded the 18th Amendment.

He emphasized the importance of the JUI-F's vote and demanded to be heard on the matter. While accepting the court's ruling on Article 63-A, he cautioned

against using the decision as a tool for manipulation or vote-buying. He stated that any future strategy

regarding the constitutional amendment will depend on the JUI-F's stance, clarifying that the party is currently not in favor of the amendment. He also indicated a lack of information regarding any joint parliamentary session. He dismissed the government's justifications for the amendment as insignificant.



# Experts at CASS explore the rising threat of weaponised consumer technologies

LAHORE: The Centre for Aerospace & Security Studies (CASS), Islamabad, hosted a NextGen Tech Roundtable, 'Lebanon Explosions: Weaponising Consumer Technologies,' where experts analysed implications of the recent incidents in Lebanon for global technological security. Air Commodore Raza Haider (Retd) provided an overview of the subject and highlighted the unprecedented nature of the pager and walkie-talkie explosions in Lebanon, stressing that they exemplify the potential dangers of weaponising consumer technologies. He urged for an exhaustive analysis of these incidents due to their implications for Fifth Generation Warfare

Dr Haider Abbas (TI), Director Emergency Response Team (NCERT), discussed how the Lebanon incidents cooperation could have security implivalidate concerns about the weaponisation of operational technology. He urged the need for Pakistan to enhance cybersecurity preparedness by screening consumer technologies and aligning with international in Pakistan which reflect the govern-

In closing, Air Marshal Javaid Ahmed (Retd), President of CASS, reiterated the significant national security implications of the Lebanon explosions. The President of CASS stated that the growing collaboration between Israel and India indicated that disruptive technologies could soon make their way to India, urging Pakistan to develop countering mech-

He appreciated the work being undertaken at NCERT but stressed the urgency of maintaining a focus on these issues amidst the changing technological landscape, warning that Pakistan must navigate carefully through the emerging technological blocs and the evolving nature of Fifth Generation Warfare.

The roundtable also included an interactive question and answer session with experts from NICAT, NASTP, retired military officers, and researchers, further enriching the discourse on this critical subject.

#### Attock Police arrested 128 drug dealers and recovered valued of 21.4 million rupees

ATTOCK: Attock Police has released the performance report for September 2024. Under the leadership of District Police Officer Attock, Dr. Sardar Ghayas Gul Khan, Attock Police arrested 128 drug dealers and recovered 147 kilograms of hashish, 3,100 grams of opium, 490 grams of heroin, and 120 grams of ice. During September, 26 cases were registered against liquor sellers, leading to the arrest of 31 individuals involved in liquor supply, with 303 liters of alcohol seized from their possession. Under the Arms Ordinance, 71 cases were registered, resulting in the arrest of 72 individuals. From them, 65 pistols, 4 rifles, 3 shotguns, 4 Kalashnikovs, 1 revolver, 306 bullets, and 2 sharp knives were recovered. Additionally, 23 proclaimed offenders were arrested last month, including 5 from Category A and 18 from Category B, along with multiple court fugitives. In September, 15 dangerous robbery gangs consisting of 42 suspects were apprehended, with a total recovery of valuables worth 21.4 million rupees. During the past month, Attock Police issued 1,649 character certificates and 1,414 general police verifications, providing services to the public. Moreover, 8,227 learner permits and 5,897 driving licenses were issued, while 418 tenancy reports and 242 missing reports were registered.

The event commenced with a screening of CSJ's documentary film based on the true stories of the families of minor girls who had been forcibly converted in Pakistan and present awards to leading Characters Haider Jamal and Lala Robin. The film won the award for Best Short Documentary on Human Rights at the prestigious Venice Intercultural Film Festival in 2023, and it has been selected for its fifth international screening, including at the 7th FICNOVA in Spain in 2024.

Human rights activist including; Lala Robin, Saiqa Kaur, Yassar Talib, Gurmeet Singh, Manzoor Anthony and



Abrar Sohtra addressed the pressing issue of forced conversions and child marriages in Pakistan. The speakers emphasized that coerced conversions violate fundamental human rights, yet remain largely unaddressed due to governmental inaction. The speakers called on the government and legislative bodies to introduce and implement

legal and administrative safeguards to protect underage girls from forced religious conversions and marriages.

Lala Robin underlined that the half-hearted efforts made by federal and provincial governments in the past, failed to cultivate empathy for strengthening protections against forced conversions and child marriages.

Saiqa Kaur stressed that the adoption of legal procedures for conversion and marriage under judicial oversight

Gurmeet Singh agreed that no individuals particularly children should be forced to enter into marriage and revoke their religion, therefore legislation criminalizing the act of forced conversions, and strictly enforcing 18 years as the minimum legal age for both religious conversion and marriage is imperative, in line with rulings issued by the Lahore High Court in 2019, Federal Shariat Court in 2021, and Islamabad High Court in 2022.

Yassar Talib quoted CSJ data revealing that at least 338 cases of abduction and forced religious conversions of minority girls and women were reported in Pakistan during 2021 and 2023, which underscores the credibility of these complaints.

KARACHI, OCTOBER 3, 2024: NEPRA concluded its hearing on K-Electric's petition of provisional monthly fuel charge adjustments (FCA) for August 2024, at PKR 0.51 per unit. Following the public hearing the regulator will issue a decision clarifying the FCA amount to be passed on to customer bills and the period for which they will be applicable.

For July 2024, K-Electric requested the regulator for an increase of PKR 3.09 per unit, and the hearing for this request has already been concluded on August 29, while a decision is awaited on the final amount and which month they will reflect in customer bills. By comparison, KE's request for August 2024 reflects a net decrease of PKR 2.58 rupees per unit as compared to its requested FCA for July 2024.

# BISP, UN WFP sign agreement to extend Benazir Nashonuma Programme

ISLAMABAD, OCTOBER 03, 2024: Benazir Income Support Programme (BISP) and United Nations World Food Programme (WFP) have extended their partnership for another two years under the Benazir Nashonuma Programme. In a ceremony held today at BISP Headquarters, witnessed by Senator Rubina Khalid, Chairperson of BISP. Secretary BISP Mr. Amer Ali Ahmad and Ms. Coco Ushiyama, Country Director & Representative of WFP exchanged the agreement documents. #### Cyber threats to 27.2% of industrial systems in **Pakistan**

aspersky's report on the cyber security landscape for industrial control systems (ICS) in the second quarter of 2024, revealed a 20% increase in ransomware attacks compared to the previous quarter. The report underscores a growing threat to critical infrastructure sectors worldwide, with ransomware and spyware posing the most significant risks.

Kaspersky Security Network statistics show that 23.5% of ICS computers globally were exposed to cyber threats in O2 2024. ICS systems in Africa remain the most heavily exposed, with 30% of ICS computers attacked, while in Pakistan the figure is 27%.

Ransom ware activity surged, with the percentage of ICS computers affected by ransom ware rising by 1.2 times compared to the previous quarter. Kaspersky's report also highlights a continued exposure to scripts and phishing pages as well as to spyware, including backdoors, keyloggers, and trojans, which are often used for data theft and to enable further attacks such as ransomware.

"Our findings reveal that while the overall number of attacks on operational technology (OT) computers is slightly down, the rise in ransomware and spyware is concerning," says Evgeny Goncharov, head of Kaspersky's ICS Cyber Emergency Response Team. "High-impact malware like ransom ware can disrupt critical operations in any industry. Phishing pages and spyware are often used to steal corporate credentials and either uses them for further propagation into the target's infrastructure or to sell them on dark web marketplaces for future reuse by ransomware gangs, activists, and APT groups. Overexposing OT infrastructures to these threats puts operations and businesses at high risk of a devastating incident."

The building automation sector saw the highest percentage of ICS computers attacked (28.3%) in the reviewed period globally, with attackers exploiting weak points in building automation networks, often targeting internet-facing systems and outdated software. The following sectors are Energy (26.3%), Oil & Gas (22,5%), Engineering and ICS Integration (23,4%) and Manufacturing (11,7%).

## Pakistan needs unified strategy for sustainable growth and investment: Azfar Ahsan

ISLAMABAD: Muhammad Azfar Ahsan, former Minister for Investment, stressed the need for Pakistan to prioritize optimizing its existing investments, advocating for a strategy that focuses 80% on nurturing current investors rather than concentrating on attracting new investments.

Azfar spoke at a special talk hosted by the China Pakistan Study Centre (CPSC) at the Institute of Strategic Studies Islamabad (ISSI) on the topic of "Pakistan's Investment Landscape: Challenges, Opportunities, and Way Forward." He emphasized that sustainable economic growth and stability can only be achieved by consolidating resources, improving capacity-building, and creating an enabling environment for investors. "If we focus 80% on existing investments, foreign investment will follow," he remarked.

Comparing Pakistan's highlighted that the country has attracted USD 49 billion

billion, and India pulls in USD a coherent national strategy and reforms to improve Pakistan's competitiveness," he said.

Azfar also raised concerns about Pakistan's rapidly growing population, which is expected to reach 400 million by 2047. PYONGYANG: Kim Kang Il, vice-minister of National Defence of the Democratic People's Republic of Korea, on Tuesday issued the following press statement titled "The U.S. reckless military bluff and moves for escalating tensions will only increase security instability of its mainland":

Pentagon's confrontational attempt to permanently deploy nuclear strategic assets to the Korean peninsula and its vicinities to intentionally demonstrate the "upperhand in strength" and put military pressure on the sovereign states in the region is being manifested in a diverse way.

Shortly ago, the latest nuclear submarine of the U.S. Navy openly revealed its shape at Pusan Port of the ROK. #### NDRMF Business Policy 2024 envisages paradigm shift in disaster, humanitarian sector: **Bilal**Anwar

ISLAMABAD: Chief Executive Officer (CEO), National Disaster Risk Management Fund (NDRMF), Bilal Anwar on Thursday said the Fund have launched its first Business Policy 2024 that helped in repurposing and redefining it over a course of 18-month to change the donors' mindset for well-informed disaster resilience interventions.

The document is a 10-year long-term policy intervention being implemented after extensive consultations with all stakeholders, Chief Executive Officer (CEO), NDRMF, Bilal Anwar said in an exclusive interview with APP while showcasing the efforts and accomplishments of the Fund.

"Resilience building is a long-term process and its challenging amid growing climate catastrophes as every intervention has its impacts but a long-term strategy is necessary and the NDRMF Business Policy is addressing it.

There have been repeated discussions with relevant bodies, provinces, fund implementing partners (FIPs), researchers, pratitioners and experts related to the subject which resulted into culmination of our efforts in the form of the strategy," Bilal Anwar said.
"The National Catastrophe model (NATCAT) Data Center has

been established with the support of the Pakistan Space and Upper  $\,$ Atmosphere Research Commission (SUPARCO) whereas a special application to be built on its data is underway," he said.

The NATCAT unlike the conventional databases is a progressive tech-based solution using most-modern approach and solutions," he said, adding that it could help drawing risk profiling of intended regions and use that risk modelling to assess future disaster before The NDRMF CEO underlined that there have been nine perils

identified by this system and it could undertake 400 years modelling in case of flood and gauge its impacts. The NATCAT covered the entire country whereas it has the capability to provide limited and selected area projections as well, he said. He informed that the Disaster Risk Financing (DRF) Strategy

has been recently approved by the government which was enacted in the aftermath of devastating 2022 floods' impacts and losses borne by the government.


