Special Parliamentary Committee recommends Justice Yahya Afridi for CJP slot

ISLAMABAD: The Special Parliamentary Committee on Tuesday recommended Justice Yahya Afridi's name to be the next chief justice of Pakistan (CJP).

Incumbent CJP Qazi Faez Isa is set to retire on October 25, 2024 and will be replaced by Justice Yahya Afridi, who is third in the seniority list.

The Special Parliamentary Committee, formed after the 26th constitutional amendment. held its meeting with nine out of 12 members in attendance to deliberate the three names for a top judge slot.

Pakistan Muslim League-Nawaz's (PML-N) Senator Azam Nazir Tarar, Khawaja Asif,

Ahsan Iqbal, and Shaista Pervaiz; Pakistan People's Party's (PPP) Farooq H Naek, Raja Pervaiz Ashraf, and Syed Naveed Qamar; Rana Ansar of Muttahida Qaumi Movement-Pakistan (MQM-P) and Senator Kamran Murtaza of Jamiat Ulema-e-Islam-Fazl (JUI-F) attended the meeting.

Pakistan Tehreek-e-Insaf's Barrister Gohar Ali Khan, Barrister Ali Zafar, and SIC chief Sahibzada Hamid Raza abstained from the meeting.

How CJP is appointed after

26th constitutional amendment? The constitutional amendment to Article 175A paved the



way for key changes to how judges are appointed, shifting more authority to a 12-member parliamentary committee comprised of eight members from the National Assembly (NA) and four senators – to appoint the CJP, selecting from among the three most senior judges.

After amendment to clause 3 of

Article 175A, the top judge is now College, Cambridge University. appointed on the recommendation of the Special Parliamentary Committee from amongst the three most senior SC judges, rather than the president designating the most senior judge of the Supreme Court as the CJP.

After finalising the name, the prime minister conveys the nominee's name to the president for appointment after receiving it from the committee established for the same purpose.

Justice Yahya Afridi was born on January 23, 1965, in Dera Ghazi Khan. He received his early education at Aitchison College, Lahore, and later graduated from Government College, Lahore. He furthered his legal studies, earning an LLM from Jesus

He commenced his legal practice in 1990, eventually joining the Supreme Court bar in 2004. His judicial career began with his appointment as an additional judge of the Peshawar High Court in 2010, becoming a permanent judge in 2012.

He rose to the position of Chief Justice of the Peshawar High Court in 2016. Justice Afridi's appointment to the Supreme

Court followed in 2018. Since then, he has participated in larger benches hearing significant cases, including those related to reserved seats and the Zulfikar Ali Bhutto presidential reference. He has also written dissenting notes in several key judgments.



He said that performance of various districts of the division is much better than before while micro plans have been improving in Dadu, Badin, Jamshoro, Sujawal and Hyderabad to cover up refusals cases.



Achieving selfsufficiency in edible oil

s the government embarks on agricultural transformation shifting to corporate from traditional farming, peasants are embracing to novel technologies and techniques to enhance cash crops productivity for attaining food sufficiency and economic stability.

This voyage to economic resilience, like other parts of the country can also be seen in merged districts of erstwhile FATA where in Bajaur district of Khyber Pakhtunkhwa, the farmers opted for olive grafting for locally enhancing olive oil production.

Taking advantage of land and climate suitability in Malakand division, farmers like Barkat Shah have started uncovering the potential for significant financial gains from their limited mountainous land.

His five-acre lush green olive grove on Mohmand-Bajaur road not only present an eye catching view but also makes him confident to earn sufficient dividend for his

"Bajaur's climate and soil conditions are ideal for wild olive grafting," Barkat Shah said. "Response from farmers is overwhelmingly due to grafting technique's cost-effectiveness and high oil yielding efficiency."

Known locally as 'Ustad' for his expertise in olive grafting, Haji Barkat reveals, the process of olive grafting involves a precise and skilled technique where a scion—a young, healthy olive variety—is joined to a robust rootstock, typically an older olive tree, resilient to diseases.

"This method enhances health and productivity of olive trees and ensures farmers to maximize gains form their land," he said. "We select a scion at growth stage, cut the scion and rootstock carefully for a snug fit and bind them together securely.'

This careful union, he said, leads to formation of a strong new branch, capable of yielding high-quality olives in just four to five years. "The optimal period for grafting is from February to April and July to September."

As the region provides suitable land environment, Ziaul Islam Dawar, Director, Agriculture Extension appreciates people's response in Malakand towards olive grafting.

"Growers are getting aware of this farming and start ing best quality olive varieties," he informed. "A good quality scion can easily be grafted onto a rootstock of rare variety to prepare a high-yielding and disease-resistant olive tree in a few years."

He stated that by grafting these rare varieties, the farmers can ensure better productivity for a longer period. "Besides their personal food and nutritional needs, olive also helps them earn living for their families and reduce import burden on national kitty."

Also known as the city of saints, Multan's cultural and architectural heritage is encapsulated within its Walled City; a 1.2 square kilometer area that houses scores of historic buildings, each with a unique story to tell.

"Each street and every home in the Walled City has a unique history," said Umair Ghazanfar, Assistant Director of Walled City Multan. "It is among the ancient cities and offers ample opportunities to culture and heritage lovers."

Excited about its uplift and restoration, streets like Mohalla Jatoo Shah, Mohalla Umair highlights the potential for further the Walled City a more welcoming desti-

growth, hoping for visit of more tourists nation for tourists. to this historic and cultural city.

"We welcome an average 100 foreign tourists monthly and our tricycle tours are exciting for visitors to explore these historic streets and buildings," he said. "By uplifting and rekindling this heritage, we can attract more tourists and earn revenue."

Local enthusiasts are equally optimistic about the future of Multan's Walled City as Dr. Sajid, a medical practitioner and passionate lover of Multan's ancient beauty, sees immense potential for tourism in the area.

"We need to improve infrastructure of the Walled City, including small hotels, cafés and entertainment spots," he suggested. "By renovating and making it more attractive, we can turn it into an attractive destination for local and foreign tourists.

Similarly, Dr. Muzzamal, a local tourist suggests to hold cultural events in the walled city to highlight its importance locally and internationally. "Cultural events and festivals in Walled city must be made a regular feature to celebrate city's history."

He was confident that these events would attract more tourists and develop deeper connection among local residents and the visitors. "We should also train local residents to act as guides to promote a culture of hospitality and engage local community in preserving and promoting their heritage.

Beyond infrastructure, a concerted effort to embrace the culture of hospitality could play a pivotal role in making

The local community, with its deeprooted traditions of warmth and generosity, would also help promote a sense of collectivity bridging the territorial and cultural divides.

"Professional guide training, hospitality workshops and cultural education would empower local residents also enabling them to share the stories of their historic city with pride and authenticity," Dr. Muzzamal said.

Looking ahead, the revitalization of Multan's Walled City holds the promise of transforming it into a cultural tourism hotspot. With restored buildings, improved infrastructure and focus on hospitality, the area is poised to offer a blend of history, spirituality and local

"Social gatherings and festivals would not only breathe new life into these old streets but also flourish small businesses like boutique, hotels and traditional eateries to offer tourists an immersive experience," Dr. Muzzamal remarked.

As Pakistan is home to remnants of different ancient civilization discovered in Harappa and Mohenjo-Daro in Punjab and Sindh provinces and Buddah's stupa in KPK, Multan's Walled City is also important.

Raja Bazar – A colonial era business legacy

ost often stuffed with buyers, traffic and illeencroaching vendors, Raja Bazaar, boasts of it's over one and half century old legacy for once being the only central commercial point of ancient Rawalpindi. As the time ran down, this British colo-

nial era sanctuary of traders named after Rajput or Raja (castes) traders of this region still stands there with least of our younger generation knowing its origin and evolution into today's busiest bazar of Rawalpindi.

This blend of history and trade still holds a prominent place in city's business activities for its distinctive socioeconomic features, ancient building structures, classical archaeology designs and antique woodwork adorned with superb grillwork on facades of houses.

Majority of them are remnants of Sikh rule during their reign of Punjab. Narrow streets, multi-religious community centers, mosques and temples, historic mansions, havelis, old shops and godowns reflect its cultural heritage and socioeconomic importance. Abrar Sheikh, General Secretary Raja Bazaar's Central Traders' Association terms the bazaar as 'a symbol of socio-economic legacy' having multi-dimensional links with local and international markets.

"Looking around Fawara Chowk, one can find marks of ancient civilization towards 'Dingi Khoi' on one side and the rich marketplace on the other side," he said. "Strong reasons for being the heart of city are its central location and market linkage as it connects country's North region with the South. The entrepreneurs from GB and KP too, prefer Raja Bazaar for their trading

ventures after China's silk route." Highlighted an interesting feature of

departmentalized nomenclature of its sections, Abrar Sheikh mentioned to Sarafa Bazaar as house of jewelry; Kapra Bazar for cloths and garments; Lakar Bazaar for wooden articles and raw material; Urdu Bazaar books and stationary and Masala Bazar, Sabzi Mandi and other bazars for variety of goods and services.

"Around 50% of shops have been converted into small plazas and joint markets after joining close by shops together making Raja Bazar the largest wholesale market of the city," he said

Discipline of the bazaar and running businesses is governed by a 'constitution' formally crafted almost 120 years ago by Late Haji Muhammad Ismael, the founding father of central traders' association.

Faisal Shahzad, Ex RCCI Vice President and President of Garments Traders Association informed that more than 2500 shops in Raja Bazar are source of employment for thousands of workers. "Raja Bazar hosts millions of customer locally and from Azad Kashmir, GB and KP for being a 'one-stop market' providing multiple facilities of business, logistics, banking, currency exchangers, hotels, restaurants etc."

Raja Bazaar serves as a strong linkage between buyers and sellers offering multiple choices in terms of brands, quality and prices. It hotels, restaurants and tea stalls also have a variety of traditional foods like nihari, fish, soup, lassi, khoya falooda etc. as per seasonal requirement.

With Raja Bazar's expansion, the adjacent bazars like City Sadar road, Bara Market, Iqbal Road, Moti Bazaar etc, once having independent identity, now seem like its offshoots.

However, on identity of Moti Bazar alive, Tahir Taj Bhatti, Executive Member RCCI reveals Moti Bazaar as a separate entity named after a Hindu merchant, Moti Ram who built a haveli in 1883, that served as a Women Shelter for Hindu widows who had

rejected the 'Satti' ritual.

"The haveli, named 'Kunya Ashram' was meant for training widows on cloths stitching whose articles were displayed on haveli's outer walls for sale to generate welfare funds. But, later, it converted into a small shop," Bhatti said.

After Pakistan's coming into being, the haveli was converted into a boy's school and small market was developed into a bigger Moti Bazaar with 12 small market segments, Bhatti said. "Today, in Moti Bazar, over 1500 shops with diverse product are serving traders and customers.

'Purana Qila' (Old Fort) is another ancient market known for variety of wedding clothes while Imperial Market is home to electronics and electrical items. But, after conversion of adjacent residential area into commercial markets, nearby markets now look like parts of Raja Bazar.

But, this growth of Raja Bazar and other markets brought along multiple problems for traders and residents like unusual rushes, suffocating and filthy environment and deterioration in quality of goods.

"Markets expansion has reached its maximum capacity without addition of facilities," remarked a trader, Faisal Shahzad. "Continuous traffic jam coupled with noise and air pollution creates a mess besides unhealthy environment for eaters

"Therefore, we need special economic zone along new Ring Road for trucks and cargo containers to facilitate small traders coming to Raja Bazar," he said also recommending "time management by starting bazars early morning and closing early evening to avoid rushes.'

As an iconic mega trade center, Raja Bazaar can be transformed into a new commercial hub planned expansion, traffic and time management, removing encroachments and ensuring hygienic business envi-

Others speculated that hidden forces, possibly linked to the military establishment, played a role in weakening the PML-N's position. These theories gained traction given Pakistan's complex political history, where the military has often been seen as an influential player behind the scenes.

However, based on my research, I conclude that the real disruption in the PML-N's electoral performance was caused by the Tehreek-e-Labbaik Pakistan (TLP), a religious party that emerged as a significant force in the election. TLP, known for its hardline stance on religious issues, particularly the blasphemy law, managed to capture a considerable share of the vote, particularly in constituencies where religious sentiments run high. When analyzing the constituencies where the PML-N lost, it becomes evident that the margin between the winners and the PML-N candidates was often filled by votes that went to the TLP candidates.

This pattern is not confined to a few constituencies but is evident across the board, both in the national and provincial assemblies. The TLP's influence was

efore the general election, it was widely particularly noticeable in Punjab, where it managed to secure a significant number of votes, even in constituencies traditionally dominated by the PML-N. Even secure a simple majority or at least come in constituencies where the PML-N managed to secure victory, the TLP still managed to siphon off a substantial number of votes, thereby weakening the overall strength of the PML-N. This diversion of votes played a critical role in the PML-N's inability to secure



a stronger position in the assembly. The emergence of TLP as a substantial force in the electoral landscape presents a real and growing threat to the PML-N. The PML-N's dominance in Punjab has been crucial for securing federal power, and its ability to maintain this dominance is now being challenged by the TLP. The TLP's appeal to religious

campaign, focusing on anti-corruption and prom-

If this trend continues, it could jeopardize the PML-N's ability to maintain its electoral and political significance in future elections. The implications of this shift are profound. The PML-N must recognize that the TLP, with its growing influence and appeal, is not just a passing challenge but a formidable opponent that could reshape the political dynamics in Punjab and beyond. To counter this threat, the PML-N will need to strategize effectively, perhaps by addressing the issues that have led to the TLP's rise and by re-engaging with the voter base that has been drawn towards the TLP.

This may involve addressing the socio-economic and religious concerns that have fueled the TLP's popularity, as well as reasserting the PML-N's commitment to its core values and promises. Without a timely and robust response, the PML-N risks a continued decline, which could ultimately undermine its position in both provincial and national politics. The party's future success will depend on its ability to adapt to the changing political landscape and to counter the influence of emerging forces like the TLP.

MIU uses market data to keep surveillance of the various sectors of the economy.

The District Plastic Management impose fines to ensure implementation of plastic elimination campaign. They will also have the power to seal



factories manufacturing non-standard and environmentally non-friendly plastic bags besides lowering the registration and renewal fee of a quality and environment-friendly plastic bag manufacturing factory. The Cabinet also gave approval to recruit 310 Envi-Committees will have the power to ronment Inspectors besides approving the purchase of 250 e-bikes and a

Standard Uniform for them. The Cabinet approved the estab-

lishment of Punjab Examination, Curriculum, Training and Assessment Authority (PECTAA) besides approving CM Punjab laptop scheme. Madam Chief Minister directed the authorities concerned to give laptops to students as soon as possible.

The Provincial Cabinet gave approval to Khelta Punjab Games 2024 (Under 16 Talent Hunt Programme).

It was briefed that more than one lakh 15 thousand players have been registered for Khelta Punjab Games, and 6,000 youths will be given internship in sports department at Rs 25,000 per month. It was also apprised that private universities will provide 50 young athletes with free education along with sports facilities.

The cabinet approved Chief Minister Punjab Livestock Card for Small Farmers, and set a target of producing 2 lakh animals per year, besides extending the scheme to big farmers too.
