Iftar time today According to details, gas distribution companies had pledged uninterrupted supply during Sehri and Iftar hours. However, on the first day of Ramazan, residents in various cities, including Karachi and Rawalpindi, reported complete gas outages.

In Karachi, areas such as Rifah Aam Society, Malir, Nazimabad, Gulbahar, and Ranchore Line were severely affected. Similarly, Rawalpindi's Sixth Road, Satellite Town, Dhoke Kashmirian, Dhoke Pracha, Service Road, Dhoke Kala Khan, Khurram Colony, and Sadiqabad also faced gas shortages.

Due to the unavailability of gas, many households struggled to prepare Sehri, forcing residents to rush to hotels and roadside eateries for food.

In some areas, people had no choice but to begin fasting without Sehri.

## US judge declares Trump's firing of watchdog agency head illegal

WASHINGTON: A U.S. judge on Saturday declared President Donald Trump's firing of the head of a federal watchdog agency illegal in an early test of the scope of presidential power likely to be decided at the U. S. Supreme Court.

U. S. District Judge Amy Berman Jackson in Washington had previously ruled Hampton Dellinger, the head of the Office of Special Counsel who is responsible for protecting whistleblowers, could remain in his post pending a ruling.

Jackson said in her ruling Saturday, opens new tab that upholding Trump's



ability to fire Dellinger would give him "a constitutional license to bully officials in the executive branch into doing his will."

The Justice Department filed a notice late on Saturday saying they were appealing Berman's ruling to the U.S. Court of Appeals for the District of Columbia.



The plant also includes multi-stage filtration, automated sensors, and a digital control system that continuously monitor and regulate water quality. Citizens were informed that the water from this RO plant has a TDS 224, pH 7, and an arsenic level of 0.005ppm, making it of the highest quality. Additionally, the mineral remineralisation technology restores essential minerals in purified water, ensuring it remains healthy for consumption.

Following this, Chaudhry Zulfiqar Ali Anjum was invited to the stage, where he high-

lighted the plant's key features. He informed the commissioner and guests that water would be available for 15 hours a day, with plans to extend it to 24-hour availability based on demand. He emphasized the nozzle system, allowing elderly individuals, women, and children to fill their water containers directly from their vehicles without removing them.

In his speech, Chairman SM Group of Industries, Chaudhry Zulfiqar Ali Anjum, expressed gratitude to the Multan administration for their support, particularly recognizing the contributions of former Commissioner Maryam Khan, DG MDA, MD WASA Khalid Raza Khan, and senior WASA engineer Abdul Salam. ### London-Based Solicitor Waheed-ur-Rehman Mian Faces Serious Allegations

 $LONDON: The \ Solicitors \ Regulation \ Authority (SRA) \ has \ prohibited$ London-based solicitor Waheed-ur-Rehman Mian from practicing as a solicitor in England and Wales, referring his case to the Solicitors Disciplinary Tribunal (SDT) over allegations of professional misconduct.

Mian, a solicitor at M-R Solicitors LLP, is notably the legal representative of Ali Imran, the son-in-law of Pakistan's Prime Minister,

Following an SRA investigation dated 23rd February 2024, publicly disclosed on 11th August 2024, several serious allegations have been made against Mian, including:

Failure to Disclose Connections Accused of not revealing relevant associations and interests to clients investing in development projects. Conflict of Interest Allegedly acted despite a significant risk of conflict

Inadequate Client Advice

Alleged failure to properly advise clients on investment risks and planning considerations. Supervisory Failures

Accused of failing to provide sufficient oversight to junior staff handling client matters. The Solicitors Disciplinary Tribunal has determined that Mian

has a case to answer, and a formal hearing will be held to examine the evidence. It is important to note that these allegations remain unproven until the Tribunal reaches a final decision. At the time of the alleged misconduct, Mian was practicing at M-R

Solicitors LLP in South Woodford, London. The forthcoming tribunal hearing will provide him an opportunity to present his defence, with the Tribunal carefully assessing the evidence submitted by both the SRA and the respondent. This case underscores the SRA's commitment to upholding ethical

standards in the legal profession and ensuring transparency and accountability in client representation. The legal community and the public will closely follow the outcome of the SDT proceedings.

It should be noted that Mian Waheedur Rehman is a senior leader of PTI and a former president of PTI London. In addition to serving as the general secretary of the UK-based Pakistani business organization UKPCCI, he has also been a director of various companies.

## **Pakistan Urges UN** Security Council to Reform and Reflect **New Realities**

he UN Security Council must be more transparent and inclusive in conducting its business to meet the challenges posed by current global, regional conflicts and crises, Pakistan's Ambassador to the UN Munir Akram has said. Delivering Pakistan's statement at a debate on Working Methods under the long-running Intergovernmental Negotiations on Security Council Reforms, he said that while everyone was agreed on early restructuring of the 15-member body, the 'Pact for the Future', which the world leaders adopted last September, calls for strengthening the entire UN system, including the General Assembly, the Economic and Social Council and the Peacebuilding Commission.

Ambassador Akram therefore proposed focusing on moving on all fronts to reform the UN bodies.

Responding to a suggestion during the debate for reflecting on "new realities", he said doing that would again freeze the Council at a particular time

in its 1945 framework — when the world body was estab-

"Any expansion of permanent members would freeze the Council at that moment; It is only through the process of elections that the new realities that constantly change can be reflected in the composition of the Security Council, not by adding new permanent members," the Pakistani envoy said.

He was obviously referring to the intensive campaign by India, Brazil, Germany and Japan — known as the Group of Four for permanent seats as they seek expansion of the Council by 10 seats, with six additional permanent and four non-permanent

On the other hand, the Italy/Pakistan-led Uniting for Consensus (UfC) group, which firmly opposes additional permanent members, has proposed a new category of members — not permanent members — with longer duration in terms and a possibility to get re-elected, raising the number of elected seats to 21.

The Security Council is currently composed of five permanent members — Britain, China, France, Russia and the United - and 10 non-permanent members elected to serve for States two years.

The discussions over the years have revealed convergences as well as divergences on various elements of reform — convergence on priority for Africa, expanding the membership of developing countries and on the need for representation of regional and cross-regional groups, the Pakistani envoy said.

"But these discussions and the presentation of models have also revealed the divergences and these are considerable divergences on the size of the Council, on the issue of the categories of membership, on regional representations, on the veto, and even on working methods where there is a large convergence.'

On working methods, Ambassador Akram called for transparency — open meetings, more interactive open meetings, not set piece statements that, he said, are made without any thought to interaction and action by the Council.

Investigations and Inquiries. Standing legal and parliamentary powers through which the Chairmen, Parliamentary Secretaries, or other relevant officials can be questioned for inaction of the Standing Committees of the National and Provincial Assemblies

1. Constitutional and legal framework: The Constitution of Pakistan, 1973, clearly states that it is essential for parliamentary committees to be active. The Rules of Procedure and Conduct of Business in the National Assembly, 2007, and the Rules of Sindh Assembly are clear about the functioning of parliament, the composition of committees, and their responsibilities. Under these, it is possible to inquire about the non-regular meetings of committees or their performance.

2. Inquiries through parliamentary forums. Some imortant ways through which inquiries can be made:

(a) Question Hour. During the session of the Assembly or the Senate, members can ask questions to the Speaker or the Chairman of the Senate about the functioning of the Standing Committees.

(b) Calling Attention Notice

Members of the Assembly can file a Calling Attention Notice regarding the inaction of any inactive Committee or its Chairman, which must be explained to the concerned Minister or Parliamen-

(c). Adjournment Motion. If the Standing Committee continues to be inactive or no important matter is

These memorials are not only dedicated to soldiers but also represent the resilience and sacrifices of the Pakistani people.

The May 9 attacks had significant consequences for national security. In their aftermath, the military and law enforcement agencies were compelled to respond forcefully, resulting in widespread arrests, crackdowns on protestors, and increased security measures. The violence of that day raised concerns about the state's ability to maintain law and order, putting Pakistan's national security at risk. It also weakened the country's governance, eroding public trust in the political system and prompting doubts about the nation's stability. These events underscored the fragile nature of Pakistan's democracy.

The Pakistani government decided to take a firm stance against those responsible for the May 9 violence, while the Pakistan Army chose to remain neutral. It was determined that antistate elements would be dealt with according to the law, military courts, and military regulations. Imran Khan's politics have often been at odds with the country's best interests. He stated that even if a letter had been received, he would forward it to Prime Minister Shehbaz Sharif. Speaking informally during a luncheon with Turkish President Recep Tayyip Erdogan, General Munir emphasized that he would not read or entertain any such letter. This clear stance by the Army Chief, who affirmed the military's neutrality, reassured Pakistanis that the Army had decided to let the nation's legal system handle anti-state elements. Imran Khan has repeatedly stated that the Army should remain neutral, yet he is now contradicting himself by attempting to involve the Pakistan Army in his personal political and legal battles. These actions highlight the duality in Imran Khan's approach—on one hand, he assures his followers that he will not seek any NRO, but on the other, he is actively seeking every possible route to gain an NRO and secure relief. The nation sees this as a clear indication of Imran Khan's deep desire to obtain an NRO. Imran Khan and his party must have the moral fortitude to address their issues through political and legal means.

Imran Khan and others involved in the events of May 9 must face Pakistan's legal system for their actions, rather than attempting to bypass it. The nation remains shocked by the May 9 incidents and demands that those responsible for these heinous acts face strict legal consequences. The people urge the government not to yield to any pressure and to deal with these individuals firmly, setting an example to prevent such inci-

LONDON: The International Lawyers Club UK organised a special conference titled "Legal Implications of Revocation of Articles 370 and 35A in Jammu & Kashmir" at the UK Parliament. The conference, aimed at discussing the legal and human rights consequences of India's revocation of Jammu & Kashmir's special status, brought together British parliamentarians, legal experts, and members of the British-Pa-

### UN chief urges 'maximum restraint' as first phase of Gaza ceasefire expires

UNITED NATIONS: United Nations Secretary-General Antonio Guterres has called on Israel and Hamas to exercise "maximum restraint" as the first phase of their ceasefire agreement concludes.

"The past six weeks have provided a fragile but vital reprieve, offering a measure of relief to both Palestinians and Israelis," the UN chief said in a statement issued by his Spokesperson.

During the period of the truce, thousands of trucks carrying lifesaving assistance entered Gaza, reaching nearly every person in the besieged Strip. According to media reports, the six-week long ceasefire between Israel and Hamas ended earlier on Saturday with further negotiations between the sides still pending.

The Secretary-General emphasized the importance of preventing a return to hostilities, which he described as potentially catastrophic. "It is imperative that all efforts be made to prevent a return to hostilities," the statement urged.

Guterres called on all parties to exercise maximum restraint and to find a way forward on the next phase of the ceasefire. He highlighted the necessity of a permanent ceasefire and the release of all hostages to prevent further escalation and protect civilians.

"A permanent ceasefire and the release of all hostages are essential to preventing escalation and averting more devastating consequences for civilians," the UN chief said in the statement.

His statement was recorded and other than the two main as directors of different companies of alleged persons who received the alleged amount in their bank accounts, the complainant nominated six other individuals as mentioned in FIR below. The complainant also provided screenshots of WhatsApp chat with the accused Mateen Ud Din, having WhatsApp number 03336138452. The said screenshots contained the details about the forex trading portal/application, "ZX Trading", and the login details of the complainant. The bank account statements of the alleged accounts of the accused person(s) and the bank account statement of the complainant's MCB account number PK69MUCB0493942281002297

(used by the complainant for transferring the alleged amount) were acquired from the respective banks. The account statements corroborated the claim of the

transactions were found in their statements. Moreover, the record of the Venus group of companies was acquired from the SECP. As per the SECP AJRM No: 837, dated 29.04.2024, six (06) companies were found to be registered with SECP: (1) Venus Energy Pvt Ltd, (2) Venus Products and Services (SMC) Pvt Ltd, (3) Venus Real Estate Services (SMC) Pvt Ltd, (4) Venus Software Solutions & Services Pvt Ltd, (5) Venus Livestock (SMC) Pvt Ltd, and (6) Venus Solar Technology (Pvt.) The notices u/s 160 CrPC were issued to all of the alleged persons for attending the enquiry proceedings. However, only Imtisal Akram, Muhammad Iqbal and, Zahid Siddique attended the office, but they failed to give ar justification. Their Mobile phones (01 from each) were seized and sent to the forensic lab for digital forensic analysis. It was established that it was an organized crime committed under the guise of Venus group of companies; however in reality, it was an online forex trading scam. More than 200 investors were defrauded on the name of investment with a total amount reaching approximately PKR. 12 billion. The names of the alleged persons were placed in passport control list (PCL) due the apprehension the alleged persons might flee the country
