Pakistan, China strengthen strategic partnership in Beijing dialogue

BEIJING: Pakistan and China agreed to strengthen high-level exchanges and interactions at all levels, deepen strategic communication and coordination of actions, fully implement the action plan for building a China-Pakistan community with a shared future, and strive to achieve a number of early harvest outcomes.

During the Seventh Pakistan-China Strategic Dialogue between Deputy Prime Minister/Foreign Minister Mohammad Ishaq Dar and Chinese Foreign Minister Wang Yi held here, both countries will advance the development of the upgraded "CPEC 2.0," enhance cooperation in industry, agriculture, and mining, jointly commemorate the 75th anniversary of diplomatic relations to consolidate the

public support for China-Pakistan friendship, unite the Global South to safeguard common interests, uphold the purposes and principles of the UN Charter, and oppose bullying acts that infringe upon the sovereignty of other countries, according to a read out issued by Chinese Ministry of Foreign Affairs on Sunday night.

The two sides also conducted comprehensive and in-depth

strategic communication on international and regional issues of common concern and reached a broad consensus.

DPM/FM Ishaq Dar conveyed the warm greetings of the Pakistani leadership to the Chinese leaders and congratulated the Communist Party of China on the adoption of the proposals for the 15th Five-Year Plan at the Fourth Plenary Session of the 20th CPC Central Committee, stressing that

China's path to modernization is an important force for safeguarding world peace and development.

He said that friendship with China is the cornerstone of Pakistan's foreign policy and a consensus shared by all political parties and all sectors of Pakistani society. This year, the two sides will jointly witness 75 years of brotherly and iron-clad friendship.

Major terror plot foiled in Karachi as CTD seizes massive explosives cache

KARACHI: Law enforcement agencies in Karachi have thwarted a major terrorist plot through a timely operation, recovering a large quantity of explosives and arresting three suspected terrorists.

Addressing a press conference on Monday, Additional Inspector General of Counter Terrorism Department (CTD) Zulfiqar Lark and Deputy Inspector General Ghulam Azfar Mahesar said a raid was conducted in Rais Goth on Karachi's outskirts following intelligence reports about the presence of terrorists in the area.

During the operation, a significant amount of explosive material was recovered.

According to Additional IG Zulfiqar Lark, the suspects had prepared around 2,000 kilograms of explosives which were stored

in plastic drums.

One suspect was arrested at the scene, while others initially managed to escape. However, based on information provided by the arrested suspect, two more suspects were later taken into custody.

The arrested individuals were identified as Jalil Ahmed alias Fareed, son of Muhammad Noor; Niaz Qadir alias King, son of Qadir Bakhsh; and Hamdan alias Fareed, son of Muhammad Ali.

Officials said the suspects are affiliated with Indian terror proxy Fitna Al Hindustan, adding that efforts are ongoing to arrest additional members of the network.

Providing further details, DIG Ghulam Azfar Mahesar said the suspects were planning attacks on civilian targets in Karachi and had rented a house approximately 40 kilometres outside the city.

Mohsin Naqvi slams criminal UN silence on Indian atrocities in Occupied Kashmir

ISLAMABAD: Minister for Interior Mohsin Naqvi on Monday vowed that Pakistan will continue to extend full support to Kashmiris on Right to Self-Determination Day. In his message on Monday, Mohsin Naqvi

said that January 5 is a historic day on which the United Nations recognized Kashmiris' rights of self-determination.

He said, despite the passage of 77 years, Kashmiris are still being denied from their rights and facing brutalities and oppression.

Mohsin Naqvi said, "Occupied Jammu and Kashmir is a disputed territory and a global issue that has been unresolved for seven decades."

He said that people of Kashmir are looking at the United Nations for the resolution of their right of self-determination issue, and this

wait is weighing on the consciences of the United Nations, the international community, and human rights-loving countries. The Interior Minister said that Indian Occupied Kashmir is currently a picture of helplessness and oppression that questions claims of global justice.

AJK PM Rathore urges UN Action on Kashmir Self-Determination Resolutions

ISLAMABAD: Prime Minister Azad Jammu and Kashmir, Faisal Mumtaz Rathore, has said that it was high time that the United Nations should help implement its resolutions that guarantee the right to self-determination to the people of Kashmir.

He made these assertions while speaking at a seminar organized by Friends of Kashmir at the Pakistan Institute of Parliamentary Studies on the occasion of the Right to Self-Determination Day today.

The Prime Minister said that 5th January, observed by Kashmiris as Right to Self-Determination Day, serves as a reminder of the UN's promises to the Kashmiri people.

Urging the United Nations to take effective notice of the continued bloodshed and violence in Indian illegally occupied territory of Jammu and Kashmir, he said, "The world needs to confront the bitter reality that the people of Kashmir continue to reel under India's oppression and tyranny



despite the passage of decades." Paying tribute to the Kashmiri people's struggle and their resilience in the face of India's state terrorism, PM Rathore stated that India must bear in mind the fact that genuine movements involving sacrifice never fail.

The event was also addressed by Chairman of the Parliamentary Kashmir Committee, Rana Qasim Noon. Mr. Noon said that Kashmir is a noble cause for Pakistan and that

Kashmiris have the right to decide their own future.

He emphasized that Pakistan and Kashmir are inseparable and recalled that Quaid-e-Azam Muhammad Ali Jinnah had called Kashmir Pakistan's jugular vein.

Other speakers on the occasion sought the United Nation's urgent attention towards Kashmir issue, urging it to fulfill its commitments and ensure the right to self-determination

for the Kashmiri people.

Kashmir Right to Self-Determination Day marked in Islamabad, leaders stress UN resolutions

ISLAMABAD: A programme to mark January 5 – Right to Self-Determination Day was organized by the All Jammu and Kashmir Muslim Conference at the National Press Club, Islamabad.

Addressing the gathering, President of the Muslim Conference and former Prime Minister of Azad Jammu and Kashmir Sardar Attique Ahmed Khan said that the right to self-determination is the fundamental and inalienable right of the people of Jammu and Kashmir. DC Attock distribution of sewing machines among Women



KARACHI: Sindh Chief Minister Syed Murad Ali Shah paid glowing tribute to Shaheed Zulfikar Ali Bhutto, describing him as a visionary, charismatic and people-centric leader, who transformed Pakistan's political, constitutional and defence landscape.

Pakistan develops 400 advanced chickpea breeding lines

Pakistan has developed 400 advanced chickpea breeding lines under a newly established Speed Breeding Facility, aimed at accelerating the development of climate-resilient and high-yield pulse varieties.

Dr Shahid Riaz Malik, Head of the Pulses Research Program at the National Agricultural Research Centre, told Wealth Pakistan that the advanced breeding lines have been developed using controlled-environment speed breeding techniques and are now being prepared for field testing.

He said the new facility allows researchers to reduce the development cycle of pulse varieties by nearly half. "Traditionally, it takes 12 to 15 years to develop a new pulse variety, but through speed breeding, we can now release a new variety in seven to eight years," he said.

The facility focuses on key pulse crops including chickpeas, lentils, mung beans, black gram and other beans, which play a critical role in food security and farm incomes. Using precisely controlled temperature, humidity and light conditions, scientists are able to grow pulse crops every two months instead of once a year.

"In open-field conditions, chickpea takes about six months and can be grown only once a year. In our chambers, we can achieve five to six generations annually," Dr Shahid explained.

He said the speed breeding approach enables rapid screening of plants for traits such as drought tolerance, heat resistance and disease resistance, which are increasingly important due to climate change. Promising lines are quickly advanced through hybridisation before moving to field trials.

The facility is Pakistan's first dedicated speed breeding centre for pulses and the largest of its kind in South Asia. While similar facilities exist in other countries, Dr Shahid said they usually focus on multiple crops rather than pulses alone.

He said chickpea research under the programme is nearing completion, while work on lentils is around 70 to 75 percent finalised. Breeding protocols for mung bean and black gram are also being optimised, particularly as limited global research exists for these crops.

Following field testing, national yield trials and approval by seed councils, the newly developed pulse varieties are expected to be released to farmers within the next few years.

The programme has also expanded to include peanuts, millet and other crops, reflecting a broader multi-crop research approach. Capacity building is another major component, with scientists from across the national agricultural research system receiving training in speed breeding techniques, alongside university students engaged in advanced research.



How Trump Normalized Abducting Foreign Leaders

The abduction and prosecution of a sitting head of state is not merely a criminal case. It is a constitutional moment for the international system. With the dramatic seizure of Venezuelan President Nicolás Maduro and his transfer to the Southern District of New York to face drug-trafficking and weapons conspiracy charges, the United States has crossed a threshold that international law has traditionally treated as inviolable: a sitting head of state is not subject to the criminal jurisdiction of another state's courts.

Under customary international law, confirmed most famously by the International Court of Justice in the Arrest Warrant Case (2002), a sitting head of state enjoys immunity ratione personae—absolute immunity from foreign criminal proceedings, arrest, and detention. The basis is not personal privilege, but sovereignty itself. If the head of state can be arrested like a common suspect, then the state itself is no longer sovereign.

And here lies the danger. Imagine the mirror case. Suppose Venezuela indicted a sitting U. S. president—say Donald Trump—on charges of mass civilian casualties, illegal blockade, or extrajudicial destruction of vessels at sea. Suppose further that Venezuelan agents abducted him abroad and transported him to Caracas for trial. Under the very logic now applied to Maduro, Venezuela could insist that its criminal statutes have extraterritorial reach, that Trump's actions were criminal rather than "official" and that its courts therefore possess jurisdiction.

How would the United States

respond? Not by arguing immunity in court, but by invoking force. A national emergency would be declared. Military forces would mobilize. The U. S. would demand immediate release and—if refused—would act unilaterally, claiming self-defense under the U. N. Charter. Washington would not accept the idea that a foreign domestic judge could lawfully sit in judgment over a sitting U. S. president. Nor would any American

attempt to do so.

The reality, then, is that law permits the United States what it forbids others, but that power determines whose law prevails.

When China pursues influence, it does so primarily through economic integration and diplomatic leverage, binding states into webs of trade and dependence. The United States once did the same. But as its economic leverage erodes and its diplomatic authority is increasingly contested, military and coercive instruments have become more visible tools of statecraft. The Maduro case is not an isolated legal proceeding; it is an expression of power through law—what scholars call "lawfare."

The timing reinforces this interpretation. Senior U. S. military officials have openly acknowledged that operational planning for the mission began many months before the final raid, using intelligence mapping, maritime blockade, tanker seizures, and legal narrative to sculpt a justification.

That sequence suggests the decision to neutralize Maduro came first; the legal story followed. Declaring drugs a "weapon of mass destruction," escalating maritime enforcement, and ultimately seizing a sitting president were phases of a single strategy—not spontaneous responses. It is no coincidence that Venezuela controls the world's largest proven oil reserves.

Yet the legal stakes stretch far beyond Venezuela. If abducting a sitting presi-

dent becomes normalized practice, the Pandora's box is open. Russia could seize the Ukrainian president. Ukraine could attempt to capture the Russian leader. India and Pakistan could abduct each other's heads of government under rival criminal indictments. Every major power could claim universal criminal jurisdiction over its geopolitical adversaries. The international system would slide from law-based coexistence into unrestrained strategic kidnapping.

This is why head-of-state immunity exists in the first place. Not because leaders should be above the law—but because there must be a lawful, international forum for accountability, not unilateral justice imposed by strength. International tribunals, or trials after a leader leaves office, are the established routes. Anything else destabilizes the sovereign equality that prevents chaos.

It is also essential to note that the same immunity doctrine protects U. S. presidents, including Donald Trump. Under

international law, he cannot be arrested or tried abroad while in office, nor prosecuted for official acts thereafter. If the United States disregards these principles when dealing with weaker states, it cannot coherently object when others attempt the same logic against it.

The charges against Maduro in New York—drug trafficking and weapons conspiracy—were shaped precisely because those are the statutes that grant U. S. courts extraterritorial jurisdiction. They were not chosen for factual accuracy alone but to manufacture legal standing. If conviction follows, it will rest on a foundation that may be domestically valid yet internationally corrosive.

The world should be under no illusion: this is not only a criminal case. It is a test of whether law restrains power, or power bends law to its will. If the precedent stands unchecked, the guardrails that have prevented interstate retribution through legalized kidnapping will weaken. The result will not be justice—but a colder, more dangerous world where states resolve grievances by force wrapped in court filings.

For the sake of order, sovereignty, and genuine international justice, this Pandora's box must be closed—quickly and decisively. Otherwise the rule of law will not have been advanced by the Maduro prosecution. It will have been mortally wounded.

It is home to 34.3% of the Pashto-speaking (Kandahari dialects) population, making Pashto the second most spoken language in the province after Balochi, according to the 2023 Census of Pakistan (the first digital Census in Pakistan). The Pashtun Belt includes around three divisions: Quetta, Zhob, and Loralai. These 3 divisions consist of about 14 districts such as: Quetta, Pishin, Karezat, Killa Abdullah, Chaman, Zhob, Killa Saifullah, Sherani, Loralai, Musakhel, Duki, Barkhan, Ziarat and Harnai. Together, these districts are referred to as the Pashtun-majority areas of Northern Balochistan. The literacy rate here is higher than in the rest of the province, particularly in Quetta, Ziarat, and Loralai. Quetta is the educational hub of Balochistan.



Government Operations Room and Ministry of Public Works and Housing Launch “#RightToShelterGaza” Campaign

RAMALLAH: The Government Operations Room for Emergency Interventions in the Gaza Strip, in partnership with the Ministry of Public Works and Housing, have launched the “#RightToShelterGaza” campaign. The effort comes amidst the worsening suffering of hundreds of thousands of displaced people, who are living in poorly equipped tents that provide no protection from cold and rain. The campaign calls on the international community to pressure the Israeli occupation to allow the immediate entry of prefabricated housing units as an urgent humanitarian solution.

The Government Operations Room and the Ministry of Public Works and Housing affirmed that the recent weather depressions have clearly exposed the failure of tents to provide adequate protection for displaced people, as thousands of tents were flooded or blown away by heavy rainfall and strong winds. This has placed the lives of children and older people at direct risk amid the absence of safe heating methods. They further noted that more than 53,000 tents for displaced families were damaged during the recent weather depressions across various areas of the Gaza Strip, exacerbating the suffering of displaced

households and expanding urgent humanitarian needs.

The launch of the campaign comes amid deeply alarming humanitarian figures. Approximately two million people are currently displaced in the Gaza Strip, including nearly one million children, most of whom are living in harsh conditions inside inadequately equipped tents. Data indicate that, prior to the aggression, the number of persons with disabilities in Gaza stood at approximately 55,000. In addition, a report issued by the World Health Organization in September 2025 estimated that around 42,000 people sustained severe, life-altering injuries requiring long-term rehabilitation. This brings the total number of persons with disabilities and those affected by serious injuries to around 97,000 people. Many of whom are currently living in tents that lack basic safety standards and fail to accommodate their specific needs, further compounding their suffering and undermining their dignity.

Data from the Palestinian Central Bureau of Statistics also indicate that there are approximately 60,000 pregnant women in the Gaza Strip. The majority face acute shelter shortages and are living in inadequate tents that provide neither protection from the cold nor the necessary privacy, significantly increasing the health and

humanitarian risks they face amid extremely harsh living conditions.

According to data from the Ministry of Public Works and Housing, Israeli aggression has destroyed Gaza's housing sector. Approximately 90% of civilian infrastructure has been destroyed, with more than 355,000 housing units damaged to varying degrees, including around 295,000 units that were either completely destroyed or rendered uninhabitable. This widespread destruction has significantly exacerbated displacement and deepened the shelter crisis.

The Government Operations Room is saying that humanitarian organizations and relevant authorities are unable to fully meet urgent shelter needs, due to shortages of shelter materials; and due to severe lack of fuel which hampers the operation of heavy machinery required to open roads, remove rubble, and drain rainwater. The Israeli occupation continues to prevent the entry of prefabricated housing units into Gaza, allowing only small quantities of tents, further increasing the vulnerability of displaced people and placing their lives at risk.

The Ministry of Public Works and Housing has indicated that prefabricated housing units are the most appropriate option for temporary shelter, given the prolonged recon-

struction timeline and ongoing harsh weather conditions. Gaza needs 200,000 prefabricated housing units as an urgent humanitarian measure. However, Israel does not allow the entry of the needed housing units, which compels the humanitarian actors to rely on tents as a temporary and unsafe alternative. Prefabricated housing units are a necessary interim solution during this exceptional phase, and are not a permanent substitute for housing, pending the start of reconstruction.

According to the Office of the United Nations High Commissioner for Refugees (UNHCR), tents are suitable only for immediate emergency response during the initial phase of displacement and are not appropriate for winter shelter, as they cannot withstand rain and wind and are difficult to heat.


According to the Government Operations Room, the “#RightToShelterGaza” campaign seeks to generate media and political pressure, underscore that safe shelter is an urgent human right that cannot be delayed; and that the obstruction of prefabricated housing units puts the lives of hundreds of thousands of people at risk, particularly children and the elderly.

The “#RightToShelterGaza” campaign calls on the United Nations, international institutions, and states party to the Geneva Conventions to



uphold their legal and humanitarian responsibilities, to urgently pressure the Israeli occupation, and to allow the immediate entry of prefabricated housing units into the Gaza Strip as an emergency humanitarian solution to

provide safe shelter, protect lives, and ensure a minimum standard of human dignity amid harsh weather conditions and the displacement crisis.

Police Performance in Multan: The Widening Gap Between Claims and Reality

The widening gulf between the claims of Multan police and the bitter realities faced by citizens is no longer a mere administrative lapse; it has become a moment of serious reflection for our collective conscience. Amid the dazzling of social media posts and the echo of press conferences, tales of alleged recoveries worth millions are narrated as if crime has been eradicated from the city. On the ground, however, reality bluntly contradicts this narrative.

The ordinary citizen continues to lose motorcycles, cash and valuables, standing at police station doors with little more than hope for justice. Fahim Hasan Bhatti, personal assistant to Malik Muhammad Akmal Wains Editor Roznama Badalta Zamana Multan and CEO of Mux News — was robbed of Rs100,000 in cash and a mobile phone outside his home. FIR No 2218/25 was registered at New Multan police station, yet recovery remains zero. Computer engineer Muhammad Ashar Rohani was deprived of his mobile phone and motorcycle within the jurisdiction of BZ police station, with the same outcome: no recovery. My class fellow, Dr Javed Akhtar, had his motorcycle stolen from outside Nishtar Hospital hostel; FIR No 391/21 was registered at Chehlik police station, but years later

the file remains frozen where hope goes to die.

Similarly, Muhammad Aftab, an employee of SM Food Factory, lost his Honda 125 motorcycle in Old Kotwal's area. Despite approaching SP Saifullah Gujjar Gulgasht and filing complaints on 17/87 and the Pakistan Citizen Portal and FIR No 884/24 being registered, the result remains unchanged. Zafar Iqbal's case (FIR No 833/25, Shah Shams police station) tells the same story — the recovery column still blank.

IG Punjab, these are only a handful of cases all involving our close friends and employees. Beyond these lie countless untold stories scattered across every street of this city, unheard and unattended. The question is not why FIRs are registered. The real question is: to whom are recoveries actually handed over? Whose losses are compensated, and who is left holding nothing but receipts and hollow assurances? On this distinction, the police have never issued a clear or transparent explanation.

As long as performance is measured through press releases and publicity, and the redress of a citizen's loss is reduced to the mere entry “FIR registered”, recoveries worth millions will remain paper victories. True success will come the day the common man gets back his stolen motorcycle, looted cash and, most importantly, his lost

trust. Until then, questions will persist and silence itself will stand as a grave answer.

The contrast between truth and the image projected on social media has become the core reason for the erosion of public trust in the police. On one side, drums are beaten over the recovery of cars, tractors and motorcycles, with success stories piled high and performance portrayed as exemplary. On the other, the ground reality is that these recoveries benefit only a select few, while deprivation remains the lot of the ordinary citizen.

On a daily basis, a large number of cases are consigned to files under the pretext of “no clue”. On paper, the case is closed; in reality, the victim's wounds remain fresh. The question is not whether the police are taking action, but for whom these actions are taken. Is the rule of law equal for all, or has justice itself become dependent on influence and connections?

Another alarming aspect is the conduct witnessed in Multan police's khuli katcheries. Instead of acting as representatives of the public, some journalists appear as recommenders. The police oblige them, files begin to

move, and what is impossible for an ordinary citizen becomes achievable within moments. This practice not only undermines the very concept of justice but further weakens the police's public credibility.

This situation raises a fundamental question: have the institutions responsible for protecting citizens' lives and

property failed, or are they functioning only for a chosen few? Until this question is answered honestly and practically, social media glamour will not be able to rebuild public trust. Trust is not born of advertisements or press releases; it emerges from equal access to justice — and that is the yardstick by which police performance is being judged today.

A silent yet extremely damaging practice within senior police offices, particularly SP offices, has hollowed out public trust from within. Complaints lodged through the Pakistan Citizen Portal or police helpline 1787 filed with the hope that at least higher authorities will listen — are often “dropped” with misleading, vague and factually contradictory comments. This is not the discretion of a station house officer; it is a process carried out at the SP office

level, where a single stroke of the pen shuts the door on a citizen's plea for justice.

This is not mere administrative apathy; it is a mockery of state trust. When complainants are told that “action has been completed” or that “the complainant is satisfied”, while in reality no recovery has taken place and no meaningful contact has been made, one must ask: who are these reports meant to satisfy — the public or the higher-ups?

This disparity — between glowing performance claims on social media and the silent burial of complaints in offices — is inflicting irreparable damage on the police's credibility, not just in Multan but across the province. When citizens see their complaints vanish into the system, they lose faith not only in the police but in state institutions as a whole.

Direct intervention by the IG Punjab Police has now become unavoidable. The entire mechanism needs to be reviewed afresh to end the practice of “disposing” complaints under the guise of resolution, and to ensure that the people of Multan get back their valuable property — motorcycles, vehicles, cash — and their trust.

Steps to restore trust include:

Independent audit system: Quarterly independent audits of decisions taken on complaints filed via the

Citizen Portal and 1787 to determine on what basis cases were dropped.

Mandatory written justification: SP offices must provide detailed, written and evidence-based reasons before dropping any complaint as well.


Complainant verification: No case should be marked “satisfied” without written or digital confirmation from the complainant; internal notes should not suffice.

Recovery tracking dashboard: A public dashboard in every district showing FIR numbers, nature of crime and recovery progress to expose the gap between claims and reality.

Officer accountability: Where it is proven that misleading comments were deliberately used to drop complaints, exemplary departmental action must follow.

Reforming khuli katcheries: These forums should serve public accountability, not recommendations, with decisions formally recorded and compliance reports issued.

If the true purpose of policing is the protection of citizens' lives and property, then the police must move beyond promotional narratives to deliver practical justice. Otherwise, every complaint quietly marked “dropped” will continue to widen the distance between the police and the public — a distance no press conference can ever bridge.

SECP revamps REIT Regulations, 2022, to Enhance Growth and Transparency

ISLAMABAD: The Securities and Exchange Commission of Pakistan ("SECP") has notified amendments to the Real Estate Investment Trust Regulations, 2022 ("REIT Regulations") to simplify procedures, improve governance and control mechanisms, and encourage greater transparency and objectivity in the operations of REIT Schemes.

The amended regulations establish clearer timelines for the transfer of real estate and shares of special purpose vehicles, promoting early listing of REIT Schemes to enhance their visibility and development as a capital market asset class. In addition to strengthening the roles and responsibilities of REIT Management Companies (RMCs) and trustees, the amendments address regu-



latory arbitrage across different REIT structures and enable better synchronization with the Shariah governance framework.

The SECP has also streamlined procedures for the registration of trust deeds and the approval for registration of REIT Schemes.

The amendments follow an exhaustive stakeholder consultation process, which included the issuance of a consultation paper, multiple in-person sessions and

virtual meetings with key stakeholders—such as RMCs, trustees, banks, mutual funds, law firms, and consultants—further consultations based on the notification of draft amendments, and a conclusive consultation session in Karachi.

The REIT Regulations provide the framework for the establishment, operation, and management of REIT Schemes by RMCs. A REIT Scheme is a fund in which an RMC pools money from investors for investment in real estate projects. By becoming unitholders of a REIT Scheme, investors gain a proportional share in the ownership of income-generating real estate projects, entitling them to rental income and/or capital gains.

‘5 January: The Call for Self-Determination in Jammu and Kashmir’

ISLAMABAD: To commemorate and highlight the importance of United Nations Commission for India and Pakistan (UNCIP) resolution of 5th January 1949, the India Study Centre at the Institute of Strategic Studies, Islamabad (ISSI) organised a round table event titled “5 January: The Call for Self-Determination in Jammu and Kashmir” in collaboration with Kashmir Institute of International Relations (KIIR) and All Parties Hurriyet Conference (APHC).

Speaking at the occasion, Chairman Board of Governance, ISSI, Ambassador Khalid Mahmood said that the 5 January 1949 resolution established the principle that the fate of Jammu and Kashmir would be decided by the people of Jammu and Kashmir through a free and impartial plebiscite under the auspices of the United Nations (UN). India used to claim that Jammu and Kashmir is a bilateral issue, and lately, it has started saying that it is an internal issue, as it is an integral part of India.

In his introductory remarks, the

Director of the India Study Centre, Dr Khurram Abbas, said that on this date in 1949, the UNCIP acknowledged the right of self-determination of the Kashmiri people. However, after almost 78 years, the people of Jammu and Kashmir are still waiting to exercise their right of self-determination.

He said that the relevance of this resolution increased manifold post August 5, 2019.

Mr Altaf Hussain Wani, Chairman of the Kashmir Institute of International Relations, Islamabad, said there are a number of UN resolutions on Kashmir, but the UNCIP resolution of 5 January 1949 gave a roadmap towards a solution of the Jammu and Kashmir dispute.

India knew from the outset that it would forcefully occupy this princely state with a Muslim majority. It thought that it would go to the UN, saying that the Maharaja had already signed an accession with India and would get Pakistan declared an aggressor.

Mr Farooq Rehmani, senior leader and former convenor of the All Parties Hurriyet Conference, said that India never wanted to implement UN reso-

lutions and therefore, it complicated the procedure by raising one objection or another.

Ambassador Riffat Masood, Pakistan’s Representative to the OIC-Independent Permanent Human Rights Commission (IPHRC), opined that the right of self-determination was an important component of the freedom movement of India and Pakistan from British Raj. It is ironic that after its independence, India was not willing to give the same right to the people of Jammu and Kashmir. Several global examples exist, such as Kosovo, South Sudan, and East Timor, where people have successfully exercised their right to self-determination.

Members of the think tank community, intellectuals, and a large number of students attended the event. While concluding the event, Ambassador Khalid Mahmood saluted the resilience of the Kashmiri people who refuse to give up on the just and principled demand of their right of self-determination. He reiterated Pakistan’s unflinching political, moral and diplomatic support to the Kashmir cause.

Why Socrates' Way of Asking Questions Can Fix Today's Toxic Politics

Modern politics has become a theatre of noise. Voices are louder, tempers are shorter, and certainty is treated as a badge of honour. Whether on television screens, political rallies, or social media, the aim today is not to understand but to dominate. Facts are replaced with emotions, dialogue with humiliation, and disagreement with hostility. In this increasingly toxic political climate, an ancient thinker who died 2,400 years ago offers a surprisingly modern remedy: Socrates. His simple but profound method—asking sincere, logical questions—may be exactly what our politics needs to breathe again.

Socrates lived in a time of political turmoil, public distrust, and moral confusion. Yet, unlike many philosophers, he did not respond through speeches or manifestos. He walked through the streets of Athens asking ordinary people questions about justice, truth, courage, and leadership. He believed that when people explain their beliefs, they discover how much they do not know. This humility, he argued, is the beginning of wisdom. Today, when every political side claims absolute certainty, Socrates' humility feels revolutionary.

The Socratic method works through quiet disruption. It does not attack; it exposes. It does not humiliate; it clarifies. A simple question—“What do you mean by this?”—can reveal whether an opinion is built on evidence or simply on emotion. Imagine, for a moment, applying this method to modern political speeches. When a leader promises

“change,” a Socratic question would follow: “What change? How will it happen? Who benefits?” Many political arguments collapse when forced to explain themselves.

What makes today's politics toxic is not disagreement; it is the unwillingness to question ourselves. Political identities have turned into tribal identities. People defend their leaders even when they are wrong, attack opponents even when they are right, and choose loyalty over logic. Socrates warned that unexamined beliefs are dangerous—they turn people into instruments of manipulation. If we begin questioning our own assumptions, we weaken the hold of propaganda. Socratic dialogue transforms citizens from followers into thinkers.

This is not an idealistic dream; history proves it. The Athenians executed Socrates because he challenged powerful people with difficult questions. But even his enemies admitted one thing—he forced society to think. Today's politics also needs someone who slows the speed of outrage and increases the depth of conversation. Socratic questioning can act as a filter: it keeps what is logical and washes away what is empty.

Leadership, too, would change under the Socratic approach. Today, leaders are expected to appear certain even when they are uninformed. Admitting doubt is seen as weakness. Socrates flips this idea. A leader who acknowledges uncertainty is not weak but wise. A leader who asks questions makes fewer reckless decisions. A leader who listens creates space for truth. If political leaders accepted that they “do not know everything,” governance would become more ethical, transparent, and human.

But the Socratic method is not only for politicians; it is for citizens. A democracy becomes toxic when its people stop thinking critically. If voters begin asking questions—real questions—the quality of political discourse will rise. Instead of defending political parties blindly, people will evaluate policies. Instead of reacting emotionally, they will reason. Instead of treating opponents as enemies, they will treat them as partners in a shared search for

truth.

At the heart of Socrates' method lies moral courage. Asking honest questions is not easy; it exposes weakness and challenges ego. But political healing requires this courage. Citizens must be brave enough to ask:

“Why do I believe what I believe?”
“What if I am wrong?”
“What if the truth lies somewhere in the middle?”

This shift—from defending opinions to examining them—can transform national politics into a space of learning rather than conflict.

Socrates does not promise a world without disagreement. Differences will always exist, and they should. But he offers a way to disagree without hatred. He teaches that dialogue is stronger than division, clarity is better than noise, and humility is wiser than certainty. Socratic questioning is not old-fashioned; it is urgently modern. In a world addicted to outrage, it is a method of recovery.

Perhaps, more than anything, Socrates asks us to adopt one fundamental habit: to think before we speak, listen before we judge, and question before we believe. If we begin doing this, political noise will soften, political hatred will decline, and political understanding will grow.

In a time when politics is tearing societies apart, Socrates reminds us of a simple truth: a healthier political world begins with a single honest question. And maybe that question is the one we are most afraid to ask—“What if the problem is not just the politicians, but also the way we think?”

Government's Decision to Reduce Solar Net Metering Rates is Disappointing, Aman Pracha

KARACHI: Aman Pracha, Vice President of the Federation of Pakistan Chambers of Commerce and Industry (FPCCI), has strongly criticized the government's decision to reduce the solar net metering rate from 29 rupees to 11 rupees, stating that this move will severely impact new investments in the country. He further added that the business community will be disappointed, and billions of rupees invested could be wasted, as many consumers may shift to hybrid systems. In this case, they will also lose out on the electricity they currently consume.

Aman Pracha emphasized that while NEPRA (National Electric Power Regulatory Authority) has presented this as the “Solar Consumer Regulations 2025” and claimed that it had consulted with stakeholders, the reality is that the country's largest business community representative body, FPCCI, was not consulted. The decision to change the net metering policy for all solar consumers is detrimental to investment and could lead to significant losses.

He also pointed out that under the new system, the period for solar agreements has been reduced from 7 years to 5 years. Additionally, the proposed payment to consumers has been reduced to 10 rupees per unit instead of 22 rupees, which will be unacceptable for many. As a result, the benefits of the previous net metering system would disappear under the new policy.

President reaffirms Pakistan's support for Kashmiris' right to self-determination



ISLAMABAD: President Asif Ali Zardari, on Right to Self-Determination Day reaffirmed Pakistan's unwavering moral, political and diplomatic support for the people of Jammu and Kashmir, urging the international community to play an effective role in ensuring the implementation of United Nations resolutions on the dispute.

In his message issued on the occasion, the President said that on January 5, the people of Pakistan stood in solidarity with the people of Jammu and Kashmir to commemo-

rate the adoption of a 1949 UN resolution that recognised the disputed status of the territory and affirmed the Kashmiri people's right to determine their future through a free and impartial plebiscite.

He noted that more than seven decades later, the commitment made by the United Nations remained unfulfilled, adding that the passage of time had neither weakened the validity of UN resolutions nor diminished the legitimacy of the Kashmiri people's demand for self-determination. The continued denial of this right, he said, was in clear contradiction to



the UN Charter and international law.

President Zardari expressed serious concern over the prevailing situation in Indian Illegally Occupied Jammu and

Kashmir, pointing to restrictions on political activity and freedom of expression, prolonged detentions and the use of coercive laws, which he said had created an atmosphere

of fear and impunity. He added that civilians continued to suffer, with families displaced and livelihoods disrupted.

The President also highlighted emerging challenges related to control over rivers originating in Jammu and Kashmir, warning that India's unilateral suspension of the Indus Waters Treaty was a grave development with serious implications for the lives of Kashmiris and regional stability. He termed the move an attempt to weaponise water, threatening livelihoods, food security and peace for millions dependent on shared resources.

Ayaz Sadiq says Indian delegation tried to stop him from attending Khaleda Zia's funeral

ISLAMABAD: National Assembly Speaker Sardar Ayaz Sadiq has claimed that the Indian delegation attempted to prevent him from attending the funeral prayers of former Bangladeshi prime minister Khaleda Zia during his visit to Dhaka recently.

However, the Speaker maintained that he offered prayers alongside the Bangladeshi public despite pressure and security objections.

In a statement, Sadiq said he travelled to Dhaka to attend Khaleda Zia's funeral, where delegations from Pakistan, the Maldives, Nepal and Bhutan were transported to the funeral venue in a single



bus. He said the front seats of the bus were occupied by India's

External Affairs Minister S. Jaishankar and the Indian high commissioner, who had

the bus windows covered with curtains.

Ayaz Sadiq said he was

seated at the back of the bus with the Pakistan high commissioner.

According to the speaker, he pulled aside the curtains during the journey and waved in response to slogans raised by members of the Bangladeshi public along the route.

Sadiq said that upon arrival at the funeral venue, the Indian high commissioner stood at the bus door and, as he prepared to disembark, Indian officials advised him not to get off, citing security concerns.

"I made it clear that I had come to attend the funeral and that the door should be opened," Sadiq said, adding that he insisted forcefully before the door was eventually opened.
